Note

Dr. Charles H. Mercer was a Professor of Modern Language at Dalhousie University in the early 20th century. He was also involved with the League of Nations and with several Canadian prisoners' rights groups.

Custodial history

Materials were donated by Professor Eric Mercer on February 9, 1994 and on October 3, 1996.

Scope and content

Fonds consists of published material, correspondence, pamphlets, off-prints on foreign language broadcasting around the world; correspondence and literature on the League of Nations Society in Canada; and correspondence with the Canadian Prisoners' Welfare Association, the Penal Association of Canada and the Prisoners' Aid and Welfare Association.

File also contains two Macleans' articles (May and Ocober 1933) on Christianity in prisons and a portrayal of the treatment of a Black prisoner.
