Note

Ann Hughes was the widow of carpenter Edward Hughes of Granville, Nova Scotia. At the time she sold her land in Granville, she was living in Saint John, New Brunswick.

Custodial history

The item was accessioned by Dalhousie University Archives in 1971. Prior to that, the item was in the custody of Mrs. A.G. Christie of Halifax, Nova Scotia.

Scope and content

Item is a land deed registering the 1831 sale of property in Granville, Nova Scotia from Ann Hughes to Abel Sands. The document was registered in Annapolis in 1833.
