Dr. Kilpatrick was born in February 27, 1892, received her early education in Sydney Mines, Nova Scotia, and graduated from Dalhousie Medical School in 1915. She later obtained a second medical degree from Long Island College Hospital in 1925. With an interest in psychiatry, she worked at several institutions before settling in New York and starting a private practice in Psychiatry in 1928.

Custodial history

The materials were donated to the Dalhousie University Archives in 1984. The custodial history is unknown.

Scope and content

Fonds consists of manuscripts of papers and addresses in addition to published articles. This fonds also includes general notes, correspondence, and biographical sketches of Dr. Kilpatrick.
