Administrative history / Biographical sketch

Note

Lemuel Publicover was born on 25 May 1865 in Lunenburg, Nova Scotia. He was the son of Jacob Solomon Publicover and Margaret Sarah Himmelman. Publicover was married three times: to Johanna Slauenwhite on 2 January 1889; Fanny Wagner on 19 October 1893; and Mary Veinot on 28 January 1899. The Publicovers were a prominent shipping family on the Lahave River, and Lemuel was master of the schooner Algoma.

Custodial history

Records were donated to the Dalhousie University Archives by Mr. and Mrs. Murray Oickle and accessioned in 1971.

Scope and content

File contains a bill of lading dated 26 November 1892, a letter written to Lemuel Publicover by Elias Sampson dated 1 January 1894, a receipt issued by M.J. Bates on 26 July 1896, and a receipt issued by John White and Company on 30 June 1896.
