### Note

The Bridgewater Lawn and Tennis Club began in the summer of 1889, but its constitution and bylaws weren't adopted until 1890. An elected management committee held annual meetings and held general control over the affairs of the club, including membership. Charter member included R.G. Logan (president), H.T. Ross (secretary-treasurer), George Thomson and R.H. Frazer (members of the executive).
