Dear Mr. Raddall:-

I have intended to write to you for some time past to offer my hearty congratulations on the fine piece of work you have done in "His Majesty's Yankees". It is a volume which should find a place on every Nova Scotia bookshelf and will, undoubtedly, enjoy a wide circulation throughout Canada and the States. I hope to be able to get you to autograph my copy.

You will be glad to know that the premium due on May 12th on your policy, #651659, is the final payment that you will make on this contract and it will then be fully paid-up for \$8,000 with Total Disability Benefit also paid-up. Your dividends have, in the past, been used to reduce premiums; I believe, however, that you will wish to let this year's dividend remain on deposit to the credit of the policy because, in this way, the full amount of the premium will be a deductible item from compulsory savings in your Income Tax Report for 1943. If the dividends should be withdrawn or used to reduce the premium, only the net premium could be claimed as a deduction. Am enclosing a form for your use should you decide to follow my suggestion.

The policy is made payable to your mother. If you require any change in this, there is a form which we shall send you to take care of it.

I have not been able to get down to Liverpool for quite some time and it is getting more difficult, as you know, to get around the Province. I wish, however, that you would refer to the proposal (if you still have it) that I gave you about a year ago which outlined, very briefly, an Income policy for yourself. Am hopeful that your present circumstances will permit of your carrying through a plan of this nature in the near future and I'll be only too glad to make the trip down there to complete the details when you are ready.

If you should be coming to Halifax soon, I would be pleased to hear from you; if not, please drop me a line at your early convenience. Kindest regards,

Dear Mr. Raddall:-


Thanks for your letter of the 26th instant received yesterday.

Your understanding of the values, etc., of your policy is correct and I would recommend that you allow the contract to remain in force, especially in view of the fact that the Total Disability Benefit, such as written into the contract, is not now available in new policies.

Am enclosing the form which will be required to have the policy proceeds payable to your estate. As your mother is a preferred beneficiary, you should secure her signature on this form and have same duly attested and returned to this Office.

I was disappointed to learn that the matter of an Income policy does not interest you at this time. I hope, however, that the idea may appeal to you a bit later on and that I may be able to look after this item for you.
