THE GYMNASIUM

A friend writes as follows of the project for building the gymnasium, reference to which will be found in our Editorial columns.

Dalhousians everywhere who have been following the development of the university are at present much interested in the idea of a new gymnasium. It is understood that some years ago a fund was raised to finance the new gymnasium, or to serve as a nest egg for that purpose; and that this sum was lent to the governors when the temporary gymnasium was erected on its present site. I know that a committee of the Alumni Executive are at work on the whole problem of the gymnasium, and that we are likely before long to hear more of the project.

I am informed by a member of the committee that, while they are not in a position to divulge the plan in detail as yet, since it has not been fully worked out, they have in mind a scheme which, if approved and supported by the Alumni will assure a new gymnasium in the rather near future. If the committee have worked out a feasible scheme they deserve all credit and the Dalhousie public are looking forward with interest for further information. The "News" understands that our correspondent's information is correct, and will be glad to give publicity to the scheme whenever it is ready to be divulged.

EDITORIAL

The Gymnasium Again:

Reference has previously been made in the columns of the "News" to the need of carrying out the plan for building a permanent gymnasium. We are printing in this issue an article from one of those interested in the scheme; and it is a scheme that will bear much consideration. The present gymnasium is very useful, but the building is only temporary, and the foundation will be needed for a new Arts building as soon as the funds can be secured. The gymnasium is something that appeals to It is untouched by the discussions about the value of this or that academic activity. It should furnish a rallying point to all alumni for whatever interest and enthusiasm they may have for their Alma Mater. There is no more proper subject for universal sympathy among all good Dalhousians. The News has before now maintained and still maintains that the primary object and peculiar function of the University is scholarship; and would gladly see scholarship held in higher esteem at Dalhousie But in the field of scholarand elsewhere. ship different men are interested in different things, and it is natural and proper for each man to support his own peculiar subject. Every-one is at least mildly interested in the proper Everyphysical development of the student, and the physical development of the student, and the tradition of some exercise and friendly sport is a long and creditable one. There is further an opportunity for us, if the alumni respond kindly to the appeal, to establish for ourselves and posterity a perpetual memorial, in a dig-nified and beautiful form, that shall stand as a tribute to our honored dead, and a memento of the patriotism and devotion not of any seperate one of our lengthening list of notable benefactors, but of us common Dalhousians, great and small, who are second to none in loyalty to the old college by the sea.

The Directory:

Every university, as its list of graduates lengthens, finds itself faced with the problem of keeping in touch with them; and many graduates would be glad to find out something about friends or foes of college days, who have wandered out of sight. So in most institutions some sort of directory is kept. At Dalhousie, so far as the News is informed, we have published no list of Alumni since 1907. That list contained only the names of graduates arranged alphabetically under their various degrees. the more elaborate directories published by the larger institutions contain the names of graduates and non-graduates, arranged according to the year of graduation, according to geographical location, and alphabetically. The precise form of the directory is not so important, provided one can find in it the address of the man for whom he is looking. Every alumnus or interested person should have on hand some such list for reference. It is, speaking from some experience, worth what it cost merely of a directory for those who are organizing alumni for any purpose are at once evident

The Alumni Association has spent much time and some money during the last year or two in an attempt to get our lists into proper shape. has been proposed to publish a directory of all past students of Dalhousie, graduate and nongraduate, giving the present address of each as far as these are known. This issue of the News contains a blank which it is hoped that each interested person will fill out and forward to the secretary. It is a small thing to ask, and it will make a great difference to us if the alumni will attend to this matter promptly.

Another blank that will be found in this issue calls for nominations for various offices in the Alumni Association, and for one nomination for the position of Alumni Governor. The News hopes to see machinery established shortly, if the new by-laws now suggested are accepted, whereby distant alumni may regularly participate in elections for these offices, and hopes that all Dalhousians will make their opinions and prejudices heard and respected. What we had to say on the general subject was said in our last issue

Representation in Parliament:

The News has been asked—unofficially— to make some remarks on the subject of university representation in parliament. They have no knowledge on this subject other than what can be obtained from any discussion of the system as it obtains in Great Britain. But the idea that there should be a few men in parliament, who represent in particular, the interests of scholarship seems a good one. Just how the system should be put into operation in Canada we do not know. Under our Constitution, such a privilege granted to universities might be regarded as illogical and anamalous, as are many interesting and valuable things. Indeed we are patient of all anomalies, as modern democracy, with all its virtues, tends to a drab and stupid uniformity of mathematical regularity If any student of government cares to discuss this question in the News we shall endeavour to find space for him-limited as is the space in the News.

The Graduating Classes:

Before another issue of the News appears the class of 1925 will have passed from Dalhousie into whatever world they may choose for their life and work. The News, needless to say, wishes them all well, and it wishes also to impress upon all graduates their duty and obligation to their Alma Mater. You know best, or you will know best after some years, what you have received. It is not fashionable at present to say much to the public at large except in the way of flattery, though some voices there are, either cynical or seriously monitory, that strike a higher note. But the News thinks sufficiently well of Dalhousians to believe that they do not much want to be praised, and it reminds them again, one and all of the toil and sacrifice that it has meant for someone to build this Dalhousie that we enjoy. Universities are usually rather long-lived; and there seems a strong probability that Dalhousie will flourish for many generations to come. But she is of use and value only in us and through us, and each and every graduate, by the very fact of graduation, undertakes to dis charge a trust; so to live as to keep Dalhousie's name what we like to think it is-a synonym for honor and loyalty and honest work graduate can do something for Dalhousiemay do much—in the long years to come.
