



#### PREFACE



#### CENTRE FOR FOREIGN POLICY STUDIES: DESCRIPTION

The Centre for Foreign Policy Studies is affiliated with the Department of Political Science at Dalhousie University. It is concerned with teaching, research and other professional activity in the fields of foreign policy and international politics.

The Centre was established in 1971 with a grant from the Donner Canadian Foundation which enabled it to attract new faculty and fellows and to commence a research programme on comparative foreign policy analysis. At the same time, the Department of National Defence funded a Chair of Strategic Studies at Dalhousie University which further strengthened the Centre's activities.

The Centre consists of seven members of faculty and, through its fellowship programme, it has had several Research Fellows or Associates in residence at any one time. The routine activities of the Centre include a bi-weekly seminar, a set of publications and a series of speakers and visitors from both academic and governmental institutions. The seminar is open to faculty, fellows and students interested in world politics, and it consists of a critical discussion of papers produced by members or visitors. In addition, the Centre has organized several seminars on particular issues or themes, which have been funded by the Canada Council.

Centre faculty offer courses in the Department of Political Science on international relations, foreign policy and world order at both undergraduate and graduate levels. They also supervise masters and doctoral students and dissertations in these fields.

Four objectives were set down in the original proposal which constituted the Centre, and the Centre has made considerable progress toward realizing each of them. The first objective called for a closer integration of theoretical and descriptive approaches to the study of foreign policy decision making. This objective has been largely met since 1971 by recruiting personnel whose academic interests spanned both theory and practice, and by encouraging foreign policy research that draws inspiration from both academic literature and from observation of actual practice. Today, Centre members share a common research interest in

the policy-making process and a commitment to scholarship which bridges the perspectives of academic social scientists and practitioners. The results of this scholarship can be assessed in the publications of Centre staff.

A second Centre objective was to evaluate explanations about foreign policy by applying them to a variety of concrete cases rather than to concentrate exclusively upon the foreign policies of a specific group of nations. The Centre has simultaneously pursued both country/area and comparative foreign policy studies since 1971, each proving to be to the benefit of the other. Moreover, the geographical diversity of the interests of Centre members means that they are able to bring to bear a balanced perspective on the study of Canada's role in international relations. In large measure, the Centre's current focus on the variety of internal and international transformations associated with the "New World Order" sustains the pursuit of this objective.

A third objective was to generate interpretive analyses and policy proposals of relevance to Canadian foreign policy decision makers. Perhaps the best indicator of the Centre's accomplishment of this objective is outside recognition. The Centre has hosted two Foreign Service Visitors--Donald W. Munro and Margaret Meagher -- for one academic year each. Additionally, at the request of the Department of External Affairs, the Centre hosted a workshop on Canadian foreign policy featuring presentations by foreign service officers and Centre staff. Finally, the Centre has successfully attracted mid-level federal and provincial civil servants to its summer foreign policy workshop series. workshops are held over three-day periods and are organized around specific themes; for example, "Canada's Future in a Changing World" (1977) and "Canadian-American Relations in a Changing World" (1978). Each Workshop takes as its purpose to provide a stimulating environment for individuals with different perspectives to reflect on future directions in Canadian foreign policy.

The final objective set down at the Centre's inception was to contribute to Canada's available store of experts capable of conducting a sophisticated examination of foreign policy-making processes. In conjunction with the Department of Political Science, the Centre staff contributes to graduate and undergraduate programmes in international relations, foreign policy, and world order. Since 1971, the Centre has also funded a total of fifteen Research Fellows, the majority for multiple twelve-month periods, as well as seven Research Associates.

The Centre will pursue these four objectives in the future, and will continue the teaching, research and professional activities that have occupied its members to date. It is anticipated that Research Fellows and Associates will be recruited as needed and that graduate students will continue to be affiliated with the activities of the Centre. Additionally, the Centre is developing links with related institutions in Canada and abroad. At Dalhousie University, the Centre works closely with faculty in other disciplines interested in international studies, especially with the Centre for International Business Studies, the Centre for African Studies, and the Ocean Studies Group.

II

#### CURRENT PROGRAMME

The Centre for Foreign Policy Studies is currently conducting a three-year programme entitled "Canada's Future in the New World Order." The purpose of this programme is to examine the transformations that are now occurring in international and internal politics, and to assess the effects of these changes on Canadian foreign policy. The programme is supported by a major grant from the Donner Canadian Foundation. The Departments of External Affairs and National Defence also provide support for related research and seminar activities as does Dalhousie University.

The current programme springs from a recognition of significant transformations in both the international and domestic political systems. The world is currently undergoing changes that are as profound as those ushered in by the Second World War. Nations and peoples previously not of direct concern to Canadian policy makers are demanding answers to problems that are both immediate in their urgency and global in their scope. Traditional allies of Canada are becoming preoccupied with their own problems, and the Canadian authorities can rely less than before on the constancy of established relationships. At the same time, internal changes are occurring in Canadian society which create new and more varied demands on Canada's foreign policy establish-Any of these changes taken singly would give rise to policy adjustments, but taken together they create an enormous problem of adaptation. The programme that has been developed thus stems from the conviction that intelligent policy is not possible when reality overwhelms imagination, and it seeks to create an understanding of change and the implications of change for policy making.

The programme encompasses activity in five areas, each proceeding currently with overlapping research teams.

#### First

The first area entails an inquiry into the new global environment, and is conducted through a regular set of seminars led by Centre personnel and outside persons. Visitors whose work concerns the future international order have been invited to the Centre for discussion and consultation. Among these visitors are Dr. Seyom Brown, Carnegie Endowment for

International Peace and author of New Forces in World Politics; Professor Silviu Brucan, University of Bucharest and member of the Board of the Foundation Reshaping the International Order (RIO); and Mr. Bernard Wood, Director of the North-South In-Stitute, Ottawa. In 1978-79, the Centre engaged Mrs. Elisabeth Mann Borgese of the Center for the Study of Democratic Institutions, Santa Barbara, California, as a Killam Senior Fellow. Mrs. Borgese will continue her work on the Law of the Sea and the New World Order, relying on the strengths of the Centre and Dalhousie University for support in this area.

#### Second

The second area consists of an examination of the methods of foreign policy analysis, with the planned publication of a volume on analytical approaches to Canadian foreign policy. The volume, on which some work is already completed, will facilitate the application of systematic theory and research methods to the study of Canadian foreign policy, and will provide examples of the Canadian experience which are comparable to studies carried out in other countries.

#### Third

The third area consists of several related research projects which explore the decision-making environment of Canadian foreign policy, and which examine the impact of changing domestic conditions on Canada's external policies. These projects take up questions such as changing societal demands on foreign policy, the problems of technology in foreign policy making, and the process of representing Canada's interests abroad. The focus in these projects is on bureaucratic politics, negotiation, and the tactics of influence exercised by the press and interest groups. Specific cases being considered are the negotiations on the Law of the Sea and foreign trade, the International Joint Commission and the UN Conference on Science and Technology for Development.

The specific projects that are being conducted in the third area are as follows:

- 6. "Changing Societal Influences on Canadian Foreign Policy: Pundits, Publics, and Pressure Groups" (A group research project headed by Professor Denis Stairs)
- 7. "Public Opinion in the Canadian Foreign Policy Process:
  The Case of the IJC" (Professor Don Munton)

#### Fourth

This area consists of a series of issue-oriented research projects which illustrate the problems Canada faces in the context of changing conditions in world politics. The specific projects that are being carried out in this area are as follows:

#### Fifth

The fifth area comprises a series of three annual workshops conducted with Canadian government officials, designed to stimulate discussion of foreign policy problems between Centre staff and policy makers from various Federal departments and Provincial governments. These workshops were motivated by the belief that scholarly activity may not necessarily make its widest impact through the publication of research in traditional academic outlets. As scholars of foreign policy, Centre members wished to have their research made available to the policy community, who are often the subjects of this research and to whom, among others, the findings are implicitly directed. Workshops were viewed as an innovative means of interacting with the policy community, and of making the results of scholarship available to that community. In this manner the Centre hoped to help bridge the gap between academics and practitioners that members of the scholarly community often complain about.

#### 1977

The first workshop was held in Lunenburg, N.S. in May 1977, entitled: "Canada's Future in a Changing World." Organized by Gilbert Winham and Glyn Berry, the purpose of the workshop was to provide a stimulating environment for individuals with different perspectives to reflect on future directions in Canadian foreign policy. This workshop attracted 18 civil servants from six agencies of the Federal government, as well as three Provincial governments. It also benefitted from the presence of two senior officials as resource persons, Mr. Geoffrey Pearson from External Affairs, and Mr. Alex MacPherson of Finance.

The major portion of the workshop was devoted to a simulation of a negotiation between Canada and a fictitious Third-World country over economic issues, conducted by Gilbert Winham and Glyn Berry. A Delphi

forecasting exercise on Canadian foreign policy was conducted by Don Munton. The workshop also included seminar presentations by Centre staff, namely: "Forecasting Global Trends in the 1980's (Don Munton and Timothy Shaw); "Changing International Relations: Canada and the Third World" (Timothy Shaw and Glyn Berry); "Changing Atlantic Relations: Canada and the EEC" (Robert Boardman); and "The Policy Process, Public Accountability and the New Foreign Policy Agenda" Denis Stairs).

Some of the material presented by Centre staff at the 1977 workshop has subsequently been published. This includes: Denis Stairs, "Responsible Government and Foreign Policy," International Perspectives, May/June, 1978; Robert Boardman, "Canada and the Community: One Year After," The World Today, October, 1977; and Glyn R. Berry and Gilbert R. Winham, Canada-Third World Simulation, Halifax, Centre for Foreign Policy Studies, 1978.

#### 1978

The second workshop was held in Chester, N.S. in May 1978, entitled: "Canadian-American Relations in a Changing World." This workshop was organized by Don Munton and Dean Swanson, and was similar in purpose and design to the first workshop. The participants included 16 civil servants from the Federal government and three Provincial governments. Also attending the workshop were Mr. J. R. McKinney, Director-General, Bureau of United States Affairs, External Affairs; and Professor John Sigler, Director of the School of International Affairs, Carleton University. Professor Sigler led an evening discussion of Canada-United States relations from the American perspective.

The workshop featured a simulation of Canadian-American negotiation of Great Lakes environmental issues, conducted principally by Don Munton, with assistance from Dean Swanson and Gilbert Winham. A forecasting exercise on Canadian-American relations was conducted by Don Munton. Seminars were presented by Centre staff on the following topics: "Intellectuals and the American Connection: A Discussion of the Literature on Canada-U.S. Relations" (Denis Stairs); "Canada, United States, and the NIEO: Contrasts in Policy and Perception" (Timothy Shaw); "Science and Technology for Development: Canada and the United States (Peter Aucoin); and "The Effect of Domestic Pluralism on

Canadian and American Negotiation" (Gilbert R. Winham; revised and published as "Bureaucratic Politics and Canadian Trade Negotiation," <u>International Journal</u>, Vol. 34, Winter 1978/79).

#### 1979

The third workshop is currently being planned for May, 1979. It will be under the direction of Robert Boardman and Lawrence Gould.

#### 2. WORKSHOPS AND SEMINARS

#### Canadian Maritime Interests: 1980-1999

Organized by Michael K. MccGwire, a 25-person, two-day workshop was held in April 1972. This workshop involved senior federal officials, naval officers, and academics, and sought to open up new ways of thinking about maritime interests and about the consequential requirements for maritime forces.

# Advancing and Contending Approaches to the Study of Chinese Foreign Policy

Under the guidance of Roger L. Dial, a four-day workshop was held in May 1972 for the purpose of stimulating and promoting the social scientific approach to understanding Chinese international behaviour. Fourteen distinguished students of Chinese foreign policy were assembled to consider a series of papers presenting discrete conceptual areas of social science that are applicable to China studies. Funding for the workshop was provided by the Canada Council and the Centre for Foreign Policy Studies. The Centre subsequently published a collection of twelve workshop papers: Advancing and Contending Approaches to the Study of Chinese Foreign Policy, Roger L. Dial, ed., 1974.

# Soviet Naval Studies Group

Under the Chairmanship of Michael K. MccGwire, a series of four seminars have been held on "Soviet Naval Developments." Participants have constituted themselves as the Soviet Naval Studies Group, an informal association of analysts working in this and related fields. The group is international in scope, comprising principally Canadians, Americans and British, but others as well. Its members are affiliated with the academic research organizations and government agencies, and include most of the prominent figures professionally concerned with this topic. The objective of the seminars is to raise the level of informed analysis and debate by ensuring that as much data as possible is made readily available on Soviet naval capabilities and deployments, and that analysis of Soviet naval developments is carried out within the full and proper context. The latter encompasses the whole range of Soviet domestic, economic, foreign and military policies, as well as naval developments world wide. Michael MccGwire acts as informal coordinator of the group, assisted by John McDonnell, a Research Associate of the Centre. The first three conferences were held at the Saraguay Club in Halifax, the fourth in Washington, D.C.

The first seminar was held in October 1972, in response to contradictory assertions about the substance and significance of Soviet naval developments advanced in connection with western naval appropriations debates. hoped that by assembling those with special expertise in this and related fields, irrespective of institutional affiliations, some balance could be achieved between capabilities and context, which could thereby raise the level of informed analysis and debate. Funding was provided in part by the Canadian Institute of International Affairs, as well as by the Department of National Defence. Approximately 45 individuals participated in this four-day intensive seminar, out of which emerged, if not complete agreement, a fairly general consensus as to the background and context of Soviet naval developments, including their underlying causes. The success of the experience led to the publication of a collection of thirty-six papers, initially in a soft-cover version as part of the Centre's publication series, and subsequently in hard cover: Soviet Naval Developments: Capability and Context, Michael MccGwire, ed., New York: Praeger Special Studies, 1973.

The second seminar on Soviet Naval Developments was held in October 1973, using the same four-day intensive format, with some 60 participants. Funding was obtained in the form of a special grant from the

Department of National Defence. A series of eleven articles by Admiral Gorshkov, Commander-in-Chief of the Soviet Navy, which had been published in that service's professional journal in 1972-73, provided the background and focus for the seminar. Discussion covered such topics as economic and political constraints in the formulation of Soviet naval policy, the Soviet Navy as an instrument of foreign policy, and Soviet naval developments in comparative perspective. Papers from this conference were subsequently published in Soviet Naval Policy: Objectives and Constraints, Michael MccGwire, Ken Booth and John McDonnell, eds., New York: Praeger Special Studies, 1975.

The third seminar was convened in September 1974, using the proven format of an intensive workshop limited to sixty participants (which now required turning away a number of applicants). Funding was provided by the Canada Council as well as by the Department of National Defence. Discussion continued on the evolution of Soviet naval developments, and particular attention was focussed on warfighting and projection capabilities, East-West naval interaction, and Soviet naval involvements in the Third World. A third collection of papers was subsequently prepared and published as Soviet Naval Influence: Domestic and Foreign Dimensions, Michael MccGwire and John McDonnell, eds., New York: Praeger Special Studies, 1977.

A fourth Halifax seminar had been planned for the spring of 1977, but circumstances made it more convenient to convene an abbreviated session in Washington, D.C., in June, under the title "Update on Soviet Naval Developments." This three-day session was co-sponsored by, and held at the facilities of, the Carnegie Endowment for International Peace. Approximately sixty individuals participated, drawn mostly from the Washington policy-making community, but with both Ottawa and the academic community well represented. Admiral Gorshkov's writings, in particular his recent book The Seapower of the State, were the focus for the first day. The second and third days focussed on the Soviet Navy's mission structure in war, based on a thorough review of all relevent aspects such as operational capabilities and deployments.

Although there are no immediate plans for further publications or conferences, the Soviet Naval Studies Group continues to serve the purpose of bringing together analysts in various sectors of the community for informed interaction.

#### Canada in World Perspectives

With the assistance of Denis Stairs and Don Munton, an in-house seminar on external perspectives of Canadian foreign relations was begun in 1973. Papers authored mostly by Centre staff were presented, extensively discussed, and revised for publication in a volume to be entitled, How Others See Us: Canada in World Perspectives. Individual chapters present views of Canada's role in international politics held by major powers, smaller powers, international organizations, and transnational actors. Contributors not affiliated with the Centre include Brian W. Tomlin and David Cox. Under the sponsorship of the Centre, work on this volume is in progress with the editorial assistance of Denis Stairs and Don Munton.

# The Changing Role of the Diplomatic Function in the Making of Foreign Policy

In late January 1973, the Centre sponsored a four-day seminar in order to consider the changing structures and processes of diplomacy with special reference to Canadian foreign relations. The thirty participants included diplomats and scholars mostly from Canada, but with visitors from Britain, West Germany, and the United States. Media, business, and provincial interests in the diplomatic function were also represented. Five papers were commissioned either for the seminar itself or as an outcome of the discussions that took place there. They have been collected and published by the Centre as an Occasional Paper: The Changing Role of the Diplomatic Function in the Making of Foreign Policy, John W. Holmes, et al., June 1973.

# Energy and Defence: Canada's Continental Concerns

A one-day public seminar was held in April of 1973 for the purpose of considering Canadian policy options with respect to several continuing continental concerns. Participants from Canadian and American universities, the Canadian Institute of International Affairs, business, industry, defence, and the local community exchanged views on the topics of the Atlantic Provinces in the context of national energy policy and continental defence policy in the context of the then pending renewal

of the NORAD agreement. The seminar was held under the auspices of the Centre and the Canadian Institute of International Affairs.

# Southern Africa: A Case Study of a Regional Subsystem

Timothy Shaw and Kenneth Heard organized a workshop in August 1973 in order to assemble academic specialists to consider patterns of interaction in Southern Africa within three issue areas: (1) culture, race and history; (2) economic and infrastructural linkages; and (3) political and military systems. The workshop explicitly examined the utility of viewing Southern Africa as a subordinate state system and found that this approach not only permitted the analysis of hitherto undiscovered patterns of conflict and cooperation, but a wider range of actors than more traditional approaches. Funding for the workshop was provided by the Canada Council, the Faculty of Graduate Studies at Dalhousie, and the Centre. Revised workshop papers are included in Cooperation and Conflict in Southern Africa, Timothy M. Shaw and Kenneth A. Heard, eds., Washington, D.C.: University Press of America, 1976 and 1977.

# Approaches to the Analysis of Canadian Foreign Policy

With the assistance of Denis Stairs and Don Munton, a three-day workshop was held in May and June 1974 for the purpose of considering demonstrations of alternative perspectives on and methods of studying Canadian foreign policy. Forty-two scholars and officials met under Centre auspices and with the financial support of the Canada Council and the Faculty of Graduate Studies at Dalhousie University. Nine papers were presented for discussion around four themes: the concept of foreign policy, domestic and external sources of Canadian foreign policy, and the Canadian foreign policy-making process. A record of the proceedings has been published by the Centre: Approaches to the Analysis of Canadian Foreign Policy, Denis Stairs and Don Munton, eds., 1975.

#### Foreign Policy Seminar

A seminar focusing on issues associated with Canadian foreign policy was held in February of 1976 for the purpose of stimulating a dialogue between representatives of the Department of External Affairs and concerned individuals in the Atlantic Provinces. Participants were selected to include academics, provincial government leaders, media representatives, regional business and community leaders, and officials from External Affairs. Issues associated with Canadian policy toward the Middle East, the United States, and maritime interests were intensively considered, and the then Secretary of State for External Affairs, Mr. MacEachern, conducted a question and answer session. The workshop was sponsored by the Centre and the Department of External Affairs.

#### Trade and Aid to the Third World

Two public workshops were held in April of 1976 on the topics of trade and foreign aid in the context of Third World development. Academic participants, federal officials, and representatives of civil groups considered issues concerning Canada's aid and trade policies, seeking to increase understanding of these problems in the Atlantic Provinces. Canada's international role in the United Nations conferences on the new international economic order received particular attention. The workshops were sponsored by the Centre, the International Education Centre at St. Mary's University, the United Nations Association in Canada, and local committees of the Canadian University Services Overseas.

#### Foreign Policy Workshops

A series of three workshops for Canadian civil servants is being conducted over the years 1977 and 1979. These workshops are described on pages 8-10 of this report.

#### Workshop on Conflict and Change in the Horn of Africa

A public workshop concerning the evolution and implications of the contemporary changes in the Horn of Africa was held in April of 1978, attended by Canadian and foreign scholars as well as specialists in East

African development and politics. Participants discussed economic, political, and regional factors in the historical evolution of the conflict occurring within and between Ethiopia and the Somali Republic and, in addition, the global, strategic, and ideological implications of the processes of change in the Horn. The workshop was sponsored by the Centres for Foreign Policy Studies and for African Studies.
