My dear Abdul,

Thank you so much for your interesting and constructive letter of April 24, which reached me yesterday.

I think that the hearings we are organising for the World Commission for the Oceans will contribute valuable material with regard to your third point, that is to determine how far, if at all, our Convention has contributed to the economic and social needs of the developing countries. I am afraid, thus far the result will be rather negative. Developing countries, in most cases, just have not been in a position to take advantage of the Convention. One purpose of our World Commission certainly is to see to it that they should indeed enjoy these benefits.

I agree with you that it would be very useful to have an FAO study on this subject,. I'll try to get it done!

As to you, fourth point -- I am sure you must have seen Judge Oda's recent paper with his sharp attack on Part XV of the Convention and, especially, the International Tribunal for the Law of the Sea. He has, as always, a very sharp mind, and although there is some degree of balance in his judgment I do think the negative side of his argument is too heavy. The dispute settlement system of our Convention has universally been hailed as the most advanced system in existence today. Nothing is perfect, of course, but where is anything better?

I am not happy that the Straddling Stocks Conference is trying to create a separate dispute settlement system. That strikes me as absurd, when it is quite obvious that they should use the L.o.S. Convention system!

Do you think you yourself might prepare a paper on your point 4, that is, a study to determine what types of disputes are better handled by Hamburg or the Hague, for presentation at PIM XXIII? That would be a wonderful contribution.




Thank you for you facsimile inviting me to join the Commission and to participate in the first Plenary Session scheduled to be held in Tokyo 6-8 September 1995.

My dear Abdul,

I was horrified to hear that you still had not received any letter from President Soares. I checked immediately, and was told that a letter had been prepared and should reach you soon....

So much for that. The same applies to our friend Fleischhauer, and I would be grateful if you could explain the situation to him and give him my warmest regards. I hope things will be on course with the Commission, after this Tokyo meeting.

As to Pacem in Maribus XXIII, I am equally horrified. As the saying goes, too many cooks spoil the broth. Cooperation between Costa Rica and ourselves has been on the whole quite good, but obviously there are cracks in the communication, and the invitation you should have received must have slipped into one of them... I am attaching today the formal document that went out to everybody; as well as the detailed agenda as it stands at this moment.

I will not attach the background paper, because it is too long, but I know you received it, because you wrote a nice letter back to me. If you cannot find it, it is also reproduced in my little book, Ocean Governance and the United Nations, of which you have a copy.

The Agenda for Peace, as you remember, deals with the peaceful settlement of

Disputes as an essential part of peace-making. It does not mention the Law of the Sea at all in this connection. If you can come, could you make a statement on this whole issue? You need not have a written paper: the time is too short now,, but you could speak from your notes, and write the paper later. Eventually, I would love to have a paper. The Conference is co-sponsored by UNESCO which will also publish the Proceedings, and so I am particularly keen to have good papers!

We would also like to have you preside over one of the sessions. We need a good African presence. I have also faxed to Warioba, from whom we have not heard in a long time, but he has not yet answered.

If you can come, we would send you your round-trip ticket and, of course, everything is taken care of while you are in Costa Rica. You should, if possible, plan to travel on December 2 and to leave Costa Rica on December 10, because on the 8th and 9th we have Boaard meetings and meetings of the Directors of our Operational Centres, and these are interesting internal meetings.

I'll be in Lubljana until the 22nd, but our office here will follow up on your instructions immediately. You also very kindly might fax the registration form (it is on the printed programme) to Costa Rica.
