For your orientation I am enclosing a table of contents of the book. Perhaps there might be another chapter which would be of interest to you.

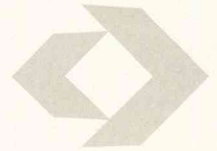

Leon Sager was kind enough to talk to you about the possibility of getting a piece on the oceans published in the MAINLINER.


