This is to confirm what I told you just now over the phone.

On March 15 I am leaving on a study trip = starting in the Soviet Union, going through India (Delhi, Cochin) Indonesia, Thailand, Philippines, Korea, Japan, and China (Peoples Republic). I will return to the States early in May. The purpose of my trip is to study aquaculture and seafarming. I am preparing a book on this subject, which will be published by Harry Abrams in New York in 1978.

My general field of interest is ocean management and the law of the sea, especially in the context of the new international order (including the new international economic order). I am enclosing a partial bibliography.

I am an American citizen and resident of Italy. I am an associate of the Center for the Study of Democratic Institutions, Chairman of the Planning Council of the International Ocean Institute, and an Advisor to the Austrian Delegation to the Law of the Sea Conference.

Until March 11 you can reach me c/o the Austrian Delegation, Law of the Sea working session, United Nations, Geneva. From March 11-15 I can be reached c/o my mother, Mrs. Thomas Mann, Alte Landstrasse 39, Kilchberg/Zurich, Telephone 715 4666. From then on, it will be difficult to reach me -- except, perhaps, through my Santa Barbara office, by cable.

I am looking forward to hearing from you in Geneva or Zurich, and shall then get in touch with the officers and offices you may indicate in your letter as my itinerary takes shape.
