I do hope the delay hasn't caused any inconvenience.



Dear Mr. Tagare,

I have just read the excellent article in the current issue of *Sea Technology*, and I feel lucky and honoured to have had the occasion to meet with you personally. Certainly, what you are doing shows the kind of vision that one does not encounter often in the business world -- or anywhere else for that matter.

Now I have some very encouraging news.

After careful consideration, I decided to apply to the Global Environment Facility (World Bank, United Nations Development Programme, and United Nations Environment Programme) for a grant of \$10 million which would be supplemented by another \$10 million from the "Pioneer Investors among the sea-bed mining companies, and another 10 million from "Sponsors," including -- if possible -- undertakings such as yours -- and for the reasons explained in the memo drafted by Dr. Saigal. This total would be for a period of five years. The \$10 million from the GEF would include \$55,000 for the preparatory feasibility study, to be undertaken this year. This is the "pump priming" that is needed.

Actually, the role of the International Ocean Institute would be to act as a catalyst. Once the feasibility study is done, the necessary MOUs are signed, etc., the International Sea-bed Authority would become the executing agency. But a catalyst is needed, and I believe, only the International Ocean Institute can do that job.

To my most pleasant surprise, the GEF responded immediately, and very positively and urged me to come to Washington ASAP. I certainly will be there before the end of the month

I thought it would be useful to keep you updated on the development of this project for which you have been kind enough to show interest.

I hope that you have not forgotten the rare but so pleasant and fruitful contacts that we had in Trieste at several occasions related to the activities of TWAS and women scientists. Later I had written to you and Alex Kwapon when he was at Dalhousie University having the privilege to work with you.

Presently I am a temporary guest scientist at the ICTP in Trieste where I continue to deal with the United Nations University (UNU) programme on Informatics for development. We are holding an International Conference on Information Technology for Social Purposes at the Univ. of Las Palmas in Grand Canary, end November 1991. I am organizing it and I look forward to achieve good results. I have also some contacts with TWOVS, especially with Lydia Makubu.

However to-day I am writing to you on another matter. My daughter Stanka Tanaskovic has been working for 8 years at the ICTP as program officer for international activities. Enclosed is her C.V. Although she likes her job here, she is obliged to look for another job somewhere else. Canada would be an ideal country from many points of view, not the least with regard to the tragic events in our own country, Yugoslavia, which prevent my daughter to return to her home. Meanwhile, and that is prompting her to move out of Trieste, an extremely critical financial situation has occurred at the ICTP, which is threatened to be closed definitely in the near future. Staff might be dismissed anytime. *Un malheur ne vient jamais seul!*

What is happening in your country absolutely breaks my heart. As you know I was a student and great admirer of the Self-management system of Yugoslavia which, I think, was one of the most interesting and important contributions to the constitutional and political post-World War II evolution. And I have so many friends in Yugoslavia, and know how hard they worked and how devoted they were to their ideas and ideals. To see it all destroyed, and to see us back in 1914 is a nightmare; it is a tragedy; it is insanity. And all that totally useless killing and suffering.

I wish I could help your daughter.

But it is not the IOI, it is ICOD (International Centre for Ocean Development) that is advertising for Programme Officers --and they are all Canadian. Nevertheless, I will give your letter, and your daughter's CV to the new President of ICOD, perhaps he can do something.

In the meantime, I hope the news about the ICTP is no longer as black as it was. My understanding is that the crisis was temporary. So I hope your daughter is still there and can remain there.

Pehr Wilhelm Wargentin (1717–1783) var Kungl. Vetenskapsakademiens sekreterare under 34 år från 1749 och förenade detta ämbete med befattningen som akademiens astronom. Wargentins uppgift blev att nästan från grunden bygga upp den unga akademien samt att uppföra och förestå Stockholms observatorium – akademiens första vetenskapliga institution. Han räknas även som en av den svenska befolkningsstatistikens grundare.

*Pehr Wilhelm Wargentin (1717–1783) was Secretary General of the Royal Swedish Academy of Sciences for 34 years, from 1749. He combined this office with the position as the Academy's Astronomer. Wargentin's first task was to establish the recently founded Academy and at the same time build and head the Stockholm Observatory – the Academy's first scientific institute. Wargentin is also regarded as being one of the founders of Swedish population statistics.*



Vielelleicht sind schon Geruechte zu Ihnen gedrungen, ueber Bestrebungen, ein *Operational Centre* unseres Internationalen Ozean Institutes an der Universitaet Bremen auf die Beine zu stellen.

Wir haben solche *Centres* bereits in 10 Laendern (Canada, China, Costa Rica, Fiji, India, Japan, Malta, Romania, Senegal, South Africa) -- und warum eigentlich nicht in der Bundesrepublik? Es waere doch schoen und nuetzlich. Wir haben ein recht umfassendes Programm, was fuer alle Teilnehmer interessant und nuetzlich ist: *training programmes, research programmes, publication programmes, Conferences, leadership seminars, alumni activities, etc.*

Abgesehen von freier Zusammenarbeit, von einer gemeinsamen "Philosophie" - die des *Common Heritage of Mankind* -- inspiriert, sind unsere *Centres* voellig autonom und sollen sich besonders auch lokalen und regionalen Problemen widmen. Alle unsere *Centres* sind in hoch angesehenen nationalen oder regionalen Lehr- und Forschungs-Institutionen untergebracht. Wie Sie sicher schon wissen, sind wir nicht ein ozeanographisches Institut, sondern ein *policy research* Institut, das aber enge Zusammenarbeit mit den ozeanographischen Wissenschaften zur Voraussetzung hat.

Die Vorbereitung dieser grossen Konferenz, ueber das Thema, *The Century of the Ocean*, waere die erste Aufgabe des IOI Bremen. Es besteht daher ein gewisser Zeitdruck: Wir muessten wirklich IOI Bremen im ersten Halbjahr auf die Beine stellen, damit es dieser Aufgabe gerecht werden kann

I shall be in Geneva next week and shall certainly try to get in touch with you. In the meantime, however, I would like to ask for your advice and, if possible, help in the following matter. Our great mutual friend, René Jean Dupuy encouraged me to do so.

I think you will find all the necessary information about our Institute in the material that will reach you very soon from Malta (where we have our headquarters).

We are now trying to raise an Endowment fund, to insure the independence and continuity of our activities.

We started in Japan -- I think, quite successfully.

Our Endowment plan provides for several segments. The largest one is for our annual conference, Pacem in Maribus, which we would like to see endowed, let us say, like the Pugwash Conference. We need five million dollars for that. A Japanese donor told us he would seriously consider to contribute half this endowment (\$2.5 million) if we could raise the other half from another source or other sources. We are now working on this.

The second big component of the Endowment plan concerns scholarships. To endow a scholarship in perpetuity requires \$100,000. Our ambitious goal is to raise 60 such scholarships (each named after the donor) -- ten for each of our operational centres. Thus far we have two, with the possibility of adding one every year from the funds contributed annually from our Swiss donor.

Now we would start the Endowment drive in Europe and North America as well: I think our efforts should focus on the private sector since most Governments and funding institutions are not in a position to contribute to an endowment. They are project oriented.

Could you give us some good advice as to where to look for scholarship endowment in Europe and North America? How do you like the Endowment Plan -- would you

suggest corrections or additions?

Whatever you can do to help us in this matter will be most fervently appreciated.

And let us go skiing soon!

We have been out of touch for quite a while.

This is just to confirm that everything is in good order for the seminar on August 24 and 25. I have secured the participation of the best possible experts,

Dr. William Dillon, NOAA, is heading NOAA's methane hydrates project;

Dr. Alexander Malahoff, University of Hawaii, is one of the chief explorers of the deep-sea geology and its minerals;

Mr. Lyle Glowka, of IUCN, Bonn, is one of the best specialists on the genetic resources.

Most certainly quite a few people from the Secretariat will be interested, starting with Mr. Nandan himself, and including Mr. Nii Odunton, Mr. Kaiser de Souza (their geologist) and Mr. Anthony Jones ( their biologist). There are also people from the University who should get invitations. Perhaps you could discuss it with Ivan Goodbody.

We are getting the air tickets for the three main speakers, we are putting them up at the Pegasus. On the other hand, if the Government, as co-sponsor of the seminar, would be willing to take care of them while in Jamaica, that would of course be excellent.

I imagine the procedure as follows: The seminar should be conducted on both evenings from 18:00 to 20:00. The first evening would focus on the hydrates and the other nonliving resources.

Some of this discussion should be carried over to the second evening; the genetic resources should have one hour and a half the second evening.

On both evenings, a simple buffet supper, with drinks, and a cash bar, should be served at 20:00. The manager of the Cafeteria of the Conference Centre arranges that beautifully and inexpensively. When we had our last reception there, for the Delegates and the participants of our training programme, the whole thing cost only US\$960, and it was beautifully done. I think there will be more people this time, but certainly the cost will not exceed US\$1,500. I would suggest that we pay for one evening and you pay for the other. Is that an acceptable format?

I think the seminar will make a most useful contribution to the study which some Delegations of the G77 have requested from the Secretariat, and the Secretariat welcomes this contribution.

Dear Professor Tobin,

First of all, I should like to introduce myself. I am Founder and Hon. Chair of the International Ocean Institute (we now have "Operational Centres" in 12 countries, all hosted by prestigious local institutions). A short description of the IOI is enclosed herewith. For your convenience, I am also enclosing a short CV of mine. I am Professor of Political Science and Adjunct Professor of Law at Dalhousie University.

Next, let me point out that I have long been an admirer of yours and your highly inspirational proposal for the "Tobin Tax."

This concept, I think, is today even more important than it was when you first proposed it. With "globalization," etc. the time for international taxation is inexorably drawing nearer. The World Bank, the United Nations, the developing countries, all are clamouring for "innovative methods to create new and additional funding" for the realization of all the beautiful development & environment plans which are stagnating because of lack of funding. The time has come to look at your proposal again. There is a lot more money in it today than when you first put it forward; and technologies to computerize and control the process have improved thousandfold.

I wonder what you would think about a pilot-scale experimental application of your proposal or some variation of it.

We have been doing a lot of work with the International Sea-bed Authority (in Jamaica), which is responsible for the management of the International Sea-bed Area, beyond the limits of the legal continental shelf. This international area is now being traversed by an incredible number of fibre-optic cables carrying a communications traffic worth -- already today a trillion dollars a year, and likely to double in a short time.

Since the Authority will have to regulate coordinate the laying and repairing and disposal of these cables, or their re-use for permanent deep-sea observatories, whose number is also

growing, it is only fair that the Authority should be compensated for this supervisory activities. If these companies were to pay only 0.001 percent of the value of their transactions, the whole development-environment picture in the world would change. This would indeed be an innovative way to generate new and additional funding to assist poor countries in the effective implementation of the whole UNCLOS/UNCED programme!

This becomes all the more logical and urgent since the United States is going to impose a quite substantial "rent" on the cable companies for permission to pass the cables through the US EEZ. I was told this just now by a senior staff member of NOAA.

With this background information, let me now come to the gist of this letter.

The International Ocean Institute is about to launch a new, very ambitious and exciting project as a contribution to "capacity building" mandated by all the UNCLOS/UNCED Conventions, Agreements and Programmes. This IOIVU will integrate the training programmes of all our Operational Centres as well as the ocean-related programmes of their host institutions, to build an internationally recognized, interdisciplinary Master's degree in ocean affairs and the Law of the Sea, accessible to any qualified student anywhere in the world. Including all this network, which is open-ended -- we welcome other institutions that wish to participate -- we will use combination of high-tech distance-learning technology with internship and traditional on-campus learning. The programme is co-sponsored by the United Nations University, UNESCO/IOC, the World Maritime University (IMO), and the United Nations Peace University in Costa Rica. We are just now entering into a partnership agreement with the Nippon Foundation in Tokyo and plan to have the first students enrolled in September, 2001. We are in the process of preparing a number of "core courses" for delivery "on line." At least one of them will deal with ocean-related economics. It is for this course that we would like to ask you for a videotaped interview or conversation, or, better, a little talk of yours, revisiting your proposal in the new context.

I know how extremely busy you must be. A look at the "Tobin tax" web site makes it quite clear that your proposal is having a "renaissance." It would not take you very much time, however, and it would be absolutely precious for our students worldwide. Could you be so very kind and generous as to do that? The purpose really is to enhance this our common cause.

If you will let me know soon, we would then make all the arrangements.





Dear Dr. Töpfer,

I was delighted to receive your letter dated September 23, and I can assure you that I agree with all the points you made.

No doubt, the effectiveness of a global “ocean assembly” will depend largely on how solid the regional components are. Probably more than anybody else, I have been insisting on the importance of regional organisation as a pillar of the whole system of ocean (and coastal) governance. And what is more, it is at the regional level that we will see most progress and most innovation during the next decade(s). The level of the nation state is rigid. Action at the global level is slowed by the rigidities at the nation state level. There is much more elasticity at the coastal-community and at the regional level, and, of course, innovation there will then affect the whole system.

And most certainly, we need a strategy to use the ongoing process for the revitalization of the Regional Seas Programme as a point of leverage for the proposed UN Ocean Assembly. An important element in this discussion is to find the best way to have the Regional Seas regimes represented and actively participate in the Assembly. One fact that has debilitated the emerging system of ocean governance thus far is the *lack of linkages*, on the one hand, between coastal communities and the regional seas programmes, on the other, between the regional seas programmes and the global level.

I believe that the local-regional gap is beginning to be filled by the institution of the Mediterranean Commission on Sustainable Development, which really is an innovation that

would have been unthinkable even a few years ago! All other Regional Seas programmes should learn from this experience!

But effective linkages between the regional seas and the global level have yet to be designed.

On your third point, I think we should have regional "leadership seminars" within each one of the regional seas programmes, to discuss the whole area of "revitalization" which includes the issue of linkages.

These leadership seminars should include representatives of "stake holders" as well as voluntary organisations, etc. That should respond to your fourth point.

On your fifth point, I have sent the proposal to Patricio Bernal, with the suggestion that the establishment of the "Assembly" would greatly facilitate the work of the ACC Sub-Committee. I have also sent it to Hans Corell, whose recent Oslo speech very much stresses the role the GA must play, but he avoids the question of *time*. It seems to me so obvious that the GA simply does not have the time necessary to do the job. Hence the suggestion of the Committee of the Whole


I think the panel you are suggesting to plan the whole course of action is an excellent idea and should be established just as soon as possible.

In the meantime I have mobilized quite a few delegations and Ministries of Foreign Affairs -- and I do think we can get it done. It is, again, a question of time -- if not this year, then perhaps next year, but it would be so good to use the momentum of the International Year of the Ocean.

We have tried our hands at a pre-pre-pre-draft resolution, which I am attaching. The Legal Advisor to the Foreign Ministry of Sweden, whom I met in Jamaica, suggested a few more points. I am attaching her draft as well.

All the very best, and thanks for your support and encouragement.

I also asked him for a couple of small things I still need from him: a one-paragraph note on him, the way he would like it to appear at the end of the book in the section "contributors to this volume." And I also needed a few bibliographical indications which were missing in his text.


The book, which will be very beautiful, will be published in 1992. Dr. Federico Mayor, Director-General of UNESCO, has agreed to write the Preface.

As to your other question, I am not quite clear. Unfortunately we do not have any funds to contribute for the printing and paper. I think you might ask UNESCO the magazine **Ecology and Peace** might prepare a special issue for UNCED in 1992. I think that would be very very useful.

I am also not sure to what Rotterdam school you are referring. Do you mean the Erasmus University? the Netherlands Institute for the Law of the Sea (NILOS)? That is in Utrecht.

I myself would be more than happy to collaborate with the magazine. Please do keep me informed how things are proceeding and if and when you need an article.


