The College of Fort Williams is

sums, paid by me, during the four years
I was connected with the College, for printing
the Analyses of my Philosophical Course
by order of the College, for Chemicals, for
breakage of App. which the College, by an
official letter from the Provost, engaged
to make good, and lastly for three years
allowance to an Assistant, the first year's
allowance was paid. The whole amounting
