Dear Dr. Jagota,

I am enclosing a brief article, consisting basically of the two statements I made during the Algiers Conference. Don't waste your time with it, but I would be grafeful if you looked at pp.5-9 concerning the Enterprise. This proposal was much discussed and very well received in Algiers.

I would like to add two points for your consideration:

Frank LaQue, retired Vice President of International Nickel Co., wrote to me in a recent letter:

With regard to the joint venture approach there is a chance that one or other of the existing consortia might be persuaded, even though reluctantly, to enter into joint ventures with a Sea Bed Authority in preference to proceeding independently with uncertain rights under a Freedom of the Seas doctrine.

They might also be influenced by fears of retaliation for independent action in terms of possible cutting off of supplies of strategic or critical metals by developing countries wishing to exercise some control, whether needed or not, over the exploitation of the ocean metals.

In other words, and knowing Dr. LaQue as a very careful and conservative spokesman for the industry, there is a real chance that a proposal like the one we have been working on might be accepted.

The second point I wanted to bring to your attention concerns nodules situated in areas under national jurisdiction. We raised this point a long time ago, in Caracas, but most people did not want to hear it at that time. Today it is absolutely certain that there will be exploitable nodules in areas over which national jurisdiction will be claimed. I was recently in Mexico for work on the excellent Third World Center there and saw that the Mexicans are enthusiastically busy about the exploitation of nodules in areas under their jurisdiction. Where does this leave the Seabed Authority?

The point I want to make is that the system we are proposing is equally applicable to areas under national jurisdiction: Instead of entering into agreements with the private Consortia -- as Mexico is about to do -- developing coastal nations should enter into joint ventures with one of the International Seabed Authority Enterprises: whereby the coastal State under whose jurisdiction the nodules are situated could control 51% and appoint half plus one of the members of the Board. This would be better for the developing country -- and it would save the Seabed Authority. And it all would fit into one uniform joint-venture system, controlled, in the international area, by the Authority, in areas under national juris' diction, by the coastal State.

All the best for 1977. May it be the Year of the 77! Looking forward to seeing you at the Evensen Group meeting in February,

Dear Dr. Jagota:

After Pacem in Maribus VII we worked out an "expanded cooperative program on the New International Economic Order and the Law of the Sea. I am enclosing a copy. This is a second draft, which is the result of a number of consultations with a number of governments. In particular, I am glad to report that we have the full approval of Algeria and Yugoslavia. It is in accordance with our discussions with members of these Governments that we are now circulating the proposal among all members of the Coordinating Durcau of the Non Aligned countries, with the hope that it will be approved, and a general resolution of support will be adopted, at the forthcoming meeting of the Bureau in New Delhi.

This is where we need your cooperation and help. Could you convince your Government to support the proposal?

Two days ago I discussed it also with Shirley Amerasinghe who, as Chairman of the Board of Trustees of the IOI, had been familiar with the proposal from the beginning. If India, Algiers, Yugoslavia, and Sri Lanka support the proposal, it will undoubtedly go ahead. So India's position in the matter is rather crucial. Shirley is going to take the matter up with Ambassador Jaipal before leaving New York, so the matter is rather urgent.

I plan to be in India towards the end of March, in connection with another matter (see attached letter) and would be glad to give any additional information or explanation if needed. I could also anticipate my visit if this were advisable. (I am scheduled to be in the Soviet Union after the meeting of the Evensen group in Geneva, and then to proceed from the Soviet Union to India, but, if necessary, I could go to the Soviet Union later).

I am enclosing a number of background documents.


I feel we have given up nothing, and gotten more, and now, than we could get under any other system. Also: we have solved a lot of problems and simplified the text of Part XI as a whole.
