Dear Paul:

We have been out of touch for too long. I'll be in New York during the first days of May. Can't we have lunch together or something?

I have two urgent concerns, not to say, anguishes, at the moment:

Over two years ago, maybe three years ago, I sent you a manuscript, by an Australian friend of mine, asking you whether would consider it for publication. My friend's name is Geoffrey L. Kesteven. The book, which came with many illustrations, is about an Australian native artist by the name of Igpen. It is really about philosophy of art, and very well written. I never got a reaction to the MS and the material. And when, two years later, I requested its return to the author, I found out that it was lost. There was a record in your office indicating that it had been received, but nobody knew where it ended up. Now the author, Mr. Kesteven, is getting desperate about having it back. "Please please please can't I not at least have back my precious manuscript?" he just faxed...Is there anything you can do in this matter?

BBB My second concern is the date of publication of the Oceanography book. True, I was late in delivering. Some of my authors were late -- beyond my control. But we did make a new schedule, and I strictly adhered to that and delivered everything, retyped and cleaned up, last

October. We then aimed at publication in 1992, in time for the big Conference on Environment and Development in Brazil in June. Which meant: Spring 1992. Now it appears, things a moving very very slowly, and I am quite concerned we will not be able to meet this date. Which would be quite a loss on the promotion side. I would be most grateful if you could get things to speed up.

Is Andreas there? Please give him my love.

Dear Paul,

We have been out of touch for a very long time. I hope everything is going well over there.

I just want to try out an idea on you today, in connection with the children's book CHAIRWORM AND SUPERSHARK. Your people did not like it when they saw the dummy with the illustrations a couple of years ago.

In the meantime it was published, I dare say, in a very handsome edition in Jamaica. It also has been published in Italian translation (by Mursia, in Milano); the Italians are also making an animated video kind of thing of it; and, by the end of this year it should be out in Spanish (in Colombia) as well as in Japanese. So there definitely is a certain interest in the book.

We don't have an American distributor, but the first edition of one thousand copies is sold out, and the Mills Press (the Jamaican publisher) would like to print a paperback edition of 3,000 copies. They would print that in I think Connecticut, and it would cost very little.

We are particularly interested in reprinting because that big wonderful Smithsonian ocean exhibition (I was on their planning committee) is coming, and they expressed interest in selling the book in connection with the exhibition (their initiative). However, they do not have a budget for placing a large enough order to enable the Mills Press to do the reprinting.

I just had a talk with Judith Gradwohl and, actually it was she who suggested we might ask you whether you could not reprint this edition, or buy it from the Mills Press, so the Mills Press could print it. (I think she mentioned she is dealing with you in

connection with another book.)

How does that strike you? It would not cost you very much!

Do let me know.

I am travelling until April 9 (Qatar, Addis Ababa, etc.), but my office (FAX 1 902 494 2034) always knows where to reach me.

Give my love all around.

What a nice surprise to hear from you. In fact I was just thinking of you the other day. The father of one of my colleagues died and I remembered so well your very, very sweet note to me when my father died nine years ago. I am sure you don't remember your note but it contained something I have never forgotten.

As to children's books, sure why don't you send a copy of CHAIRWORM AND SUPERSHARK. It is true we didn't like it but I am always willing to look.

By the way what we're working on with Judith Gradwohl is the Ocean Planet book which stems from the Smithsonian show and its connection to the Times Mirror Magazine Company.

I think your travel schedule is unbelievable, but obviously that is what keeps you so young. On another matter I must do something about the next volume of your father's diaries. To be honest I really think this should be published by another house, but I would really like to talk about this with you before making any decision. I note that you will return on April 9th. I will not be back home until April 11th. Perhaps we could talk some time that week. My point is we only published those diaries because of Fritz's involvement. I think we did a beautiful job of designing and producing the book, but certainly it was so atypical for us that I am sure another house would do better with it. (Have you any ideas?) I would even be willing to license the first volume elsewhere if that made more sense.

I will have to be in touch with Fischer Verlag about all this but I would first really like to speak with you.
