



I am glad to inform you that

PACEM IN MARIBUS X

will take place in Nicosia, Cyprus, from April 8 to April 12, 1980. The Conference will be co-sponsored by the IOI and the Government of Cyprus. The main subject will be regional co-operation in multi-purpose surveillance and monitoring in economic zones of developing countries, with special attention to the Mediterranean. I am enclosing a provisional agenda: a final agenda will be worked out at a smallmmeeting in Lisbon next week.

The Government of Cyprus has generously agreed to pay for all local expenses, including hotels, food, local transportation, and conference facilities. The IOI has to pay for transportation to and from Cyprus. We have applied, as always, for grants from the Commonwealth Foundation and IDRC to cover travel expenses for participants from developing countries. It is far more difficult, however, to raise funds for travel expenses for participants from developed countries.

Since Cyprus is so centrally located, and not very expensive to reach for many of you, I wonder whether you could make other arrangements to get your travel expenses refunded. If so, please let me know as soon as possible. If not, please advise me whether you need half or the total cost refunded by the IOI. We are trying to make arrangements with the Cyprus Airline to get tickets at a discount price, and will inform you about such arrangements, if any, at a later date.


Under separate cover you will receive a brochure on the first course of our training programme. This course will begin in Malta on April 14 and run for 12 weeks until July 4. The first week, you will remember, is of a general, introductory nature and open to "decision-makers." If you could continue from Cyprus to Malta and participate at least in the opening days of the course, that would be very nice.

At the same time, we are initiating plans for a second course ("Class B") focusing on EEZ management. This will be funded by CIDA to the extent of \$100,000. We have applied for matching funds to the Rockefeller Foundation. The same system of scholar-ships will be applied to "Class B" courses as applies to "Class A" courses. Our application to CIDA is being sent under separate cover.

Lastly, you will receive, from Geneva, the IFDA Dossier of November, with our "Interim Report" on Marine Resources, Ocean Management, and Development Strategy for the 80s and Beyond. This project is being continued and expanded in two ways: an IOI Occasional Paper, with the full text of the report plus 4 Annexes is in preparation. Secondly, three case studies are in preparation, in the context of a project that is being coordinated by the RIO Foundation and will be carried out in collaboration with Dalhousie University and the University of Southern California.

With the OCEAN YEARBOOK, the Training Project, and the new line of research, we feel the IOI can adapt to the post-LoS-Conference period and plan for the next decade.

Your reactions and suggestions would be most welcome.

This is an overdue report on the current and projected activities of the IOI.

1. Postponement of Pacem in Maribus x

On November 19, Mario Ruivo, Dr. Andrestinos Papadopoulos of the Ministry of Foreign Affairs of Cyprus, and myself, met in Lisbon to complete preparations for Pacem in Maribus X. An agenda was agreed upon (Annex 1) and working papers were commissioned.

On December 27 I was advised (by telephone) by the Ministry of Foreign Affairs that the conference was cancelled "for technical reasons." It is clear that the political situation in Cyprus is very tense, and it is understandable that the Government has other priorities.

I immediately contacted our Yugoslav Board member, Dr. Anton Vratuŝa, and explored with him the possibility of transferring the conference to Split -- since it was advisable to keep it in the Mediterranean area if the agenda was to remain approximately as it had been planned.

Today the Ministry of Foreign Affairs advised me (by phone) that it was not possible to make the necessary financial arrangements in so short a time. Ambassador Periŝić, with whom I discussed the matter, indicated that there might be a possibility to hold the conference in Split early next fall (September 1980), and that we will discuss this possibility further in March, during the Law of the Sea Conference. In the meantime, the possibilities of other venues should be explored — especially Costa Rica and the Seychelles, which have been mentioned previously. In any case, while the agenda should remain as planned (with minor locally conditioned adjustments), it is clear that pacem in Maribus X is postponed. The most likely date is September, 1980. The most likely venue is Costa Rica or the Seychelles. Please give me your reactions and suggestions.

2. Training Programme

a) Class A: deep-sea mining

Project Director

The resignation of Professor Roger Vella Bonavita was accepted by the Planning Council with one dissenting vote (Edwin Borg Costanzi). Professor Paul

White of the Department of Mining and Metallurgical Engineering of McGill University has been appointed as provisional project director. His provisional term expires on July 15, 1980.

Schedule

The first course will take place, as scheduled, from April 14 to July 4. 1980.

Course participants

There will be 23 participants. They have been nominated by the Governments of India (4), Turkey (4), Cameroon (2), Mexico (2), Sri Lanka (1), Malaysia (1), Tanzania (1), Sudan (1), Senegal (1), Nigeria (1), Ghana (1), Benin (1), and St. Kitts (1). Two will be nominated by the Government of Malta.

Since the number of cancidates corresponds to the number of participants we were prepared to accept; since all nominations were made by competent Government Ministries and are evidently of a very high quality; and since nominations came, in some cases, very late and past our deadline, we did not think it necessary to pass through a selection committee. A selection committee will have to be appointed for the second course: for which there will be, very likely, more candidates than we can accept.

Scholarships

Scholarships, of U.S.\$7,200 each, have been contributed by the following: The Commission of the EEC (8); the Government of the Federal Republic of Germany (5); CONACYI of Mexico (2); the Government of the Netherlands (1); the IOI (2; for the Maltese participants). Five scholarships had been pledged by the Commonwealth Secretariat (they had indeed been the first ones to be pledged); but due to a financial crisis, the Secretariat had to withdraw, at the very last moment, its scholarships. The UNDP hopefully will fill the gap.

Teaching staff

The following have agreed to teach: Enrico Argiroffo, myself, Alfredo Boucher, Thomas Busha, Roger Charlier, R.W. Cooke, René Dupuy, Anil Gayan, Ludwig Karbe, Tommy Koh (to be confirmed); Manfred Krutein; Francisco Orrego, Paul White.

Teaching materials

A manual is in preparation. its table of contents is enclosed (Annex 2). Audio-visual materials are being contributed by Preussag AG, by IOC/UNESCO, and by the Open University.

Field trip

Science-and-technology-oriented participants are being invited to a field trip to Hannover to visit Preussag AG. Managerially-oriented participants are being invited to spend their field trip week in Ljubljana, Yugoslavia, at the International Center for Public Enterprises (negotiations still in course).

In conclusion I should like to stress that the cooperation from Governments, the academic community, industry, and the U.N. organizations has been splendid and most heartening. It has confirmed us in the conviction that we are doing something that is needed and useful.

b) Class B: EEZ Wanagaement

Background

During the 17th session of the Planning Council (Geneva, April 7, 1879), there was a consensus that the training programms should be expended to cover other aspects of ocean management. Such encouragement also came from CIDA and Anbassador Beesley, as well as from members of the U.S. Secretarians The Chainnan of the Planning Council accordingly prepared a new project cutline and submitted it to CIDA. This project outline has been accepted, and a pontribution of \$100,000 has been approved and confirmed. The project outline has been seen to you previously.

As shown in the Project outline, this course should be a cooperative effort between the 101 and Dalhousie University, and the course should rotate between these two institutions. The first course should take place in Malta in the autumn of 1980 (presumably October/December); the second course should be held at Dalhousie during the summer of 1981.

Next Step

The next step will be a workshop in New York, during the veck-end of March 15/16 and perhaps the following Monday. This workshop should be attended by a delegation of Dalhousie University, members of our Planning Gouncil, representatives of developing countries and of interested U.N. organizations. There should be about twenty participants. The purpose of the workshop is to dealt a curriculum for the course, just as the Malta Workshop did in December 1978 for the Sea-mining course. The exact place for this workshop is New York will be announced at a later date. New York has been chosen because many of us will be there anyway because of the Law of the Sea Conference:

The workshop will be preceded by a Planning Council meeting on friday evening at 8 p.m. The exact place will be communicated later. The agenda is attacked.

Volume II of the Ocean Yearbook is in galley stage. A table of contents is attached (Annex 3); work on Volume III is proceeding, a tentative table of contents is annexed (Annex 4); your reactions and suggestions would be most welcome.


