

Dear Jean:

FAO has been splendidly cooperating with our Training Programme: so has IOC, IMO, UNEP, UNCTAD, ILO, UNDP. So we feel the time has come to make this cooperation a bit more systematic, less ad hoc, more long-term.

To discuss this possibility, we are organizing a workshop in Dubrovnik on April 29-30, which will be attended by the members of our two Governing Bodies and representatives of all the agencies engaged in marine activities. We want to make sure that our programme fits in with, and usefully complements their own sectorial activities, and we want to benefit as much as possible from their expertise in various sectors, using their staff members as lecturers and discussion leaders. We also would like to see whether each of them could perhaps assume the responsibility for one or two scholarships for each programme (IOC, UNEP, UNESCO, UNDP, and FAO have already giving us many scholarships). If this could be put, so to speak, on an automatic basis for the next three years, it would alleviate the rather backbreaking burden of raising all these funds and allow us to consolidate the programme and improve it.

Since you have been with us from the very beginning and are familiar with our work, it would be splendid if you yourself could come to this workshop. Is it possible? Please let me know as quickly as possible.

Dear Mr. Kojima:

Thank you for your cable, dated June 9, of which I am enclosing a copy.

In reply I cabled that Miss Ching Kim Looi of Malaysia cancelled her participation in the programme at the last moment. However, we now have Mr. Anton Reginald Atapattu of Sri Lanka with us.

Originally, the Government of Sri Lanka informed us that Mr. Atapattu was to receive a FAO scholarship -- which would have helped us greatly as we are running this programme at considerable sacrifice.

As it turned out, no scholarship was available. We accepted Mr. Atapattu in any case: He is as fisheries officer, and highly qualified, with a degree from the University of Sri Lanka and one from the Institute for Fisheries Education in Bombay. We are glad to have him with us.

Now I wonder whether the Malaysian scholarship could possibly be transferred to Mr. Atapattu? Since the funds had already been made available, I would hope that this should be possible. If it were necessary for the Government of Sri Lanka to submit a new application for Mr. Atapattu, I am sure they would be glad to do so upon our request.

We have accepted three Indians for the programme Two of them (including Mr. Das) are Government officials, one is a University Professor.

Originally we were told that the Indian Government would pay for the transatlantic air fare of the

two Government officials, while we would have to pay for the air fare of the University Professor (Ms.Puri) as well as the scholarships for all three. Considering the quality of the applicants and our relations with the Government of India, we were glad to accept this arrangement.

It turned out later that the Government did not pay for the trip of Mr. Das. Is it possible that there was some misunderstanding between FAO and the Government of India regarding this point?

In any case, I am enclosing invoices for the scholarships of Mr. Das and Mr. Atapattu as well as the receipts for their air fares. I leave it to you, how much of this you can pay us. The cooperation of FAO is for us as much of as moral encouragement as it is financial help, in what I really think is a pioneering effort. In general, the response we are getting is indeed heartening, and we are gratified with the development of the programme.

Dear Elisabeth,

Thank you for your invitation to contribute a paper on FAO's EEZ Programme - our Programme of Assistance in the Development and Management of Fisheries in Exclusive Economic Zones - to the <u>Ocean Yearbook</u>. I read with some admiration the contribution of Peter Thacher and Nikki Meith. I was delighted to find due acknowledgement to FAO's work in support of UNEP's Regional Seas Programme.

We might find it a little difficult to make such a lengthy contribution because the EEZ Programme has only recently been launched, but, of course, the Fisheries Department's efforts in this area pre-date the programme, even the current UNCLOS meetings. Certainly, I am sure we have a story worth telling and could provide a contribution that will have value both as a reference source and as a narrative on the emergence of a new order in world fisheries.

Because of pressure of work, I would have to join with another author. 
So I am very anxious to get things into final shape as quickly as possible.

Thanks for your letter of May 14 which took rather long to reach me here.

Thank you for your 'phone call on the 22nd May regarding IOI's next EEZ training programme. I'm sorry I was not on hand to speak to you personally but I was pleased to receive the message that you'll be happy to have John Naylor address your trainees, in my stead, on 31 July. John has worked very closely with Jean Carroz and me during these last few years on policy matters and in particular upon the design, planning and coordination of our EEZ Programme.

I note from your telex to the Director-General on 11 May that you would like the FAO representative to address the subject of the role of the (UN) specialised agencies in assisting developing coastal states (in EEZ fisheries development and management) and in fostering regional collaboration and then to lead discussion on these topics.

I'm sure you will agree that it would not really be appropriate for one such agency (FAO) to go into great detail about the activities of all the other specialised agencies in the UN System. Thus, whilst John will, of course, review in general terms the function and responsibilities of the various organisations in the UN System so far as fisheries is concerned, he will deal most fully with the role of FAO itself in this respect, in particular on policies and practices regarding regional cooperation in fisheries. We assume you will be looking for a lecture of around one hour, followed by a discussion session of about the same period.

We'll send ahead of John's arrival, a package of the new version of our EEZ Programme information kits, plus other relevant documents. Please hold these for distribution after the lecture - there's nothing more irritating to a lecturer than participants rifling through reference material whilst he's actually speaking and seeking their attention!

Incidentally, it would be helpful at this end, if you could kindly send to John Naylor, material describing the detailed programme of your Dalhousie course, together with a list of lectures and lecturers and of the trainees. The course text written by your 1980 Class B Programme participants would also be of interest.

GRI ROME TERNA JUN. 21 1977 Read Million of Kinnesolo 30 Fast 10t Str. 55101 Thank you for your letter of 17 May 1977 in which you describe briefly the plans of your Institute to publish, with the assistance of the University of Chicago Press, an annual Ocean Yearbook. I note that one of the three parts of each of your Yearbooks will present statistical tables, some of which will be concerned with the use of the ocean for food production. With regard to these tables, you mention that you would like to have our assistance in supplying, even before we issue the two annually published FAO Yearbooks of Fishery Statistics, summary tables presenting up-to-date data on catches, commodity production and trade.

My staff have reviewed the situation and have indicated that such summaries are not available until shortly before the publication of the Yearbooks of Fishery Statistics. It appears that within a week or so of receiving the up-to-date computer-printed tabulations, we send these off to the printers and then only a few weeks are necessary for the external printers to deliver copies of the Yearbooks to us. No time would be lost if you await the arrival of an airmailed copy of the Yearbook which we could send you in advance and then you can extract the data from this publication.

I feel that it would be useful to clarify our position by providing you with a brief description of the availability of timely data in the Department, which is given below.

At the beginning of each calendar year we receive, by letter or cable, total catch figures, without any breakdown from some member countries. These preliminary figures enable us to make estimates concerning the world total catch by March for the preceding calendar year. These figures are all subject to revision, however.

During the first quarter of each year we send out questionnaires requesting detailed figures which often also remain provisional but in some cases are final. These requests are sent to about 80 percent of the 240 reporting countries, territories, etc. in the world. We do not receive responses or replies from

many small countries and even some large ones and we have to make estimates for these countries and feed these into the computer. Most of the large fishing However, Japan can countries supply us with data by the middle of the year. only do so by October. Because of Japan's importance we cannot prepare any adequate summaries until we receive their figures. Within a week of receiving the Japanese data the figures are fed into the computer and we can then obtain the print-outs which we use immediately for prompt despatch to the external Our cut-off date is therefore the arrival of the Japanese data and printers. we do not delay the publication to await the arrival of data from any of the smaller countries which have not yet reported by that time. You will therefore notice that there is no time-lag between the availability to us of the final figures and the despatch of the manuscripts to the printers.

In these circumstances I think it will be best, for the quality of your own production, if you await the release of our data and we will make sure that there is no delay in sending you copies of the Yearbook of Fishery Statistics.

I should also like to point out that the above remarks apply to the Catches and Landings Volume of the Yearbook which is generally available in December and which covers the statistical time series up to the preceding calendar year. The Fishery Commodity Volume is published a month or two later and these statistics can be made available in January or February of the following year, i.e. in January 1978 we would be in a position to give you the commodities series up to and including 1976. In November or December 1977 you will have the catch statistics up to and including 1976.

One other solution, of course, would be for you to print the tables that you wish to publish and provide us with tear sheets. We will then be able to add in the last blank column the data available to us and shown in the tables we have submitted to the printers. This is the procedure we follow in the case of other Yearbooks, published by the UN Statistical Office and other UN Agencies.

I note that you suggest that Dr. S. Holt could establish an appropriate format and I will be asking him to discuss this with Mr. L. P. D. Gertenbach, the Editor of our Yearbooks of Fishery Statistics, to establish a tabular lay-out which we could up-date immediately our manuscripts have been sent to the printers.

Thank you for your letter of 13 July. Sidney mailed to Prof. Ginsburg a few days ago his contribution to the "Ocean Yearbook" containing statistical tables up to 1975. This article for the first Yearbook reviews in detail the last five years of development and therefore establishes a baseline for chapters in future issues. There is thus now plenty of time to establish a format along the lines we have agreed.

There is, however, a problem of timing. We shall normally not have ready the statistical data in less than 9 or 10 months after the end of a calendar year. Thus we still await submissions from important fishing countries relating to 1976 catches. Other kinds of data arrive later still. The editors of the Yearbook might find similar difficulties regarding other types of ocean use statistics. I suggest, therefore, that in considering the regular schedule to be established in the future, account should be taken of the real time lags in data collection, so that either the deadline be established at, say, October rather than June as it was for this first volume, or you could set it at the same time, or even earlier as far as we are concerned, about April-May, and include statistics up to the beginning of the previous calendar year.

It would be possible, in this latter case, to include provisional figures for the previous year, as I said in my letter of 21 June. There is a difficulty, however, in that in those figures we cannot, at present, distinguish marine from freshwater catches, and their inclusion could therefore be rather misleading. We may be able to improve this situation during the coming year, and we will keep in touch with you about this.

On the kind invitation of the Algerian authorities, the International Ocean Institute is organizing Pacem in Maribus VII in Algeria from October 25 to 28, 1976, on "The New International Economic Order and the Law of the Sea." The meeting will be held partly concurrently, partly jointly, with a Special Meeting of the Club of Rome on the New International Order. The main background paper for the joint conference will be the RIO (reshaping the international order) Report, drafted under the chairmanship of Professor Jan Tinbergen. The main background paper for Pacem in Maribus will be a study, The New International Economic Order and the Law of the Sea, revised edition, by Arvid Pardo and Elisabeth Mann Borgese.

The reasons for holding Pacem in Maribus VII in conjunction with the Special Meeting of the Club of Rome and the RIO project are twofold. On the one hand, the study on the new international economic order and the law of the sea developed out of the RIO project and is an integral part of it, applying many of the RIO proposals in the specific area of ocean management. On the other hand, the results of the last session of the U.N. Law of the Sea Conference must now be further developed and inserted in the general attempt to build a new international economic order. The Algerian conference on the RIO project offers a first, and exemplary, opportunity to demonstrate this juncture.

The meetings will consist of eight sessions. The first three will be held jointly with the Club of Rome. They will be devoted to the general topic: "Concepts and finalities of the new international order." On the afternoon of October 26th, Pacem in Maribus will go into special sessions. One further joint working session with the Club of Rome will take place on the afternoon of the 27th, when an attempt will be made to consider the problems of ocean management in the broader context. On the morning of October 28th, Pacem in Maribus will divide into working groups, responsible for drafting reports. The afternoon of the 28th will be dedicated to the closing of discussions and a press conference. A detailed agenda and flow chart are enclosed. The meeting will convene in the beautiful Club des Pins, about 20 kilometers from Algiers, which offers an ideal setting for such an event. Participants will be lodged in the nearby hotel which can accommodate all of them. Buses will shuttle participants to and from the meeting place.

Whatever their official positions, all participants will attend the meeting in a personal capacity. The meeting will be informal, both in spirit and organization and with respect to attire. It is aimed at fostering personal acquaintance, constructive exchanges of views, mutual understanding, as well as at indicating some feasible steps along a possible road to a more satisfactory world order, including the oceans.

Round-trip, economy-class air tickets for participants who cannot charge them to another organization and hospitality in Algeria will be provided by the Algerian sponsors of the meeting. You should inform yourself at the nearest Algerian Consulate whether or not you need a visa to come to Algeria. Visas to aprticipants of the Algiers conference will be issued without delay. Should there be no Algerian Consulate in your vicinity, or should you be unable to obtain a visa in advance, please advise me or my assistant, Mrs. Jean Muller. We shall then arrange to have your visa issued at the Algiers airport.
