

2. Summary

2.1 The Canadian Delegation presented a memorandum prepared by Professor M. L. Marasinghe which contained a proposal from the participating Canadian Law Schools. This Report contained the seven levels of exchange agreed upon at the Windsor meeting of September 30th, 1983 and particular aspects of co-operation obtained from personal and telephone interviews with the law Deans of participating Canadian Law Schools.

2.2 Mr. Robert Robertson made an oral presentation to the Chinese delegation in which he stated the I.D.R.C. position. In his view, the I.D.R.C. is unable to act upon the Canadian proposal mentioned in paragraph 2.1 unless a specific request is received from the Chinese side. Mr. Robertson therefore emphasised that the proposed programme cannot evolve any further until the I.D.R.C. has heard from the Chinese side.

2.3 Mr. Wang Fusun, speaking after consultations with his delegation declared that the proposal appears to a very large measure in line with their present needs and that he is confident that a "positive and more detailed response will be going out from [his] department as soon as possible". This should be after he and his delegation had a chance to consult with others in the P.R.C. The Chinese delegation was leaving for Beijing on Thursday 27th October, 1983.

2.4 During the course of the meeting Mr. Wang informed the Canadian side that he intends leaving the Canadian Legal Academic Exchange Programme to evolve either with the P.R.C. Law Schools that are now within the present American agreement, outside it or a combination of the two groups. This kind of flexibility was sought during the meeting in Beijing between May 5th-7th, 1983 by the Canadian Observer (Prof. Marasinghe) and was agreed to by Mr. Wang. The Canadian Law Schools therefore could now work out their own exchange programme unfettered by any aspects of the American agreement subject to the response mentioned in paragraph 2.3.

2.5 In the light of the foregoing it will be necessary to postpone the meeting fixed for Friday, November 18th, 1983 until the response from the P.R.C. is received.




Thank you for your letters of February 27 and July 26, which I received only recently after my colleague who took care of my mail returned from her vocation. I am sorry for the delay in replying them.


Dear Professor Macdonald:


Thank you for your letter of June 6, 1986. I just got news from Professor Wang that you were awarded an Honorary Professorship from Peking University. Please accept my congratulations.






