• WRITERS IN ELECTRONIC
RESIDENCE This exciting new project links high school and elementary students to Canadian writers by computer. Marshall McLuhan Award-winning teacher Trevor Owen established the project at Toronto's Riverdale Collegiate in 1987 in conjunction with Simon Fraser University. In 1990, the project came under the administration of the Trust. With seed funding from the Ontario Arts Council and the continued generous participation of Simon Fraser University, schools and school boards, the W.I.E.R. program will be expanded.

Since 1988, six Canadian writers – Lionel Kearns, David McFadden, Lorna Crozier, Katherine Govier, Guy Gavriel Kay and Crawford Killian – have offered their experience and insights to creative writing students in ten Canadian schools from Baffin Island to Williams Lake, British Columbia. In 1991-92, ten writers and twenty schools will be involved.

How Does it Work?

Working in his/her home study, the writer joins students in their classes – electronically. S/he becomes an on-line tutor in creative writing and English-language classes, perusing student work and feeding suggestions. Teachers bring the on-line experience into the class work, using contemporary texts suggested by writers. Both students and writers become part of an electronic network that reaches across Canada and as far away as Iceland, China, the United States and Europe. Contemporary Canadian writing comes alive, and the classroom becomes a literary communication centre.

- THE MARGARET LAURENCE MEMORIAL LECTURE Instituted in 1987, this lecture is given annually by a respected senior writer to an assembly of professional authors and the general public. It is the kind of lecture Margaret herself would have given. The inaugural address was delivered by Hugh MacLennan, followed by Mavis Gallant in 1988, Dorothy Livesay in 1989 and Roch Carrier in 1990.
- LITERARY LUNCHEONS A series of luncheons is held in Ottawa at which members of business, professional and

community groups meet and talk with authors. This project was begun in 1980 and remains popular.

- RESOURCE GUIDES FOR THE TEACHING OF CANADIAN LITERATURE The publication of a series of literary resource guides was begun by the Trust in 1977. Eleven guides have been published and more than 36,000 volumes distributed to teachers, schools, libraries and departments of education across Canada.
- NATIVE WRITING While there is a growing community of native writers, their importance to our culture is yet to be fully realized. We began by making funds available to The Committee to Re-establish the Trickster, an organization run by and for native writers. Recently we have also given funds to the En'owkin International School of Writing in Penticton, British Columbia. The first Canadian School of Writing for people of native indian ancestry opened in the fall of 1989.

Under the charitable status of the Trust, donations have been collected to establish the following awards and funds:

THE THOMAS RADDALL ATLANTIC FICTION AWARD, an annual award to be presented in conjunction with the Writers' Federation of Nova Scotia, will go to an Atlantic writer for a work of fiction published in the previous year.

THE BRONWEN WALLACE MEMORIAL AWARD will honour a young poetry or short-fiction writer at the start of his or her career.

THE MERLE SHAIN FUND was established in 1989 to commemorate her work.

The Writers' Development Trust has in the past been involved in organizing the Baffin Island Writers' Project and has provided funds for the Wallace Stegner House in Saskatchewan, the Ganaraska Writers' Colony in Ontario and many other projects.

The Trust retains close ties with the Canadian Centre of International P.E.N., the Writers' Union of Canada and the League of Canadian Poets.



The Purpose of the Trust

The Writers' Development Trust was incorporated under federal charter in 1976 as a registered charitable organization for the vital purpose of actively advancing interest in Canadian literature and supporting the development of its writers.

The Trust's constituency is large and eclectic, embracing all those who write, or will write, the literature of this country, those who teach it, and all who have a passion for the literary arts.

Specific objectives of the Trust are as follows:

- To increase recognition of the role writers play in creating, illuminating, exploring and recording the cultural richness and diversity of Canada and its people.
- To use the knowledge and insights of this generation of writers for the benefit of gifted young writers in oncoming generations.
- To recognize excellence in the craft of writing and the pursuit of literature.
- To engage in educational programs for Canadian schools.
- To undertake research and accumulate information of benefit to writers and their public.
- To accept and administer funds obtained through wills, bequests, endowments and donations.

The Need

The long-term objectives of the Trust cannot be attained without permanent organization and funding.

The solid foundation of the Trust enabled a permanent endowment fund to be established in 1986. The GREAT LITERARY DINNER PARTY in 1986 created an endowment of \$120,000. In 1987 and 1988 \$225,000 was raised. At this point the Trust holds more than \$650,000.

The pressing goal is a permanent endowment fund of \$2 million.

The Involvement

Become a member of the Trust and be a part of the ongoing and exciting evolvement of Canada's writers. The annual tax-deductible fees are as follows:

- \$25 for writers
- \$50 for patrons
- \$275 for corporations

The Event

In October 1986, the first GREAT LITERARY DINNER PARTY was held across Canada. It was a unique opportunity to meet distinguished Canadian writers in intimate settings such as private homes, clubs and restaurants. Forty-nine dinners were held and they raised revenues of close to \$200,000. The dinners were so successful that the Trust has made it an annual event across the country.

In 1990, dinners are planned in major Canadian cities – St. John's, Fredericton, Halifax, Montreal, Toronto, Ottawa, Winnipeg, Regina, Calgary, Vancouver and Whitehorse.

This fall The Writers' Development Trust will be staging the biggest literary dinner party yet . . . and you're invited. Have a great Canadian success in your home . . . invite an author to dinner, or volunteer to help us. The dinners will be held during October and November.

The Trust Projects

- THE MARIAN ENGEL AWARD
 The Marian Engel Award is given
 annually for outstanding prose writing by
 a Canadian woman. The Trust has
 established an endowment fund of
 \$125,000 to maintain this major award,
 which was given to Alice Munro in 1986,
 Audrey Thomas in 1987, Edna Alford in
 1988 and Merna Summers in 1989.
- THE SUPPORT OF INDIGENT WRITERS Canadian writers generally live meagerly from book to book. When they attain old age and their productivity slows, their financial status becomes even more precarious.

The Canadian Writers' Foundation tries to help indigent writers of known merit as much as possible. It does not, however, have the fund-raising capability that would allow it to give a level of support commensurate with the level of need. The Trust gives the Canadian Writers' Foundation a generous sum annually.

 WOODCOCK FUND George and Inge Woodcock have made a generous donation to the Trust to establish an emergency fund for published writers in time of need. The fund is given out annually based on eligibility requirements.


