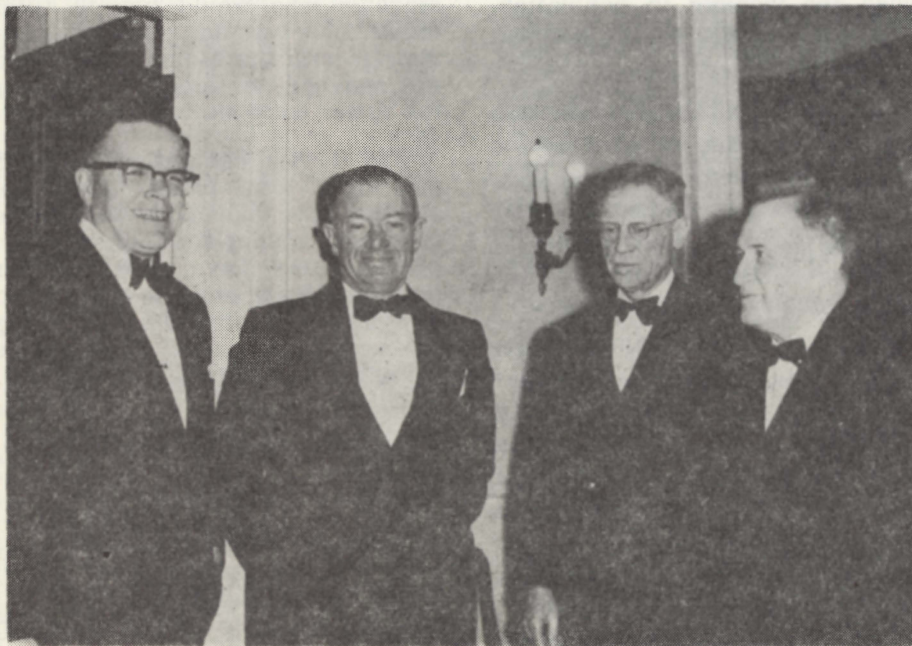

THE PENALTY OF INCREASED ENROLLMENT

It has often been said that "brains" are Nova Scotia's major export, and the system of federal grants to the provinces bears out the fact that there are more university students per capita in this Maritime Province than in any other province in Canada. It is indeed unfortunate, however, that the universities of Nova Scotia are being penalized because of this admirable trait of the hardy easterner to seek a higher education.

The Federal Grants to Universities are allocated to provinces on the basis of \$1.50 per head of population. This grant is then divided among the universities on the basis of the number of students registered. Thus an increase in students without a corresponding increase in population can only mean a reduction in the amount of the grant received by the

universities. Because in 1959 the increase in student enrollment exceeded the increase in population, the grants were \$12 per student less than in 1958.

This means that the Nova Scotian universities, already effected by the economic problems of the area, received \$203 per student in 1959-60, while our sister universities in prosperous Ontario received \$342 per student in the same period.

At a meeting of the Nova Scotia Education Association, held earlier this year, a unanimous resolution was passed calling for a change in the federal system of grants. It is hoped that this penalty on the Nova Scotian's desire to obtain a higher education will soon be eliminated. Our cry is not for special treatment, only for an equal share in aid for our universities.

From Library Files of The Dalhousie Gazette

1910

It was reported that the Treasurer of the Alumni Association, Mr. S. A. Morton, was working to endow a proposed chair of Biology. The Alumni President was Arthur S. Barnstead.

John Read was chosen as Rhodes Scholar 1910.

The Nova Scotia Technical College awarded grants of \$75 to A. G. McAulay, C. L. Dimock, F. R. Archibald, R. W. McCoolough, T. W. Hardy, F. M. Dawson, Walter Putnam, Neil McKay, the late T. M. DeBlois, and the late J. A. McKay.

1915

Two Dalhousians volunteered for service in the Army Service Medical Corps and were to leave immediately for Salisbury Plains. The two were the late Cyril Hyde and R. A. Patterson.

1920

On the best-seller list was "How To Make A Noise" by George Hardy—a remarkable treatise on the subject.

The Sophomore girls held their annual "feed" where great distress was reported over the lateness of the ice cream in arriving.

1925

Homer Norton was chosen as Rhodes Scholar.

Fabian Bates, Dal's star centre, leads the scorers in the City League Hockey Series with a total of nine goals. Monte Haslam came third with seven goals.

G. MacGregor Grant, Fred W. Bissett and Avery F. Newcomb represented Dalhousie when they debated the topic, "Resolved that there should be an embargo on the export of manufactured pulpwood from Canada." The Dalhousians took the negative.

1930

An advertisement announced that all dresses at D'Eauville's were selling for \$12.00.

Turret cigarettes cost 25c for 20 and each package contained a valuable poker hand.

The Gazette announced that James Jordan Fay married Miss Kathleen Hagen. In doing so, Mr. Fay now gave every law class a married man among its members.

Student Council Executive consisted of Edwin Ross and the late John Denoon as Medical representatives; Raeburn MacCunn as Law; Erwin Taylor, Dentistry; Robert Brown, Class of '33; the late James Muir and Catherine Hebb, '32; Thomas Goudge, '31; the late Potter Oyler, Commerce; Manning Archibald, Engineering; and Don Grant, Freshman representative.

1935

Charles Manning, 2nd year law student, was elected President of Sodales.

The Casino Theatre presented Greta Garbo in "The Painted Veil."

Dal defeated YMCA in the City Basketball League opener. Sammy Fairstein hooped 16 points. Final score 50-38.

At a "What Is Wrong With Dal?" forum, John Fisher spoke for some time on fraternities, the electoral system and college spirit.

1940

In reply to "should boys send corsages?", Fred Faulkner said, "Did you say corsets? Yeah! Good idea!"

Column note: We wonder who he had in mind?

The Who's Who Column spotlighted Walter Butch Lawson. Three-quarters of a column was devoted to his numerous activities.

In the column "Fraternities on the Campus," Phi Delta Theta was reviewed. It was noted that member S. W. "Barney" Archibald wrote the words to "Dalhousie Dream Girl" while the music was composed by pledge Don Murray.

James Doull was receiving plaudits as Dal's new Rhodes Scholar.

1945

Liz Reeves and Pat Ryan represented Dal Girl's interests at an intercollegiate debate at Acadia. Judges were Bob McCleave and Abe Sheffman, who selected the girls from among other Dal competitors to represent the University.

Rosalyn Schaefer was photographed in a bathing suit. She was 18, blonde, 5' 5", 129 pounds.

1950

Law Notes by Alf Harris reported that the Law Basketball Team had a good turnout at the opening practice, coached by Andy McKay and Mason MacDonald.

Douglas Brown and Elise Lane were elected President and Vice-President of Student Council.

Charlie Connelly in a fetching pose with glasses on nose, appeared on the sports page. He was a third year student and a mainstay of Varsity Basketball.

Christina MacKeen was chosen Sweater Queen at the Commerce Ball.

1955

Ellen Pipe participated in the Maritime Junior Badminton Tournament, winning the ladies singles title, and was also on the winning ladies doubles and mixed doubles teams.

Barbara Clancey was chosen Pharmacy representative in the Queen Contest.

The Diary of Sam Peeps reported, "Up to the college by the sea and in to Inforrests to purchase some vile purgative—a vile, thick, brew which they serve under the name of coffee. I did not dare take it internally."

DR. KERR'S NEW BOOK

Dr. A. E. Kerr, President of Dalhousie University, is the author of a new book entitled "The Ten Words," published this spring by the Ryerson Press. The title of the book comes from a translation of the Hebrew words for "The Ten Commandments."

The book is a revised and expanded form of a lecture given by Dr. Kerr to a class in Jurisprudence during the 1958-1959 session. In it, he examines the Ten Commandments as an expression of the divine will, as a foundation of the moral law of society, and as a basis of the fundamental principles of the positive law of the nation.

Although the original text was prepared especially for students of the law, the revised edition is of interest to everyone. The Hon. John E. Read, Judge of the International Court of Justice, and former Dean of the Faculty of Law at Dalhousie, contributes the forward.
