Dear Minister, dear friend Nejeeb,

The news from Lisbon is good. The meeting we had on June 30 was quite constructive, and everything is on course. We have elected you to be a Member of the Commission and are looking forward with great enthusiasm to working with you on the important subjects of the Commission.

Please take note that the first Plenary Session of the Commission is scheduled for September 6 through 8. The venue will be the United Nations University in Tokyo. You will receive, in due time, an official invitation from President Soares of Portugal, Chairman of our Commission.

It would be extremely useful if, by the time of the Tokyo meeting, you could get together a concrete plan for the Hearings in the Gulf Region. I know Dr. Meshal of the UNESCO Office in Doha would be most happy to assist you. Perhaps you could also enlist the cooperation of the Gulf Cooperation Council. The Hearings should be completed by the end of the year, if they are to make a useful contribution to the work of the Commission.

Another question: are we making headway with the IOI Operational Centre at the University? I would be most grateful if you could keep me posted.

Subject: World Commission for the Oceans

I have the pleasure to acknowledge receipt of your fax dated 9 July 1995.

First of all I want to express my sincere gratitude to you for the kind assistance you have extended in getting me elected as Member of the Commission and as wished I will do my level best to work with you on the important subjects of the Commission.

I have noted that the first Plenary Session of the Commission is scheduled to be held in Tokyo during the period 6-8 September 1995.

Recently there has been certain changes at the ministerial level in the Government of Qatar and perhaps you might have read that I have been appointed as Minister of Justice of the State of Qatar effective from 11 July 1995. Although I was an active member in the decision making and formulation of rules for the Government in my previous capacity as Minister Legal Adviser, the present assignment has put me in pressure to concentrate at an increasing level on the activities of the Ministry of Justice in addition to the responsibilities and obligations which I administered under my previous position. Thus I feel that I will not be able to stay away from Doha initially for a period of at least two to three months and so I do not think that I will be able to participate at the proposed Plenary Session of the Commission from 6-8 September 1995. However I can send you a written statement if you so wish and I will certainly be pleased to attend the subsequent sessions organized by the Commission at a later date. I regret if this has caused to you any inconveniences.

Please accept the assurances of my highest consideration.
