Manuscripts should be submitted to the Editor, Natural Resources Forum, Centre for Natural Resources, Energy and Transport, United Nations, N.Y. 10017. All manuscript material should be typed, double-spaced on 8-1/2" x 11" paper with wide margins. An original and two copies are required. A brief Abstract (150 words or less) and a Biographical Note (100 words or less) on the author or authors must accompany each full length manuscript.

Tables should be numbered consecutively, in Roman numerals, in order of their intended appearance in the text. Each should be typed on a separate sheet. Appropriate headings and source citations, if any, should be included.

Figures and illustrations should be sumbitted in a form that permits reproduction without retouching. Line drawings should be done in India ink, with lettering large enough to be legible after reduction. All figures should be numbered and include a caption. Photographs should be glossy prints; orientation (top, North, etc.) should be noted on the reverse side.

Units, all scientific or technical data included in the text, should be in the M.K.S. system. Scientific notation is preferred for large or small numbers.

Footnotes to appear at the bottom of a page should be used only when absolutely essential. Whenever possible, the information should be incorporated into the text.

References must be numbered in the text and listed at the end of the paper. All quotes and other material taken from another source should be referenced. References should include full name of author(s) or editor(s). For books, the title, place of publication, name of publisher and publication date, in that order, are required with the page number(s) included where appropriate. For periodicals, article title, journal name, volume number, issue number and date are required, with page number(s) where appropriate.

Page charges and reprints. There are no page charges for Natural Resources Forum. Contributors to the journal will receive 25 free reprints of their article. Additional reprints are available from the publisher at a nominal charge.
