Miss Emelyn L. MacKenzie, Q. C. Our Honorary President

The following is Dr. Scammell's nomination of Miss MacKenzie to the office of Honorary President.

Mr. President and Fellow Dalhousians:

For many years the Dalhousie University Club of New York, the New York Branch of this Association, has been the brightest jewel in its Crown. It is fair to say that there have been times when the child outshone the parent in interest and activity. One of the founders of this Club and one of its most interested and en-thusiastic supporters during its years of existence is Miss Emelyn Laura Mackenzie, now retired and living in Chester, Nova

Miss Mackenzie entered Dalhousie from Pictou Academy. In 1914 she won a B.A. with Distinction, and the year following a Master of Arts Degree. In 1919 she was graduated from our Law School. Her career in Corporation Law in New York City has been successful and distinguished.

Dalhousie owes a great deal to Clan Mackenzie. In 1877, J. J. Mackenzie came by way of Pictou Academy, Dalhousie and Leipsig to become our first professor of Physics. This was the first regular Department of Physics in a Canadian University. Two years later he died. There is no doubt that his brilliant career and his tragic death impressed a boy of 14, then a student at Pictou Academy. was Alexander Stanley Mackenzie, who

Reports of continued growth, results of the annual election and periods of spirited discussion were highlights of the Annual Meeting of the Dalhousie Alumni Association held at Shirreff Hall on May

Association held at Shirreff Hall on May 16th. A capacity crowd of 225 alumni and members of the graduating class attended the buffet supper which preceded the business meeting.

Alumni President Arthur Meagher called the meeting to order at 7.30, congratulated the Class of '60 and welcomed them to membership in the Association. Stuart G. MacKinnon, Life President of the Class of '60, introduced the Life Officers and thanked the Alumni for their hospitality.

Following the adoption of the Minutes of the 1959 Meeting, Mrs. H. Terry Creighton, retiring First Vice-President, thanked Miss Reynolds for the excellent buffet, and Mrs. Gordon Blair for her excellent co-operation during her term of effice as Associate Transpurer. In classing office as Associate Treasurer. In closing, Mrs. Creighton paid tribute to Mrs. Kerr for the "graciousness with which she fills the office of Chatelaine of the Presidential residence.

President Meagher thanked Mrs. Creighton for her report and for her unstinting efforts in forwarding all endeavors of the Alumni Association. He then called on Bruce Irwin to present the report of the Director of Alumni Affairs.

Mr. Irwin reported on the changes in The Alumni News, the formation of four new branches of the association, the sponsoring of school tours of Dalhousie, the establishment of a tutoring service to assist Dalhousie students in supplement. assist Dalhousie students in supplementing their incomes, and the production of a long-playing record of Dalhousie songs which will be available in the monthis ahead. In closing, Mr. Irwin thanked the executive for their willing co-operation and untiring efforts.

Treasurer John Moore explained the Financial Statement which had been distributed in printed form. A condensed copy of this Statement appears on page 3 of this issue of The News.

Associate Treasurer, Mrs. Blair, explained the Financial Statement of The Women's Division which had also been distributed in printed form, and which is

Dr. William A. Murray, President of the Dalhousie Medical Alumni Associ-

ation, reported their Annual Meeting would be held in November 7th, 1960. would be held in November 7th, 1960. Medical membership for the past year totals 225 ordinary and 70 Life Members, and the association is working on the development of a Medical Museum and Archives, and the establishment of a scholarship fund.

Dr. A. B. Campbell reported that the Football Fund had been most successful and thanked all those who had so gener-

and thanked all those who had so gener-ously supported it. He recommended that these funds should be separated from the general funds, since they were administered by a special committee and not by the Executive as a whole.

In his report, Alumni President Arthur Meagher, stated that the most important

change in the past year was the appointment of a full-time Director of Alumni Affairs, and he thanked Dr. Kerr and the Board of Governors for making the appointment. Mr. Meagher reported that pointment. Mr. Meagher reported that our combined membership now stands at a new high of 2142, an increase of 41 over last year, and explained that this was in a large measure "due to the excellent work of our Membership Secretary, Mr. Carmen Moir, and to Mrs. Giffin of the Alumni Office and Miss Blauvelt of the Medical School."

President Meagher reported that the Alumni Fund has grown from \$55,391 to \$69,525 during the past year. In that period 649 members had contributed to the fund, 314 of them for the first time. He asked the association to "put on a special drive to complete its objective of \$100,000 as soon as possible."

Mr. Meagher expressed his appreciation to those members of the Executive who are retiring this year for their efforts on behalf of the association. He also thanked Mr. George Herman for editing the two excellent issues of The Alumni News in 1959. In closing, the President thanked all the members of the Executive for their co-operation during a very interesting

Sam S. Jacobson was elected by the general meeting to fill the unexpired term of A. Gordon Archibald who has been made a full member and Vice-Chairman of the Board, by Order-in-Council.

Dalhousie President, Dr. A. E. Kerr, congratulated the Alumni for their achievements in furthering the affairs of Dalhousie. He stressed the need for increased scholar-ships and residence facilities for women sing sand residence facilities for women if Dalhousie is to continue to attract top students. Dr. Kerr drew attention to the \$100,000 Alumni Fund and urged the Association to strive for a greater percentage of graduate participation in support of Dalhousie.

Under the heading of "New Business," Aaron Zive reported that the Alumni House Committee has been investigating, in co-operation with the Faculty Association, the feasibility of establishing a combined Alumni-Faculty Club House, and asked that the meeting indicate their opinion. A period of lively discussion en-

sued during which several opinions and queries were put forth. Finally, on a motion of Dr. Murray Fraser, seconded by Dean Horace Read, the meeting went on record as approving of the idea, and re-commended that the Committee continue its investigation and report back to the Executive at the earliest possible moment. The Executive was given the power to take appropriate action following the Committee's report.

Further discussion developed regarding a letter from the Executive Committee of the Board of Governors stating that consideration was being given to a proposal that "The Act Relating to Dalhousie College," which excludes full-time teachers from membership on the Board of Governors, be amended to exclude parttime teachers as well. Because the information available was limited it was felt that the meeting was handicapped in their judgment and the debate was brought to a close with a motion that discussion of this subject cease.

The meeting ended on a motion of adjournment at 10.00 p.m.

soon afterward entered Dalhousie, graduated, took his Doctorate at Johns Hopkins in Physics and later returned to Dalhousie as Professor of Physics. In 1911 he became our fourth President and the fourth one to come from Pictou Academy. During his tenure of office another Pictou Academy graduate, Dr. Kenneth A. Mackenzie became Professor of Medicine, and remained the beloved physician to hundreds of Dalhousie students long after President Mackenzie had been laid to rest with his fathers. As though to fill a vacant space, "Stan's" nephew, Charlie Mackenzie was appointed to the Board of Governors, served as its Honorary Secretary for many years until business affairs made residence out of the city necessary and visits infrequent. Then we have our own Dr. Luther Mackenzie, distinguished retired internest of New York City who as you all know, has devoted so much time and effort to enlarging our pictorial archives.

So, in Miss Emelyn Mackenzie you have a worthy representative of a worthy clan, a Clan which has been a power for good at Dalhousie for more than four generations; a Clan which has sought her welfare and never her distress. She has used her well earned degrees to bring distinction alike to herself and to the university that granted them. She has been unremitting in her efforts to promote anything which she conceived to be of benefit to her Alma Mater. For all these reasons, and for her character, individual dignity and intrinsic worth, I move the nomination of Miss Emelyn Laura Mackenzie to the position of Honorary President, the highest honour in our power to bestow.



A MATTER OF PRONUNCIATION

Those who attend meetings of our Association are often puzzled at the uncertainty of speakers with the pronunciation of certain words which are commonplace in our everyday activities. One day in the summer of 1946, soon after I had assumed responsibility for the operation of the Alumni Office, I had a visit from Jotham W. Logan, bearer of the banner of Classical Education in Halifax for many years. I pass on to you his remarks on this relative subject of pronunciation, as nearly as I can recall, verbatim:

"An alumnus is a male, and it is pronounced. al-um-nus.

An alumna is a female, and it is pronounced. al-um-na.

These are Latin words and the singular form is pronounced the same in English as in Latin.

In the plural it is different. The Latin plural of alumnus is pronounced. . . . al-um-nee, but in English conversation you should say. . . . al-um-nigh. The Latin plural of alumna is al-um-nigh, but in English you say. . . . al-um-nay.

Since our Association is composed of both men and women the masculine plural is used as a composite word and we speak of the Al-um-nigh Association.

Now don't you ever forget that!"

I promised to remember and in order to keep the faith I pass it on to you. Our Dalhousie Al-um-nigh Association is made up of Al-um-nay and Al-um-nigh, and please do not refer to it as the A-loom-nigh Association.

A good many years ago some pundits began to refer to our University as Dalhoosie. On being asked to determine the issue the then Earl of Dalhousie said:

"The uneducated speaking in the vernacular may pronounce it Dal-hoosie, but we say Dal-howsie."

So boys and girls you may clean your slates and put them away until Monday.
