

Dear Layashi,

the documents arrived Friday evening. Here are my comments:

Draft Annotated Agenda

I have a few problems with that and don't think it provides the best structure for our discussion. It leans too much in the direction of details ("incentives," "discount rates" rather than fundamentals on which new thinking is needed.

However, that is not really important. The agenda can be handled freely in such a manner that the discussion flows anyway.

Ruud Lubbers

It is of course a very nice paper. There is an error on the first page, with regard to the entry into force of the Law of the Sea Convention, but that is not important, and I am sure Jean-Pierre caught that already. By coincidence, there is a similar error in Paul Streeten's paper.

It is good that he starts with the concept of the common heritage and points out that the results of the enlightenment, technology out of science, economics out of individualisation -- would lead to disaster. That will head the discussion in the right direction.

As far as the recommendations is concerned, the first one is a little bit too limiting. Certainly "capacity building" is a very important component of the implementation of the concept of common heritage of mankind; but that concept is far wider, and it cannot be "translated" just into capacity building, even though Ruud does give a very wide meaning to "capacity building," including institution building.

The suggestion that the concession of fishing rights by developing nations should, as a counterpart, always include "capacity building" -- including technology transfer, is a good one. It is already embodied in the Law of the Sea Convention.

B and C deal with the importance of regional organisation. A lot needs to be said there -- but I don't know whether it should come under "Economics" or somewhere else in our Report. Certainly something could be said about the relations between regional seas and regional trading blocs.

D raises a very tricky issue: the surveillance of the so-called "carbon sinks" in the EEZs of developing countries. Just a new way of invading their sovereign rights?

E is of course correct

F is fine in principle, but one should not forget that, at this stage I think about 90 percent of NGOs are in developed countries, I think 60 percent in the USA alone! So: to whom are we giving these new rights to intervene?

G of course is fine, but very generic.

I do think our recommendations on economics have to be stronger, and really moving into the next century. The direction given in Para.7 (Conclusion) is very good.

One problem that I have with both Ruud's and Streeten's paper is that there is little connection between these papers and the Agenda. Probably there could not have been, because I imagine they did not have the agenda when they prepared their papers!

Paul Streeten's paper

It is a very good paper, perhaps a little bit too theoretical, without sufficient links to ongoing developments -- the agreement on straddling fish stocks and highly migratory fish stocks; changes within the regional seas programmes.

Of course I completely agree with the desirability of international taxes -- most likely on a regional basis.

I am attaching a few pages of what I think might be major discussion points. Some of them, of course, are already included in the annotated agenda, but I have tried to be a little bit more comprehensive.


