


# ACROSS THE OCEANS The IOI Newsletter

### THE IOI TRAINING PROGRAMME

Over the past two years, the International Ocean Institute has developed a Training Programme on the Management and Conservation of Marine Resources for participants from Third World countries. The purpose of the Programme is to deepen the understanding of the ever increasing importance of the oceans and their resources in world politics and world economics; to assist developing countries in the formation of a core of decision-makers fully aware of the complexissues of ocean management; and to maximize benefits to be derived from the proper integration of ocean management into national and international development strategy.

During the first two years, the Programme was divided into two parts. Class A was devoted to ocean mining; Class B to Economic Zone management. Both courses were conceived in a broadly interdisciplinary way and covered all aspects -- from technology and economics to administration, management, national and international law and institutional infrastructure. Each course lasted 10-12 weeks.





Highlights of Class A included a Simulation Exercise, designed by Canadian and German experts, on negotiating a joint venture with the Seabed Authority. Participants assumed the roles of representatives of the Authority, of a consortium, and of a group of developing countries with different interests. Of special interest also was the Participants' involvement in the actual processing of manganese nodules and analysis of their metal content. During the field trip arranged by the German mining company Preussag AG, Participants had the rare experience of descending more than more kilometer below the surface of the earth into one of the world's largest salt and potash mines where the temperature of the walls approached 65 degrees Centigrade.

# IOI ACTIVITIES IN 1982

As in 1980 and 1981, Class A on Ocean Mining and Class B on EEZ Management will once again take place.

Starting in 1982, however, a third course, Class C, will be added to the Programme. While Classes A and B are organised on a global basis, Class C will focus on the needs and concerns of one particular region. And the participants will all be drawn from that region.

As in 1981, Class A will be held in Malta and Germany. The first part of this course on Seabed Mining will be devoted to the economic, managerial and legal aspects of ocean mining. This will start in Malta on 12 April. The second part of the course will take place in the Federal Republic of Germany, and will once again be organised in cooperation with the Aachen Technical University, which contributes to this course its unique technical infrastructure and expertise. Also included, while in Germany, is the field trip to the mining company, Preussag AG, in Hannover.

The Programme is completely updated each year, and current developments in the Law of the Sea, the changing scene of world economics, and new scientific discoveries that may affect the development of ocean mining, are fully taken into account.

Class B is being organised, as last year, in cooperation with Dalhousie University in Nova Scotia, Canada. The aim of this course, which will take place in the summer months, is to increase awareness of the fact that ocean management adds a new dimension to development strategy; that is requires broadly interdisciplinary skills, new institutional and legal infrastructures, and new forms of local, national and international, intergovernmental and nongovernmental, organisation and cooperation. The IOI is currently working on arrangements with local institutions for the addition of an optional technical work programme to the course. If arrangements can be completed for this year, three optional classes would be offered in marine geology,

oil drilling technology, and fisheries/aquaculture technology respectively. The courses would be given Thursdays and Fridays, 6 hours a day (for a total of 120 hours), while the interdisciplinary foundation course would be concentrated on the first three days of each week.

The Class B course is conducted from a systems-analytical point of view, emphasizing linkages and conflicts between ocean uses, both in the short-range and the long-range perspective. It tries to encourage the emergence of new concepts and approaches in the participants' minds and to strengthen their ability to negotiate in international fora and bilateral negotiations affecting the uses of the oceans.

Class C will take place in Goa, India between October and December. This course will deal with all aspects of ocean management in South and Southeast Asia. Particular attention will be given to such specific topics as pond culture, cage culture, pearl farms, seaweed beds, mangrove swamps, and coral reefs.

There will be field trips to Kerala, Sri Lanka, and the Maldives in order to get first-hand impressions of aquaculture practices and of local and regional research institutions and extension services. A research ship will be at the disposal of the participants for a few days.

#### EDITORIAL NOTE

More than a year has passed since the last issue of <u>IOI</u> <u>News</u>. So much has happened in the meantime that this issue is necessarily longer than usual. The IOI has seen changes in structure and staff, new research projects and training programmes and a more active presence in Malta. In the latter respect, the first Training Programme on the Management of the Mediterranean was convened at the University of Malta last autumn.

As the IOI nears its 20th anniversary in 1992, much energy is going into the endowment fund campaign which will see the IOI's core funding put on a more secure footing. The target is US\$10 million. By that year the Institute hopes to have permanent premises for its headquarters in Malta. Spearheaded by Pierpont & Associates in New York, the campaign will cover North America. Western Europe and Japan.

1989 has also seen the new IMO International Maritime Law Institute (IMLI) successfully commence its first masters course at the University of Malta for students from developing countries. With Prof. Patricia Birnie as Director, IMLI will be filling an important gap in international training activities in the field of maritime law for participants from developing countries. The IOI warmly welcomes its sister institution and wishes it every success in its endeavours.

1990 is already a very active year. Training programmes in marine resources management will be convened in Canada, Malta, Finland, the Caribbean and Indian Ocean, Pacem in Maribus XVIII in Rotterdam, research projects on global and regional issues, publication of conference proceedings, the <u>Ocean Yearbook</u> and newsletters. In particular a new newsletter entitled <u>Current</u> <u>Holdings</u> will be commenced.

#### CONFERENCES

#### PIM XVII - Moscow 1989

Maribus XVII Pacem in was convened at the Sovincentre in Moscow between 26-30 June 1989. The theme was "Peace in the Oceans: The New Era" and initiatives for security. legal order and environmental protection were addressed. Cosponsors with the IOI were the Soviet Peace Fund, the Soviet Maritime Law Association and the United Nations Environment Programme.

The Convocation was attended by some five hundred people from over 50 countries.

#### Sustainable Development

IOI (Canada) co-sponsored with the Lester Pearson Institute for International Development and the School for Resource and Environmental Studies a conference on "Sustainable Development: Critical appraisal and future chalenges." at Dalhousie University. Halifax. Canada between 12-14 February 1990. The Canadian International Development Agency (CIDA) funded the conference with supplementary support from the organising institutions.

Participants came from the USSR, UK, Canada, US, Italy, Norway, Brazil, India and Mexico.

The purpose of the conference was to review current knowledge about sustainable development and its application as well as to discuss issues and themes that will affect both our views of sustainable development and our social behaviour.

#### PIM XVIII - Rotterdam 1990

The arrangements for Pacem in Maribus XVIII. scheduled for Rotterdam between 27-31 August 1990 are progressing. To be convened at De Doelen. Rotterdam. the theme of this convocation is "Ports as 'Nodal Points' in a Global Transport System." As in PIM XVI in Halifax. Canada. a trade show will be organised concurrently with the conference.

Opening addresses will be given, <u>inter alia</u>, by Mrs. J. R. H. Maij-Weggen, Netherlands Minister of Transport and Public Works, and Mr J. P. Pronk, Netherlands Minister for Development Cooperation. The Panels of the convocation carry the following themes:

Panel 1: Changes in the World Economy 2: Developments Panel in Technology Panel 3: Interaction with the Environment Panel 4: Points' Ports as 'Nodal Panel 5: A Global Transport System Panel 6: Developing Countries; Cases of Ports Panel 7: Developing Countries; Role and Needs Panel 8: The Port of Rotterdam Panel 9: Summary and Conclusions.

The convocation will also cover a number of ports around the world as case studies. The new container port of Marsaxlokk run by Malta Freeport Corporation in the south of Malta has been chosen as one of these and a presentation will be made by a representative of that Corporation.

#### TRAINING PROGRAMME

#### <u>Class B - Halifax, (Canada)</u> 1989

As usual, this Class was convened at Dalhousie University, Halifax, Canada between 12 June-18 August, 1989 with Dr S. P. Jagota as course director and Ms Anita Coady as Assistant Director. Twenty four participants Solomon from Islands, Ethiopia, Cook Islands. Barbados, Sri Lanka, India, China, Sierre Nigeria, Pakistan. Leone. Ghana, Philippines, Tanzania, Malta, Socialist Republic of Vietnam, Western Samoa, Indonesia and Yuqoslavia attended this course.

The sponsors of this 1989 Summer Training Programme were the International Centre for Ocean Development (ICOD). Commomwealth Secretariat (COMSEC), Food and Agriculture Organization (FAO), United Nations Environment Program Norwegian (UNEP), Agency for International Development (NORAD), the Marine Affairs Frogramme at Dalhousie University and the Canadian International Development Agency.

Dr Anna Mallia, from the Attorney General's Office. Ministry of Justice, was the Maltese participant for this course who was sponsored by the Commonwealth Secretariat (COMSEC).

#### <u>Class C - Indian Ocean (Eqypt)</u> 1989

This Class C course, which is the third in a series of five on Indian Ocean Marine Affairs Cooperation, has been designed for decision-makers concerned with ocean management in the Indian Ocean region. This course was jointly convened by IOMAC and IOI between 15 1989 in October-21 December, Cairo, Egypt. Nineteen Pakistan, participants from Malawi, Seychelles, Sri Lanka, Tanzania, Egypt. Kenya, Malaysia. Mauritius and Indonesia attended this course. Dr Krishan Saigal was course director whereas Ms C. F. Vanderbilt was the Associate Director.

The sponsors for this course were UNDP, UNCTAD and ICOD. Assistance was also provided by the Egyptian Academy for Scientific Research and Technology.

#### <u>Class C - Mediterranean (Malta)</u> <u>1989</u>

This training programme was the first in a series of Mediterranean courses. Convened between 2 October-7 December 1989, the course was directed by Dr Aldo Chircop, assisted by Mr Paul Mifsud. Twelve participants from Malta, Italy, Jordan. Turkey, Egypt. Yugoslavia and Syria spent ten weeks at the University of Malta discussing the management problems of the Mediterranean region.

UNEP/MAP. UNESCO/IOC and ENEA (Italy) provided scholarships for this programme. Support by of lecturers came from way IOC. FAO/GFCM. UNEP/MAP. UNCTAD, WTO, ALECSO and the IMO/UNEP Regional Marine Pollution Response Centre (formerly ROCC, Manoel Island). Cooperating with the IOI in the coordination local and organisation of the course were the University of Malta, the Foundation for International Studies and the Malta Council for Science and Technology.

Several Maltese University lectured in the Faculty programme: Prof. Victor Axiak, Prof. Patrick Schembri, Mr John Schembri, Prof. David Attard, Prof. Carmelo Agius, Prof. Anthony Bonanno, Prof. Salvino Busuttil, Prof. Rev. Peter Inglott, Dr Dominic Serracino Fenech, Prof. Edward Scicluna. The Maltese participants in the course were Mr Simon Mifsud, Mr Mark Jaccarini and Mr Peter Spiteri. Mr William Scicluna gave an on-board lecture to the participants.

#### Distance education

As a logical development of its training programmes, the IOI has developed an interest in distance education in marine affairs. In a Commonwealth of Learning Symposium on the Application of Distance Education to Marine Resources Development, the IOI submitted a project proposal for a distance learning project in marine resources management with the Centre for Distance Learning at the University of Malta, Convened at the University of Malta in April 1989, the meeting adopted the proposal project and recommended its adoption by the of Governors of Board the Commonwealth of Learning in Vancouver.

The proposal consists of 12 distance learning units that examine different aspects of ocean use, development and management, through a specially prepared film or video and reading materials for each The course is aimed at unit. civil servants, educators and teachers of marine affairs, and students. The project proposal now awaits funding.

#### MARINE SCIENCES NETWORK

A major responsibility being undertaken by the IOI through its Director, Dr Aldo Chircop, is the coordination of the Marine Sciences of the Malta Council for Science and Technology. As coordinator of the Network, Dr Chircop works closely with Maltese scientists and Government officials on a broad range of subjects in marine affairs in Malta. For more information on the network and its activities, refer to <u>Marine Affairs</u>, the Network's quarterly newsletter.

#### IOI ACTIVITIES IN THE INDIAN OCEAN

IOI work in the Indian Ocean continues to be a priority area within its scope of activities. These endeavours, which are undertaken in cooperation with the Indian Ocean Marine Affairs Cooperation (IOMAC) Secretariat, range from training programmes, to information/data exchange networks, to publications.

Ms. C.F. Vanderbilt represented the IOI at the 4th Standing Committee of IOMAC in July 1989 where she presented a paper on the Status of Training in Marine Affairs in the Indian Ocean. She also formed part of the Working Group on Information which concentrated on devising an information and data exchange system for the IOMAC region. The establishment of a network for the exchange of information. which would be called IO-MAARIS, was part of the initial Plan of Action set out in IOMAC-I in 1987. The short-term goals had been met and it was decided that the time had come for further development. Accordingly. an IOMAC Information Workshop was convened in Indonesia in February 1990, where Ms February 1990, where Ms Vanderbilt again represented the IOI. This meeting focused on identifying the information needs of the participating States, established priorities in relation to these needs, and developed a strategy for implementing information implementing information products to meet these requirements.

Other developments were the announcement of the Second IOMAC Conference, IOMAC-2, which will take place in Arusha, Tanzania from 3-7 September 1990. The Statute of the IOMAC has been drafted and will be in place for adoption by that meeting. This will give IOMAC the status of an intergovernmental organisation which will enhance its ability to enact its programmes and raise funds.

The latest issue of <u>IO News</u>, a bulletin of information on Indian Ocean marine affairs cooperation, is now in preparation and is expected to be published in the coming months. Copies are available free of charge from the IOMAC Secretariat, BMICH. Bauddhaloka Mawatha, Colombo 7, Sri Lanka.

#### RESEARCH

#### <u>Mediterranean</u><u>Industrial</u> <u>Technology Centre</u>

The proposal of Malta to establish a Mediterranean Centre for Research Development in Industrial Technology and Marine Development Industrial Technology advanced to gain support. has much international support. The proposal was first put forward by Malta during the Fifth Ordinary Meeting of the Ordinary Meeting Contracting Parties to Descelona Convention the Barcelona Convention in September 1987, within the framework of the Mediterranean Action Plan (MAP). IOI has been providing research support from the inception and throughout the various stages of the proposal.

A UNIDO-convened meeting of Mediterranean experts to assess the proposal and feasibility study in April 1989 welcomed the initiative and gave that organisation the green light to take the steps necessary for the establishment of the the establishment of centre. In that meeting. Government experts from several Mediterranean states, such as Egypt, Morocco, Turkey, Cyprus, Algeria and Italy, studied the proposal and supported its development and implementation. Spain and Bulgaria sent observers. Yugoslavia. Greece and Israel also expressed interest in the centre. Following the meeting, a number

of states specifically offered to host the centre.

The workshop was convened in collaboration with the UN Secretariat Office of Ocean Affairs and the Law of the Sea. Also supporting the proposal at the meeting were representatives of IOC, UNEP Coordinating Unit for MAP and FAO.

Since the beginning of 1990. UNIDO has continued to carry out consultations with Mediterranean Governnments and other intergovernmental organisations to facilitate the establishment of the centre.

#### <u>Caribbean marine technology</u> <u>centre</u>

Following the warm reception of the Mediterranean proposal, a similar proposal for a marine technology centre suitable to needs of the the Wider Caribbean is being supported by UNIDO in its first phase, and eventually also by UNEP in its second phase. As in the Mediterranean, the IOI 15 providing support to the project from its office in Canada.

#### Tourism and environment

The research project on finding alternative ways of financing the Mediterranean Trust Fund of the Mediterranean Action Plan is well under way. Funded by the Ford Foundation, a number of studies are being undertaken by the Malta and Canada offices of the IOI, as well as by other researchers. A principal activity of the project will be the distribution of a questionnaire to a sample of tourists in the region.

The project is examining ways

how tourists in this environmentally sensitive region may be more directly involved in measures for the protection of the Mediterranean marine environment, notably by supporting a charge on the 'use' of the environment. The ensuing income channelled into the would be Trust Fund support efforts to protect to and enhance the Mediterranean marine environment.

#### Perestroika International

Following a proposal by Prof. Ronald St. John Macdonald, of Dalhousie Law School, the IOI is involved in a project to set up an international commission to study the international implications of Perestroika. In collaboration with Soviet scholars, the project will have component on the a implementation and the progressive development of the law of the sea.
