doesn't take much to wreck our ability to pay rich dividends – we have come through a very difficult decade in Nova Scotia during which our higher education system has struggled to keep up to the demands placed on us during an era of stringent cutbacks – yesterday the provincial government reaffirmed its support for improved post-secondary funding and we are grateful for this – yesterday, the federal government also made an historic announcement creating the 21st Century Chairs for Research Excellence – we are grateful for this announcement as well as recent increases in the funding provided to our national research councils

- strong and continuing support from our federal and provincial governments for higher education and research are an essential investment in our future today we see a direct manifestation of that impact and potential through the creation of the Atlantic Canada Petroleum Institute I want to thank all of our sponsors and on behalf of our education partners in this endeavour I want to say how proud and committed we are to helping build a better future for Nova Scotians.

## Closing Remarks

- Before we close this event, allow me to summarize the support we've received to date for the
   ACPI and its overall mandate.
- To date, we have received \$5.35 million over five years to support the ACPI:
  - \$2.1 million from our industry partners
  - \$1.25 million from the Canada-Nova Scotia Economic Cooperation Agreement

- \$1.5 million from the Canada-Nova Scotia Offshore Development Agreement
- \$0.5 million from the Dalhousie University Killam Endowment
- Our purpose at this stage in the evolution of the ACPI, and subject to further discussions with our partners, is three-fold:
  - (1) Coordinate and organize research activity in cooperation with our industry partners and community groups
  - (2) Coordinate and organize education programs and training opportunities for those who wish to work and develop in the industry
  - (3) Create a forum where the producers, their suppliers, their customers, affected social groups such as the offshore fishery, government representatives and university faculty and staff can meet informally to define problems of mutual concern and develop solutions that meet our collective needs.
