

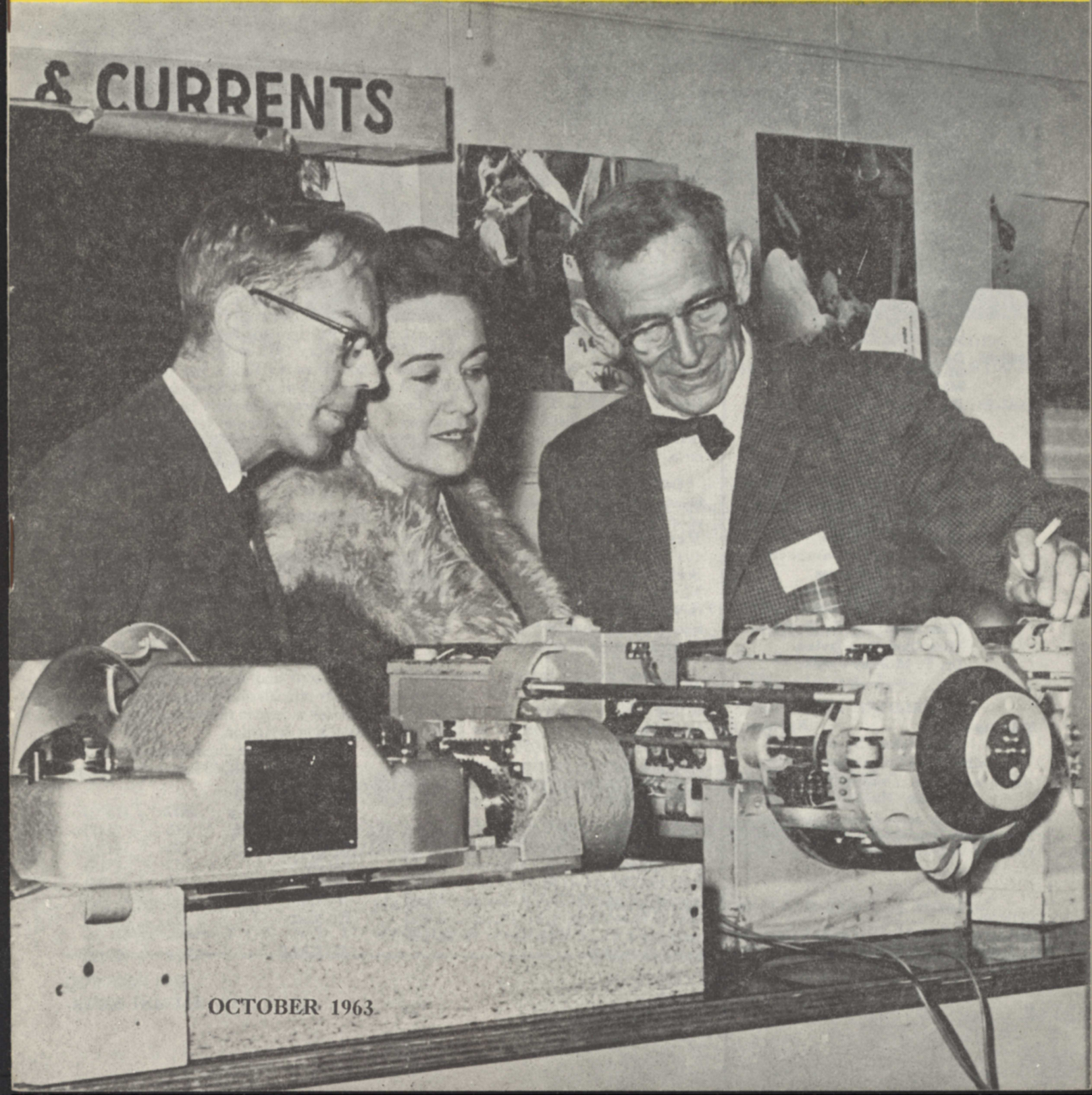

Dal-King's: NEW PRESIDENTS AT THE HELMS

Both Dalhousie and the University of King's College began the 1963-64 term with new presidents at the helms. At Dalhousie Dr. Henry D. Hicks succeeded Dr. A. E. Kerr, who has retired, and at King's Dr. Harry D. Smith succeeded Rev. Canon H. L. Puxley, who has become head of the newly formed Canadian Institute of Ecumenical Affairs in Toronto.

Dr. Hicks has been on the staff at Dalhousie since 1960 as Dean of the Faculty of Arts and Science, and since 1961 as Vice-President. A Rhodes Scholar for 1937, he received his early education at Bridgetown, N. S. before going on to Mount Allison and Dalhousie. He received his Bachelor of Civil Law degree from Oxford in 1940 and saw service overseas during World War II.

He was elected to the Nova Scotia Legislature in 1945 and was appointed to the cabinet in 1949. In 1954 he became Premier and he served as leader of the opposition from 1956 to 1960. Dr. Hicks is married to the former Pauline Banks of Caledonia and has two sons and two daughters.

Dr. Smith is also a native Nova Scotian and received his early education in Halifax. He graduated from Dalhousie with a B.A. in 1939 and an M.A. in 1941. After serving in the RCNVR during World War II he returned to his studies and was awarded a Ph.D. from Laval (with distinction) in 1947.

Dr. Smith began his career as a teacher at Queen Elizabeth High School in Halifax. In 1949 he joined the staff at Dalhousie and from 1953 until the time of his appointment to King's has been professor of French at Royal Roads and head of the department of modern languages. Mrs. Smith is the former Joy Morrison, B.A. (K) '42 of Halifax. The Smiths have four children, a son and three daughters.

Registration Soars to 2864

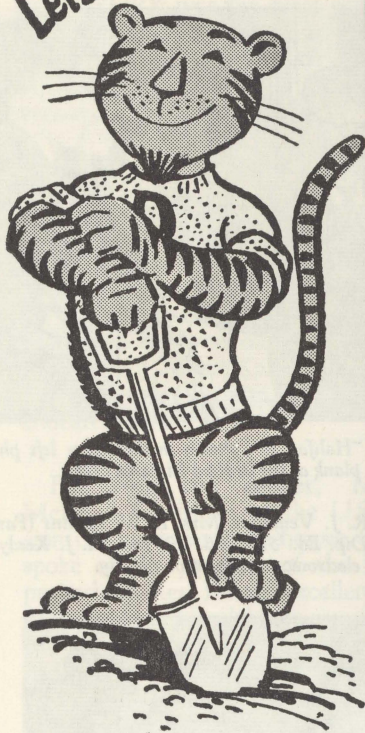
There are over 1000 more students on campus at Dalhousie this year than there were four years ago. With 2864 students registered for 1963-64 the University is literally bulging at the seams.

This year's enrollment, which is an increase of 352 over last year's, has created many staff and space problems for University officials and points out the urgent need for success in the current \$16,100,000 expansion campaign.

ALUMNI VISIT THE BEDFORD INSTITUTE OF OCEANOGRAPHY

Dalhousie Alumni took to the water instead of the banquet table when they gathered for their fall meeting on October 10. The occasion was a visit by ferry boat to the Bedford Institute of Oceanography.

Over 200 alumni from the Halifax-Dartmouth area took advantage of the cruise on Halifax Harbour, while over 100 less-nautically-inclined members travelled to the Institute by car. The weatherman favoured the alumni and came up with a calm, crystal clear, fall night which made the boat cruise all the more pleasant.

The visit to the Institute was arranged by a special committee of the Board of Directors in co-operation with the Dalhousie Institute of Oceanography and the federally owned Bedford Institute. The Dalhousie Institute is closely affiliated with the Bedford group, and the various demonstrations were staffed by personnel from both institutes.

The Bedford Institute is Canada's center for hydrography, oceanography, geophysics, chemistry and geology for the Atlantic and most of the Canadian Arctic. The Institute is designed for a total staff of 300 - about half engineers and scientists.

The establishment of the Institute in Halifax is of major importance to the Dalhousie Institute and means that the university department will become one of the leading oceanographic centers in North America.

At Bedford, the alumni were able to roam freely throughout the brand new building and observe many interesting displays including the Tidal Laboratory, the Seawater Analysis Section, Oceanographic Analysis, Sedimentology and Geochemistry Sections.

During the evening, coffee and doughnuts were served in the Institute cafeteria.

The visit ended on a humorous note. Apparently several alumni became so engrossed in the demonstrations that they failed to hear the repeated soundings of the departure whistle. It was rather pathetic to see them waving frantically from the dock as the ferry pulled out into mid-stream and started down the harbour. Fortunately, thanks to those who took their cars, all got home safely and no one had to spend the night on the dock.

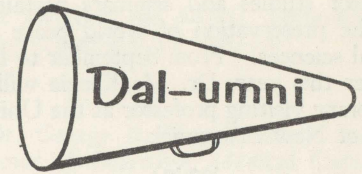
SAINT JOHN

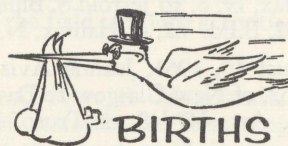

In Memoriam

Dr. Lorris E. Borden, B.A. '99, M.D., C.M. '02, died in Victoria, July 22, 1963, at the age of 86. Born at Sheffield Mills, N. S., he was a member of the first Canadian Arctic expedition in 1903 when official possession of Ellesmere and Southampton and adjacent smaller Islands was taken for the Canadian government. Fifty-three years later Canada's claim of sovereignty over the Arctic islands was established through his efforts. He was a surgeon with the government-sponsored sealing vessel Neptune which sailed north on the expedition. He retired from practice after 37 years in Nelson, B. C., and

had lived in Victoria since 1955. He was a major in the medical corps in both world wars, and represented Nelson from 1928 to 1933 in the British Columbia legislature. During his days at Dalhousie he was a star football player.

Gerald Dwyer, LL.B. '32, died in Halifax, July 3. He received his early education in England and after engaging in business in Halifax for a time he entered Dalhousie Law School. He began his legal career in Kentville, and in 1945 became associated with the Mersey Paper Company in Liverpool. Since retirement he had lived at his old home in Halifax. He served in both world wars with the rank of captain. He was prominent in politics, and also interested in golf and yachting. He received the bronze medal of the Royal Humane Society for saving the life of a friend at sea in a yachting accident.

Roderick M. Richardson, B.A. '22, Dip. Eng. '22, B.Sc. (McGill), died in Westville, July 29, after a brief illness. He was born in Eureka, and attended Pictou Academy, later graduating from Dalhousie with great distinction. He served for four years with the Canadian Expeditionary Force. He was chief Engineer with the New Brunswick Telephone Company for the last several years before his retirement in 1956.

Mrs. H. G. Grant, the former Marguerite H. L. Silver, died in Halifax, July 27. She was born in Halifax and was a graduate of Halifax Ladies' College. She received her B.A. from Dalhousie in 1910 with distinction, and her M.A. the following year. Most of her life was spent in Halifax where her husband the late Dr. H. G. Grant was Dean of Medicine at Dalhousie University.

Peter L. Judge, Q.C., LL.B. '27, died in Yarmouth, August 4. He was born in Liverpool in 1902 and graduated from Liverpool High School before moving with his family to Yarmouth. He received his B.A. and B.Sc. degrees from Acadia University before entering Dalhousie Law School. Since 1937 he had been in practice in his own law firm in Yarmouth, and had been solicitor for the town since 1954. He was a director of various local companies, and active in politics, serving for a time as president of the local Progressive Conservative Association.

Judge A. W. Bennett, LL.B. '85, a native of Albert County, New Brunswick and for many years a leading New Brunswick jurist, died in Moncton, July 10.

He was appointed county court judge in 1918 and held that position until his retirement in 1945. In 1959 he was awarded an honorary doctorate of laws by Dalhousie University.

Rev. Robert H. Scott died in Queensville, Ontario, July 7, at the age of 71. He was born at Jardenville, N. B. and attended Dalhousie University for a few years between 1911 and 1924, first in Arts and later in Law. He graduated in 1925 from Pine Hill Divinity College, and since then had held charges chiefly in New Brunswick, as well as being prominent in welfare work.

John J. Eisnor, Arts and Eng. '07-'09, died at his home in Belmont, Mass., May 2. He was born in Lunenburg and attended Pictou Academy before coming to Dalhousie. Most of his later life was spent in Massachusetts where he was engaged as a civil and construction engineer, for the last years in business for himself.

Alan R. Yeoman, B.A. '13, died in Halifax, June 28. He was a native of Halifax, and was 76 years old. He was professor of English literature at St. Mary's University, and was an active member of the Halifax Poetry Society and the North British Society.

Frank Peter Harris was killed in a highway accident near Presque Isle, Maine, May 9, 1963. He was a second year Arts and Science student. He was 21 years old. He was the son of Mr. and Mrs. Roy C. Harris of Truro, his mother being the former Kathleen Miller, B.A. '29. Brian K. O'Donoghue (Kings) of Lancaster, New Brunswick, died May 27 as a result of the same accident. He was 23. The boys were en route to summer employment at the time of the tragedy.

B. in 1912, he attended Saint John High School and Mount Allison University before coming to Dalhousie in 1934. During World War Two he served with the Royal Canadian Navy. His wife, who survives, is the former Dr. Dorothy Redmond, B.A. '33, M.D., C.M., (Toronto), '39.

Irving B. Howatt, Q.C., B.A. '02, M.A. '12, died in Edmonton, June 29 after a short illness. He was born at Victoria, P.E.I. in 1875, and after graduation from Dalhousie, he went to Alberta where he was appointed King's Counsel in 1921. In 1960 after 50 years of service, he was made an Honorary Life Member of the Edmonton Bar Association. He was Crown Prosecutor at the first Eskimo murder trial ever held in the North West Territories, at Aklavik in 1921. The defendant was found guilty and sentenced to five years at Stony Mountain Penitentiary.

Miss Ethel Belcher died in Halifax, September 10, after a long period of ill-health. She was a life-long resident of Halifax, having attended Halifax Academy and later Dalhousie University for one year, 1900-'01.

Fred George Faulkner, Dip. Pharm. '42, died in Halifax, October 4, at the age of 44. He was born at Truro, and attended school at Shubenacadie before coming to Halifax. For the past 12 years he was proprietor of the Medical Arts Pharmacy in Halifax. He is survived by his wife and four children.

Rev. William Forsyth Burns, Arts '03-'07, Minister of Duncan United Church, Duncan, B. C., for the 20 years, died in October. He was a native of Scotch Ridge, and attended school at Milltown and Fredericton before coming to Dalhousie. Later he graduated from Pine Hill Theological College. His first pastorate was at Salt Springs, Pictou County before going West, first to Alberta and for the last many years in British Columbia. One of his surviving relatives is his brother, Ralph C. Burns, Q.C., '06, of Calgary, Alberta.

Donald Willis MacDonald, died at his home in Kentville, October 14, following a heart attack. For the past 18 years he had been a teacher in the Kings County Academy. Born at Sydney Mines 48 years ago, he graduated from Acadia University with a B.A. in 1936, and attended Dalhousie Med. '37-'39. He taught school at Woodville and Sydney Mines before going to Kentville. Surviving are his wife and one son.
