I am enclosing one set of all the material we have prepared for our World Commission activities. I know that there has been some delay in this work, but I have been under tremendous pressure having to do a lot of work in my department.

You will notice that I am trying to do two things through IWCO work :

- 1. A survey of the views of about 1500 individuals in the Indian Ocean region who are in one way or other connected with Ocean Affairs.
- 2. A Directory of Institutions and Organizations in the Indian Ocean Region engaged in any aspect of Ocean Affairs. We are mailing the questionnaire to about 500 such institutions.

I propose to hold the hearings in two or three places in the first week of August 1996. Dr.Saigal is willing to be present at these hearings.

I would like to have your comments on the material we have prepared and any advice regarding the hearings.



I have just returned from Delhi to find your fax dated August 4, 1996. All of us here thank you for the nice words you have said about our work. We ourselves believe that our contribution is very modest when compared to what people like you and Dr. Salgal have been doing for so many years.

I know that Dr. Saigal has kept you informed of the events of last week. All the four hearings went off very well with good participation. They also received publicity in the national press. I am now busy summarising the conclusions and recomendations of the four hearings. Both from the survey and the hearings, we now have a wealth of information. While it would take considerable time to analyse of the data in detail, we hope to put together a quick report for submission to the Commission before the Rotterdam meeting. Dr. Saigal wants the report by mid-October and we will try to stick to this deadline.

Mr. Faleiro chaired the hearings in Goa and Delhi and he is now completely with us. He would have realised that we can be so much more helpful to him compared to what the Department of Ocean Development could have done for him. From now on, I shall keep him informed of all the developments.

I will be in Canada from 17th to 29th of this month. I am attending a symposium of the International Organization of Science and Technology Education at Edmonton from 17th to 22nd August. Of the two papers I am presenting there, one is entitled "A Sea of Ignorance : What Our Children Do Not Know About the Oceans". My airticket is via Frankfurt and Toronto and I am not planning to visit Halifax. But when I am In Canada, I shall try talk to you over telephone.

I hope you received my fax message sent on July 31, 1996 agreeing to represent you at the Manila Conference in December. I am awaiting a formal invitation from ACOPS.
