

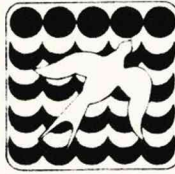

Dear Elizabeth:

While I was in Woods Hole I visited with Paul Fye, and mentioned to him our meeting and travelling down to Boston together. He was delighted, and sends his warmest regards to you.

We also talked about the 3rd World training program, about the films you are planning and the question of funding for such film projects. Following are briefly stated the main conclusions of that discussion:

1. Paul supports the idea of such films, and thinks that is one way of furthering communication and training.
2. He agrees with me that the film locales should be chosen for their particular subject and relevance, and that they should not necessarily be made where your courses are given.
3. He has broad experience in funding and foundation money, and suggests the Tinker Foundation (money to Latin & S. America), Morgan Guarantee Trust, Pew (of SunOil Co.) and Busch. There are of course a host of others who might be very interested in this kind of project, and it might be worthwhile talking to Fye directly.

He also suggested that Maurice Strong (formerly of PetroCanada) might be interested. You may recall that he was at one time very much a third-world champion, and may be interested in diverting some funds or energies in your direction. Now living I believe in Phoenix, Arizona.

Also, there is a Japanese businessman named Sasakawa, who is underwriting IFIAS. He is very much ocean-oriented, is involved in the UN, has vast and high-level connections (Japan's emperor, King of Sweden, etc.). But speak to Paul, since he is seen in somewhat dubious light in Japan. However, his funding IFIAS is a positive, and maybe you don't care what they think of him in Japan.


