

and where Li Da-Zhao and Mao Zhe-dong used to work. Some well-known artists, scientists, historians, philosophers, jurists, and educators used to study or work in Peking University. At present, Peking University plays a key role in the current effort to update legal education in China and to improve the socialist legal system with the context of the "Four Modernizations".

As regards Chinese legal reform, progress has been made since the third Session of the 11th Central Committee of the Chinese Communist Party in 1978, which is regarded as the historical turning point of the Chinese legal system. The new Constitution was adopted in 1982, at the Fifth Session of the National People's Congress. Four basic principles, the foundation stones of the country, were written within the Preamble of the Constitution: Adhere to Leninist Mao-Zhe-dong thought; Adhere to people's democratic dictatorship; Adhere to socialist road and Adhere to the four modernizations.

According to the new Constitution, which provides that the socialist legal system should be developed and improved, 56 laws have been adopted by the National People's Congress and its Standing Committee, more than half of which are legislations on economy; 107 resolutions, decisions on revision of laws and on other legal matters, have been made. In addition, more than 700 local legal regulations were promulgated by provinces, autonomous regions or state-controlled municipalities. Constitutive laws are basically completed.

The following laws have already been promulgated: the General Civil Law, Civil Procedures(for trial implementation), Criminal Law,Criminal Procedures, Law of Economic Contracts, Law of Trade Mark, Patent Law, Law of Chinese Foreign Joint Venture Enterprises, Law of Foreign Venture Enterprises, Law of Economic Contracts with Foreign Elements, Family Law, Law of Succession, Law of Environmental Protection (for trial implementation), Law of Forest, Law of Free Education, Law of Nationality, etc. It is thus evident that China has laws in place to regulate and promote its national and social life.

Since 1978, China has been carrying on an open-door policy to the outside world In particular, foreign and joint venture projects are encouraged. At the same time, private and collective enterprises are encouraged according to the policy of the reform of the economic system. All these domestic and external reforms have stimulated law reform and the development of Chinese legal education.t

In this commentary, an effort will be made to sketch a few of the broad trends in legal education in China, with special reference to Peking University and to outline briefly the development of the Chinese legal system. Our discussion will conclude with a specific proposal for the establishment of a research centre in Beijing on comparative and international law. A brief overview of the development of Chinese legal education since the founding of the P.R.C. may be useful.



AGREEMENT FOR ACADEMIC EXCHANGE BETWEEN
AND PEKING UNIVERSITY

It is decided that _____ and PEKING UNIVERSITY will put into practice the following agreement on academic exchange:

1. Both universities will maintain a continuous relationship and will each year exchange all relevant information concerning teaching and research plans.

2. Both universities, subject to the host university's agreement in each case, shall exchange academic staff as visiting scholars to engage in research and advanced study. The international travel expenses of the scholars will be borne by the sending university; but academic and living expenses at the host university will be paid as far as possible by the host university. The amount of the payment should be determined consistent with the academic rank and the work undertaken by the visiting scholar and should conform to the regulations of the host university.

3. Both universities will also receive visiting scholars for purposes of teaching and the exchange of teaching experiences. For such visits, terms of appointment shall be individually arranged.

4. Each university may, subject to agreement, accept Ph. D. candidates from the other university who will, during their studies at the host university, be supervised by a staff member in the host university. Arrangement for the supervision in the host university should be

agreed when the student embarks on his postgraduate course. Notwithstanding the need for close cooperation between the two supervisors and the two departments participating in the joint programme, the responsibility for the agreed courses and for the assessment of the thesis shall remain with the sending university.

The doctoral student should enjoy the same treatment as that of the visiting scholars.

5. This academic exchange agreement may be implemented through the financial support of the respective governments or of appropriate foundations.

6. will assist PEKING UNIVERSITY library to obtain books and periodicals, both current and out of print, in original or photocopied form, and PEKING UNIVERSITY will assist the library of to obtain Chinese books and periodicals in similar way.

7. Both universities shall make proposals each year for the coming year and, subject to approval by both sides, arrange for the implementation of what has been agreed to.

8. This agreement may, after consultation, be revised or terminated.
