## REPORT

# NGO Roundtable Organized

The United Nations Association in Canada (UNA Canada) convened a Roundtable for NGOs concerned with fisheries and oceans issues at the United Nations in New York, April 20-22, 1993. The NGO Roundtable was held on the margin of the intergovernmental Organizational Session (April 19-23) in preparation for the UN Conference on Straddling and Highly Migratory Fish Stocks. The Conference is scheduled for July 12-30, 1993 in New York. Support for the organization of this Roundtable was provided by the Government of Canada's fund for public information on high seas fishing.

# Roundtable Objectives

The objectives of the Roundtable were to: facilitate NGO support for this Conference; heighten the NGO community's awareness of this international marine environmental problem; identify and discuss the issues; develop individual NGO and collective approaches towards addressing the problem(s); and, discuss mechanisms for ensuring effective NGO participation in the Conference.

## Participation

Twenty-five participants representing NGOs from Europe, the United States, and Canada attended. (See attached participants list.) The participants regretted the absence of southern representatives, and resolved to secure funding for southern NGOs to attend the meeting in July. [Alicia Barcena of the Costa Rican-based Earth Council is endeavouring to obtain funds and UNA Canada is seeking support from the Canadian government for southern NGOs to participate in the Conference.]

### Agenda

A flexible agenda was adopted enabling the Roundtable participants to meet on the margin of the official plenary sessions and affording individuals as well as the group the opportunity to meet with government delegations. As much of the week's Organizational Meeting was spent in informal sessions to which NGOs were not privy, the Roundtable discussions proceeded intensely for three days. (See attached Agenda). The NGOs discussed issues, initiatives, management principles, mechanisms and strategies.

# Roundtable Meetings with Delegations

Several delegations (Chile, Iceland, Peru, the United States, Canada, and the European Commission including Spain, Denmark, Germany, and the U.K.) as well as the Conference Chairperson, Satya Nandan, agreed to meet with the Roundtable

participants. These exchanges were very useful and served to clarify individual government's positions, strategies, aspirations and options. In turn, the NGOs demonstrated their interest in and level of commitment towards achieving sustainable fisheries policies and practices both within national jurisdiction and on the high seas.

# **Roundtable Common Interests**

The Roundtable participants are concerned that concrete conservation and responsible fishing measures be adopted and implemented at the July Conference; and that the Conference not repeat the protracted Law of the Sea process. The Roundtable NGOs agreed that the following measures were necessary: a binding code of conduct for responsible fishing; effective international monitoring, control and surveillance systems; an ecosystem management approach, where possible, to fisheries management; restrictions on reflagging; improved scientific research and data collection to assess the impact of high seas fishing on the marine ecosystem; and the adoption of the precautionary principle (to abate, abstain, or prohibit fishing) where the resource is at risk and scientific information is not available or is inadequate.

Several other management principles and mechanisms, sanctions and types of governance (to include stakeholders, communities, and NGOs) were also discussed. The provisions of the Fisheries Treaty drafted at the Global Forum were reviewed and consideration was given to expanding the Treaty or developing a separate document prior to or during the Conference pertaining to straddling and highly migratory fish.

# Follow-Up Action

1. Several Working Groups and an information exchange network were established in order to facilitate a cooperative approach in preparation for the July Conference. These groups/committees are open to all interested. Clif Curtis, Greenpeace agreed to coordinate the submissions from the Working Groups and disseminate the materials to all participants and others interested.

2. An Information Session for European NGOs is being planned (possibly in Geneva in June) in cooperation with Indrani Lutchman, WWF-UK and Art Van Remundt, Earthtrust.

3. It is hoped that an NGO newsletter will be circulated in May or June to bring everyone up to date on developments since the New York meeting in preparation for the July session (Greenpeace, UNAC, others).

4. Events for Oceans Day, June 8, are also in the offing. Oceans Day was officially proclaimed at the Earth Summit. (The Oceans Institute of Canada held a two day event at the Global Forum.)

5. Canadian NGOs are planning to coordinate activities in Canada (and possibly abroad) prior to the Conference, perhaps in conjunction with Oceans Day.

6. The U.S. NGOs were planning to continue networking prior to the Conference and to link in with the Roundtable and other NGOs.

7. A full report of the New York Roundtable is being sent to southern NGOs and other interested parties who were unable to attend.

During the Organizational Meeting, Morocco, Tunisia and India attempted to undermine the participation of NGOs in the July conference. The Roundtable NGOs lobbied during the session to protect their access to and participation in the formal sessions. As a result of these efforts, NGOs mitigated these efforts to circumscribe NGO participation. NGOs are invited to make formal written submissions to the Conference Secretariat prior to May 15, 1993.

The Roundtable proved to be useful and productive. (please see attached Press releases.)

# NGOs gear up for the UN conference on overfishing (New York, July 1993)

New York - The Non-Governmental Organizations (NGOs) have begun gearing up for the UN Conference on the problem of overfishing on high seas, to be held in New York from 12-30 July, 1993. They hope the Conference will result in concrete conservation and management measures to address this global fisheries crisis in national and international waters.

More than 20 Canadian, American and International NGOs are represented this week in New York for the the organizational session preceeding the July Conference. In an effort to exchange ideas and to seek areas of cooperation among NGOs, the United Nations Association in Canada (UNA-Canada) is coordinating a 3-day Round-Table, attended by: Greenpeace, the World Wide Fund for Nature(WWF), the National Audubon Society, International Coalition of Fisheries Associations, Earthtrust, the Natural Resources Defense Council, the Council on Ocean Law, the American Oceans Campaign, Environmental Defense Fund, Oceans Institute of Canada, SONAR, and the UNA-Canada.

The NGOs seek an effective and enforceable management regime for straddling and highly migratory fish stocks to be concluded at the July Conference. This group of NGOs promotes the implementation of concrete measures including: a binding code of conduct for responsible fishing, a precautionary approach to management, restrictions on reflagging, and improved scientific research to assess the impact of high seas fishing on the marine ecosystem.

The NGOs stressed the need for effective conservation and responsible management measures to ensure the sustainable development of fisheries everywhere, as fish do not respect political boundaries.

The problem of overfishing of straddling stocks (those fish which migrate beyond the 200-mile limit into international waters) is especially important to Canada. The federal government has taken this issue to the international community at the United Nations to further Canada's efforts to control foreign fleets offshore Newfoundland. Canada is championing the cause to protect the global commons.

This NGO Roundtable is chaired by Ms. Evelyne Meltzer from UNA-Canada's Halifax Branch.
