Dalhousie's first general international fraternity, Nova Scotia Alpha of Phi Delta Theta celebrates its 50th anniversary March 21-23 when many famous sons will be coming home for a unique reunion.

Leading off the parade will be Dr. John Budd (BA'29, MDCM'33, LLD'78) of Cleveland, Ohio, President Emeritus of the American Medical Association who received an Honorary Degree from Dalhousie in 1978. Also on the speakers rostrum will be Dr. F. Ronald Hayes (B.Sc.'26, M.Sc.'27, Ph.D'29, LLD'65), Honorary President of the fraternity who is an internationally famous oceanographer.

Don Murray, (BA'29), resident musician in the fraternity's first chapter house on South Park Street composed the music for the Half Pint Revue, a smash Glee Club hit of the twenties and has revived the old songs for presentation at the Homecoming Dinner at the Hotel Nova Scotian March 21. They include: Dalhousie Dream Girl, Down Back of Shirreff Hall, the Dalhousie Cheer Song and We Just Came in from Tatamagouche. As you may have guessed, Don hails from Tatamagouche, ancestral home of the musical Murrays and is an uncle of the popular singer, Anne. He is now a retired teacher living in Toronto.

From the fledgling Nova Scotia Alpha have come some continentally famous men in the fields of medicine, law, science, the arts, commerce and government. Time after time, at their Christmas banquet head table in the

present Seymour St. Chapter House have sat the Lieutenant Governor of Nova Scotia, the Premier of Nova Scotia and the Mayor of Halifax.

The active chapter members under chairman Paul MacInnes have been busy for weeks working out a lively three-day program. A reception and registration will be held at the Hotel Nova Scotian the evening of Thursday March 20. The anniversary dinner on Friday will be followed by an oldfashioned singsong and dancing. Alumni meetings will be held Saturday morning when members of 50-year standing will be presented with the Golden Legion Award. MacKay named president by Derek Mann

Dr. W. Andrew MacKay, vicepresident of Dalhousie University since 1974, will succeed Dr. Henry D. Hicks as president of the university in September

The announcement of Dr. MacKay's appointment was made January 8 by Donald McInnes, QC, chairman of the Board of Governors.

Mr. McInnes said the appointment of Dr. MacKay had been recommended by the presidential selection committee, which consisted of three members of the Board of Governors, three members of the Senate of Dalhousie, and a representative of the Student Union.

Dr. MacKay will assume the presidency on Sept. 1.

Mr. McInnes said that the selection committee had considered many outstanding candidates among the 90 nominations and applications for the presidency. Four candidates had been placed on a short list and they had been interviewed by the committee and by individuals and representative groups at the university.

"I am delighted that Andrew MacKay has been selected. His Dalhousie experience over the past 22 years as a teacher and administrator, and his intimate knowledge of all facets of the university cannot help but be valuable assets to him and to the university," said Mr. McInnes.

"In addition, his modest demeanor, his calmness and his patience are great attributes which, in a university as large and diverse as Dalhousie, will no doubt serve him and the university extremely well."

Now 50, Professor William Andrew MacKay was born in Halifax and received his early education there and in Ottawa. He was graduated from Dalhousie with his BA (1950), his LLB (1953) and his LLM (1954). In 1960 he won a Ford Foundation Fellowship for Law Teachers to study at Harvard University Law School, whence he received his second LLM.

After articling with the Halifax law firm of Stewart, Smith, MacKeen and Covert and being admitted to the Bar of Nova Scotia in 1954, Dr. MacKay joined the Department of External Affairs in Ottawa as a foreign service officer, a post he held for three years until his return to Dalhousie as a teacher in 1957. He was assistant secretary to the Royal Commission on Canada's Economic Prospects from 1955 to 1957.

Prof. MacKay was appointed an assistant professor of law at Dalhousie in 1957 and rose at two-year intervals to the rank of professor. In 1964 he succeeded the late Dr. Horace E. Read as Dean of the Faculty of Law and Weldon Professor of Law, a position he held until 1969 when he was appointed vice-president (Academic).

When the Office of the President was reorganized in 1974, Prof. MacKay was appointed vice-president of the university, becoming responsible for three faculties (Dentistry, Health Professions and Medicine), external relations and reporting, planning and forecasting services and budgets.

During his years as a student at Dalhousie, Prof. MacKay was quarterback of the varsity football team and also played varsity basketball. The Climo Trophy, for athletic ability, sportsmanship and team spirit, was awarded to him in 1948-49. In 1953 he received the Dalhousie Student Union's highest award, the Malcolm Honour Award, for outstanding student activity on and off campus, and the same year was elected life president of the Class of 1953.

Active in community organizations, Dr. MacKay was president of the Rotary Club of Halifax (1967-68); a director of the Halifax YMCA (1962-65); honorary counsel to the Nova Scotia Division of the Canadian Red Cross Society (1966-68); a member of the board of directors of the 1974 Halifax-Dartmouth United Appeal; a director of the Canadian Studies Foundation (1970-75); a member of the Oil and Gas Committee of Canada (1973-74); a director of the Association of Universities and Colleges of Canada (1975-78); is a trustee of BM-RT Realty Investment Trust (since 1973); chairman of the board of governors of Armbrae Academy (formerly Halifax Ladies' College, since 1977); and is a member of session of St. Andrew's United Church, Halifax.

In 1973, Prof. MacKay became a Queen's Counsel, and in 1976 was awarded an honorary Doctor of Laws degree by Memorial University of Newfoundland.

Dr. MacKay, whose father, the late Dr. R.A. MacKay, was a profesor of political science at Dalhousie for many years, is married to the former Alexa Eaton Wright, of Riverside, Nova Scotia. They have one daughter, Margaret.

The date of Dr. MacKay's formal installation as president will be announced later.

Tom Kent named Dean of Administrative Studies

The appointment of Tom Kent as Dean of Administrative Studies at Dalhousie University was announced in January by the president, Dr. Henry D. Hicks.

Dr. Hicks said Mr. Kent would assume the Deanship on July 1, succeeding Dr. A. Peter Ruderman, who is taking leave of absence to work in the health administration field with the Department of Health and Welfare in Ottawa.

"I am delighted that a man of Mr. Kent's broad experience in government and industry has agreed to join Dalhousie," said Dr. Hicks.

Mr. Kent, a native of England, obtained his BA, with first-class honours in philisophy, politics and economics, in 1941 from Oxford and his MA in 1950.

Mr. Kent moved to Canada in 1954 to become editor of the Free Press in Winnipeg, a post he held for five years before becoming vice-president of Chemcell Ltd., Montreal, the company then responsible for international operations of Celanese Corporation in Canada, Mexico, Venezuela and Colombia.

From 1961 Mr. Kent worked closely with Opposition Leader Lester B. Pearson and later was Policy Secretary to Mr. Pearson when he became Prime Minister, responsible for the coordination of government programming, and director of the special planning secretariat of the Privy Council Office.

In 1966 Mr. Kent was appointed deputy minister of Manpower and Immigration and, from 1968 to 1971, deputy minister of Regional Economic Expansion.

In 1971 he became president and chief executive officer of the Cape Breton Development Corporation, a post he held for six years before becoming president and chief executive officer of Sydney Steel Corporation, a post he left last year.

Mr. Kent has for some time been associated with Dalhousie University; as a member of the Council of the Institute of Public Affairs and a member of the advisory board to the School of Business Administration.

In addition he is president of T.W.K. Associated Consulting Ltd., senior adviser to H.B. Nickerson and Sons Ltd., a member of the board and chairman of the editorial board of the Institute for Research on Public Policy, a director of the Cape Breton Development Corporation, chairman of Cape Breton Lamb Ltd., a member of the board of governors of the Atlantic Provinces Economic Council, a member of the board of the Bell Institute of the College of Cape Breton, and a member of the board of the Atlantic Management Institute.

He was invested as an Officer of the Order of Canada last year.

Faculty News

Dr. Donald Drysdale Betts, professor of physics and former director of the Theoretical Physics Institute at the University of Alberta, has been appointed Dean of the Faculty of Arts and Science at Dalhousie University. The announcement was made by Dr. Henry D. Hicks, President of Dalhousie, in February.

Dr. Betts will assume the Deanship on July 1. He succeeds Dr. James Gray. Dr. Betts holds a BSc. Hon. '50 in physics and a MSc. in experimental physics from Dalhousie. He received his Ph.D in mathematical physics from McGill University in 1955.

Dr. Kenneth T. Leffek has been reappointed Dean of the Faculty of Graduate Studies for a third term, the president, Dr. Henry D. Hicks, announced in January.

Dr. Leffek, whose new term is for five years, was first appointed Dean in 1972.

Professor Jim Hoyle, head of the undergraduate* physical education division, has been appointed manager of the Canadian Canoe-Kayak White-Water Team. The two-year appointment involves sending the National Team to Europe this summer and to the World Championships in 1981, which are to be held in Wales.

Dr. Hugh William Jones has been appointed professor and director of the engineering-physics section of the university's Department of Physics.

Dr. Jones holds a BSc. degree in mathematics and physics and a Ph.D in electrical engineering, all from London University.

Before joining Dalhousie in January, Dr. Jones was head of the Department of Electrical Engineering and Physical Electronics at Newcastle-Upon-Tyne Polytechnic in England.

Dr. Dwight Nance, formerly at UCLA and recently at the University of Southern Florida in Tampa, has taken an appointment as associate professor of anatomy at Dalhousie.

Dr. Nance's specialty is psychoneuro-endocrinology.

Dr. H.A. Robertson, Dalhousie pharmacologist with the Faculty of Medicine, has received a renewal grant of \$19,750 from the New York-based Guggenheim Foundation to study the neurochemical basis of emotional bahavior in animal models.

The Guggenheim Foundation was established in 1929 and its resources are now used to study man's relation to man.

Dal Frat (con't from page 1) An old fashioned beer bash is scheduled for the McInnes Room with an Irish band providing music from 2 to 5 p.m. It will be open house at the fraternity on Sunday when Bringham Philips and his Phi Boys will provide the entertainment.

The official history of Phi Delta Theta recounts that "1930 was a triumphant Canadian year for the fraternity, for in that year, with the S.S. Eastern Star, cruising through international waters of the Great Lakes," charters were granted to local chapters of Dalhousie and the Universities of Manitoba, Alberta, and British Columbia. McGill and the University of Toronto had obtained their charters previously.

Nova Scotia Alpha of Phi Delta Theta was born as "Corps Dalhousiana", a little group of Halifax Academy lads who had made fast friends with fellow freshmen and sophomores from Pictou, Cape Breton and other wellsprings of Dalhousie. They first met at the lodgings of Dr. Walter C. "Fat" MacKenzie (B.Sc.'29, MDCM'33, LLD'66) of Baddeck and Adam C. Bell (B.Sc.'30, M.Sc.'31) of New Glasgow, on Carleton Street. MacKenzie became Dean of Medicine, University of Alberta and was honoured by Dalhousie and the American College of Surgeons. Bell became a chemistry executive of Colgate, New Jersey. Both died recent-

Some of the early group included Kenneth Matheson (BA'30, LLB'33), executive of the Fraser Companies, Edmunston, N.B.; Victor Oland (BA'35) who became Lieutenant Governor of Nova Scotia; Alison Cumming (B.Sc.'30), retired President of Union Carbide; Dr. Frederick McLellan (B.Sc.'29, MDCM'33), retired New York urologist who is coming from Florida for the reunion; W. Graham Allen (BA'29) of the C.B.C.; Sanford W. "Barney" Archibald (B. Com.'31), retired President of Printolith Inc., New York who is Alumni Homecoming

Secretary; Thomas Sedgewick, Q.C. (BA'29), LLB'31) of Pictou; George Robertson, Q.C. (BA'38, LLB'40) of Halifax; Alex Bagg (B. Com.'35) retired Department of Transport official at the Toronto International Airport; Dr. Hugh Chisholm (MDCM'41) of Vancouver, B.C.; Sydney G. Alexander (Dip. Pharm.'29, B.Sc.'31), retired pharmaceutics executive with the Ayerst company who is coming "home" from St. Catherines, Ontario and Donald A. Mahon (B. Com.'33), Halifax stationery entrepreneur.

Nova Scotia Alpha has always had strong representation in the political field. The two major party candidates in the Halifax riding in the February 18 election were ex-Premier Gerald A. Regan (Lib.) and George Cooper (P.C.), both Phis. Walter Fitzgerald, M.L.A., Alumni Chairman of the Homecoming is a leading contender for provincial Liberal Party Leadership.

Ralph "Kelly" Morton (BA'29, LLB'31), journalist, presented Dalhousie's petition for a charter to the General Fraternity Conference aboard the S.S. Eastern Star cruising the Great Lakes in 1930, along with petitioners of the three western universities. All petitions were granted, making Phi Delta Theta the largest international fraternity in Canada.

In approving the charter, George Banta Sr., first President of the General Council, told Morton that an attempt had been made 53 years previously to bring Phi Delta Theta to Nova Scotia. He said: "A Scot professor came to us from Dalhousie at a time when we were looking for desirable places to expand. So attached were we all to him that we asked him to go back to Dalhousie and establish a group of Phis. However, at that time it was impossible for him to interest enough to proceed. Now a half century later you New Scotlanders come seeking a charter. It is gladly granted and Nova Scotia Alpha of Phi Delta Theta is established 'ad maiorem gloriam patriae!""

Learned Societies Conference 1981 gets Director

Dr. Renata Hedwig Kartsaklis has been named director of the Learned Societies Conference to be held at Dalhousie in May and June of 1981.

Dr. Kartsaklis, who hails from Bremen in the Federal Republic of Germany, comes to Dalhousie from the Neighbourhood Improvement Programs of the City of Halifax, where she acted as co-ordinator. A doctor of philosophy (Vienna), she has a broad range of experience in administrative and organizational roles.

As director of the Learned Societies Conference 1981, Dr. Kartsaklis is responsible for its complete organization, from room reservations to advertising to scheduling. She will be working with a steering committee made up of Dalhousie faculty and will depend mostly on the cooperative spirit of the Dalhousie community for assistance. A work force of about 40 people will be hired for the actual conference dates.

The Learned Societies of Canada is an organization of 110 scholarly and professional societies in the humanities and the social sciences, ranging in type from the traditional to esoteric. Each year, those who are able and interested hold their annual meetings on a single university campus

The concept of holding all such meetings in one place and in conjunction with each other began in the 1940's, when the Canadian Historical Association and several other societies decided that it would be professionally and economically worthwhile to meet together. Many of the organizations which participate have overlapping memberships, so holding all the meetings in one location means a considerable saving of personal or institutional travel

More than 70 subject or special interest organizations from across Canada are expected to participate in next year's huge academic gathering,

drawing in an estimated 6,000 participants from coast to coast. From 1,000 to 2,000 academics could be in Halifax on a given day.

The conference lasts for at least two weeks (duration depends on the number of societies participating), starting in late May.

Some of the organizations expected to take part in the annual meeting include: the Association of Canadian University Teachers of English, the Canadian Meteorological Society, the Society for the Study of Architecture in Canada, the Canadian Association of Latin American Studies, the Canadian Political Science Association, the Canadian Historical Association, the Canadian Theological Society, and many more.

The 1979 Learned Societies meeting was held in Saskatchewan. The 1980 conference will take place in Montreal.

According to Dr. Kartsaklis, her role is not only to draw learned Canadians to the conference, but to introduce them to Nova Scotia as well. "We have so much to offer here," she says, "I want to let people know about it." To this end, she intends to involve not just the Dalhousie community, but the citizens of Halifax and Nova Scotia also.




