ARTICLE I: NAME

Ser.

The name of this organization is the "Gay Alliance for Equality", a duly registered non-profit organization in the city of Halifax, county of Halifax, Province of Nova Scotia, hereinafter referred to as "the GAE".

ARTICLE II: PURPOSE

The purpose of the GAE is to promote education in all aspects of homosexuality, to educate the public, both lay and professional, regarding problems confronting the homosexual, to assist the individual homosexual, and to work - either alone or in conjunction with like-minded groups - for changes in the prevailing attitudes of society toward homosexuality, and for the removal of legal sanctions and public discrimination against homosexuals.

ARTICLE III: EXECUTIVE COMMITTEE

Executive Committee shall transact business of the GAE with approval of general membership, and shall meet at least twelve (12) times in a calendar year - one each month. Five officers shall be elected to serve a term of one year, and such officers shall fill the following positions:-

> Chairman Vice-Chairman Secretary Treasurer

Public Relations Officer

Vacancies - Successor officers elected by the membership to fill any vacancies created during a term, shall serve only the unexpired portion of that term.

All officers shall serve until their successors have qualified and have assumed office.

ARTICLE IV: MEMBERSHIP

The Executive Committee, with approval of general membership, shall make necessary rules and regulations for the admission of persons to active membership in the GAE, open to all who support the principles of GAE.

With approval of the membership at a General Meeting, The Executive Committee may suspend or revoke any participation in the activities of the GAE, or expel any member or members whose conduct in their view compromises or endangers, or is likely to compromise or endanger the publ ic standing or reputation of the GAE, or whose conduct is in any way deemed by the GAE to be harmful to the best interests of the GAE.

- 1. Nominations.
 - a) Nomination's to be made orally at a General Meeting at a time and date so designated by the Executive Committee to co-incide with a date appropriate to the end of their elected one year term in office.
 - b) Such nominees required to have two oral seconders.
 - c) No candidate's name shall appear on the official ballot unless he/she has accepted his/her nomination.
- 2. Elections.

- a) Voting shall be by secret ballot, every active member in good standing being entitled to one ballot.
- b) Official ballots to be distributed to each voting member on the day, date and place so designated for the election by the Executive Committee, with approval of the membership at a General Meeting of the GAE.
- c) The distribution and collection of all ballots shall be by an appointed Election Official and his/her committee. such official and committee to be chosen by general membership.
- d) Tabulation of ballots to be responsibility of the Election Official and his/her committee.
- e) The Election Official has <u>no vote</u>, except in the event of a tie, whereupon he/she shall cast the deciding ballot.

ARTICLE VI: MEETINGS

- The annual meeting of the GAE, and any special meetings which may be called, including all ratification meetings shall constitute the official meetings of the GAE.
- 2. The Chairman of the GAE shall be <u>ex officio</u> chairman of all meetings of the GAE, official or other. In his absence, the Vice-Chairman shall preside, but the Chairman may delegate the chairmanship to any responsible member of the GAE.
- 3. The annual meetings shall be held during the month of July, the date to be determined by the Executive Committee no later than May 1st. The Secretary shall notify the members of the GAE of the date of the annual meeting no later than May 15th. Reports from the officers of the GAE shall be submitted to the annual meeting, which meeting shall be open for the transaction of any other business. Announcement of the election returns and the installation of new officers shall be the final order of business at the annual meeting.

- 4. Special meetings shall be held under any one of the following conditions:
 - a) Upon call of the Chairman.
 - b) Upon call of the Secretary, provided he/she has previously been requested to do so by a petition signed by at least ten (10) of the active members in good standing.
- 5. There shall be no less than one (1) general meeting per month.

ARTICLE VII: AMENDMENTS

- Amendments to this Constitution may be proposed by submitting them in writing to the Secretary, provided that, prior to their submission, they have been signed either, a) by a majority of the members of the Executive Committee, or b) by at least ten (10) active members of the GAE in good standing.
- 2. A proposed amendment shall become valid as part of this Constitution upon ratification by two-thirds (2/3rds) of those voting at a special meeting called for this purpose, such meeting to be denominated a ratification meeting. Upon receipt by the Secretary of any proposed amendment, duly signed as required by Section One (I) of this Article, he/she shall give at least fourteen (14) days notice prior to the ratification meeting. Voting at any ratification meeting shall be open to every active member who is in good standing.


