of Canada Esq. and Anne Supper the wife of  
said Nathaniel Supper of the first part and  
Nathaniel Supper of said Milton County  
and Anne aforesaid Merchants of the second  
part.

Whereas the said Nathaniel  
Supper and Anne Supper his wife for and in  
consideration of the covenants and Agreements  
hereinafter reserved and contained by and on  
the part of the said Nathaniel Supper to be per-  
formed and kept and also in the further  
consideration of the sum of Ten Dollars to  
him to have well and truly paid by the said  
Nathaniel Supper at or before the Executing and  
delivery of these presents the Receipt whereof  
is hereby acknowledged It is granted, bargained,  
sold, aliened, Enfeoffed, Released, Conveyed and  
conveyed and by these presents do grant bargain  
sell alien and Enfeoff release Convey and convey  
unto the said Nathaniel Supper his heirs and  
assigns the following described Lot Farm or  
Tract of Land lately in the occupation of  
Michael Turpin situate lying and being near  
Quick Point on the Limpool River the Road  
to Milton running through the same containing  
forty Acres more or less - Together with all and  
singled the houses, outsheds, buildings

with, various common rights, powers  
and appurtenances to the said Lot of Land  
including or in any wise appertaining and  
the Remainder, Reversion, Remains and  
Remainder, Reversions and profits thereof  
and also all the Estate Rights title Inheritance  
claim and demand of the said Heir  
Supper and ~~Heir~~ Supper his wife of and  
with the same - So I have and so hold the  
said Lot of Land with the appurtenances unto  
and to the said Nathaniel Supper his heirs  
and assigns forever - And Trust for the following  
uses and purposes - that is to say, that upon  
the coming of age of Archibald Supper the Grandson  
of the said Heir and Supper he the said  
Nathaniel Supper and his heirs will execute  
and deliver to the said Archibald Supper  
a deed of conveyance of the Lot of Land  
hereinbefore described in fee simple, and it  
is also hereby understood to be the meaning  
of these presents and of the parties hereto that  
the said Nathaniel Supper shall receive  
the Rents and profits of the said Lot of Land  
for the use and benefit of the said Archibald  
Supper until he comes of age.

And the said Heir and Supper  
for himself his heirs Executors and Admini-  
strators doth hereby covenant promise and  
agree to and with the said Nathaniel Supper  
his heirs Executors Administrators and assigns  
in manner and form following that is to say

 lawful authority to grant sell and

 that he the said Immanuel Tupper and his heirs  
 well and lawfully the said lot of land  
 and premises unto and to the said Nathaniel  
 Tupper and his heirs against the lawful claim  
 and demands of all persons whomsoever, shall  
 and will by these presents warrant and freely
