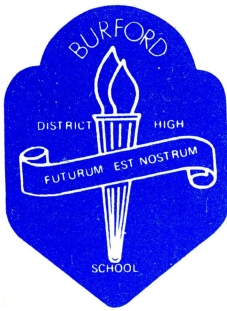
Dear Mr. Phillips:
