Dear Mr. Raddall,



Mitchell was introduced to business while travelling with his father on buying trips to New York and Montreal and to the various family owned fur operations in Eastern Canada. This training in the fur and fashion industry of the 1960's gave Mitchell a flair for showmanship and promotion.


Mitchell traded fashionshows for theatre productions and eventually this led to a Bachelor of Fine Arts degree from Concordia University in Montreal.

Principle acting roles in nearly two dozen theatre productions were followed by two positions as an associate producer of theatre production companies.

Mitchell returned to the fur trade and Nova Scotia to re-establish the family fur business. This operation grew to three fashion and fur businesses. These operations were turned over to family members to allow Mitchell to return to the entertainment industry.

Mitchell worked in 1987 as the Assistant to the Executive Producer on four films produced by Astal-Bellvue Films. He also served as director and co-ordinator of promotional packaging with Lorimar Pictures on eight films.

Most recently Mitchell has established Highland Wave Productions with his partner Richard Crouse. This company is committed to producing films that are Canadian in nature but with international appeal.

Crouse was raised and educated in Nova Scotia. While living on the South Shore of N.S., he worked in many forms of media. Involvement with several drama associations lead to extensive regional television work. After a stint as a disc jockey/news announcer, Crouse left Nova Scotia for Toronto.

Crouse has recently completed a book, which is currently under consideration by a Canadian publisher.
