Dear Elisabeth:

I am thinking ahead to future issues of our G.E.A. publication, The Whole Earth Papers and would like to invite you to do a monograph for us on The Law of the Seas - how far it has come and where it still needs to go.

I am thinking of something that would have mass appeal as well as communicating to academics. Thus, your personal feelings, experiences, insights could enter into it as well as your critical assessment of the progress to date and what still needs to be done and what is feasible in the near and long range future.

Your appreciation for the beauty and value of the seas, so beautifully expressed in Oceans would be important to include, as would mention of your early work in formulating your thoughts on an Oceans Regime and a summary of the history of law of the seas efforts.

Our readers range from university professors to church leaders to general folks. Some are well informed and some just awakening in their concern and seeking a sense of direction.

Monographs published in our series are receiving wide attention. Some church groups and teachers place bulk orders. For instance, a religious congregation of women just ordered 400 copies of our last issue, Christian Voices on World Order, to use in discussions seeking a sense of direction for their religious order. A Protestant women's organization is sending 2,000 copies of Women and World Order to their membership.

I realize your schedule may be busy and therefore would be doubly appreciative if you can do this monograph.





Dear Mrs. Mann-Borgese:

GEO Magazine in Hamburg, Germany, has agreed to commission you to write a 5,000 to 6,000-word article on the subject of "aquaculture". GEO agrees to pay you \$3,000 upon delivery of the article in form acceptable to GEO. Should the editors not find the article finally acceptable for publication, however, then in lieu of the fee, GEO agrees to pay you a guaranteed minimum fee, or "kill fee", in the amount of \$1,000.

As we agreed verbally we shall pay you the \$1,000 immediately. But please allow for some time before the money reaches you. Our accounting department is computerized - and you probably know what that means. But the request is in.

As I mentioned to you before, you are not required to adjust your article to the needs of the photographer. I just asked you for some assistance in order to facilitate the photographer's task. For his photos will have to hang together with your story. Our photo editor, Ms. Elisabeth Biondi, might have to call you again in regard to that problem.

When writing please bear in mind that there should be a "roter Faden" connecting the various aspects of "aquaculture" that you mentioned in your outline. I think you explained this point quite lucidly in your chapter two of your book and then again in chapter 13 (which was the original chapter 14): that aquaculture is a possible means of expanding the food resources of the Third World if we just pooled our resources, that the possibilities of expanding aquaculture for all practical purposes are unlimited, that the production could be doubled in ten years, that the protein yield per work hour is much higher than in the case of meat etc.

I shall be back from my vacation at the end of September. Please feel free to get in touch with me then if you have any further questions.

In the meantime, Lore Arnold will be glad to help you if there are immediate problems.

May I add that I am very much looking forward to the article.
