
Dear Dale:

Dear Dr. Kaplan:

Mrs. Elizabeth Mann Borgese, through a common friend, Lord Ritchie Calder has suggested that I contact you for advice and suggestions in my attempt to join the World Health Organization (WHO).

I am an Italian citizen and for several years I have lived and worked in the United States. A brief sketch of my training is as follows: I took my doctoral degree in 1963 in Biological Sciences at the University of Florence (Italy), except for two years when I went back to Italy at the Istituto Nazionale Tumori (Milan). I have worked in bio-medical research in several American universities (University of Rochester, Rockefeller University, New York University). At the moment, I am at the Sloan-Kettering Institute for Cancer Research where I am involved in collaborative as well as independent studies in somatic cell genetics. My own research project is aimed at establishing whether or not the human X-chromosome is involved in the regulation of immunoglobulin synthesis. To carry on my studies I have received a 3-year grant from the National Institutes of Health (NIH) starting this year.

My previous experience has involved isolation and characterization of human enteric viruses, immune response at the cellular level of group A streptococci (this study was connected with rheumatic fever), clinical laboratory tests, and some teaching. My experience has also extended to the organization of laboratories for clinical or basic research. I am single therefore free from family obligations. My present situation would thus place me at complete disposal of the work and of the organization.

The reason I am anxious to be associated with WHO is, above all, because the WHO is an international organization which might find use and value of my 10-year experience in bio-medical research for projects connected with public health. The basic motivation which impels me toward a different professional direction lies in my desire to do a kind of work which promises to give me a feeling of greater accomplishment, in a sense of self-fulfillment.

I would like to take this opportunity to wish you, as well as your organization, greater success in your worthy cause throughout 1975 and the coming years.

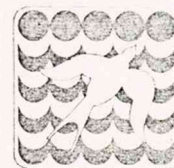

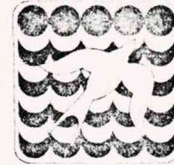

Your Eminence,

It was a great pleasure and a great honor to share your company in Guanajuato and on the plane.

May I come back once more to one of the topics we touched on during those conversations, one which is particularly close to my heart?

I am deeply concerned that the next session of the Law of the Sea Conference may end up in a fiasco. Scholarly journals in this country already publish articles pointing out that for the U.S. it will be more advantageous to have no treaty at all. There is a danger that the developing nations will be deeply split over territorial issues and if one adds to these internal difficulties the external ones -- arising from the crisis of the United Nations which may reach a climax by next winter -- it is enough to discourage even the most lion-hearted.

The fact is that there is nobody at the Conference who speaks in the name of humanity, who speaks, not out of self-interest, but in the name of justice. Nobody, for whom the New International Economic Order is not merely a slogan.

And yet, if there were only one State, even the smallest, whose representative would speak up in these terms, it might well change the fate of the Conference, which came into being, after all, just because there was one man, Arvid Pardo, representing the second-smallest member of the U.N. Malta. Due to the unfortunate rift between Pardo and Dom Mintoff, Malta has lost this voice and the world has lost Malta.

The Delegation of the Holy See made one or two nice, broad statements in Caracas but was very quiet in Geneva. If the Delegation could prepare a strong position for New York, it might be consequential indeed.

The Holy See need not go into controversies on which its faithful are divided. The Holy See could approach the problem from a highly constructive and positive point of view -- the building of the new international economic order in the oceans. One could indeed build a strong case on linking this new order to Pacem in Terris and Populorum Progressio.
