back again, after a very very busy and fruitful summer. Malta went over very well indeed. I am just finishing the proceedings. A lot of quite solid, quite original, and quite constructive material.

Also, work on the world communities is proceeding. I am sending to you today a copy of the most recent issue of the Center Magazine, with an outline of what the World Communities might look like. This, I think, or something like this (the editor has chopped up the first part rather badly) would be the conclusion of the first part of the book. The first part would deal mostly with the ocean regime. The second part would deal with the other communities. Actually, it seems to me, the first part would make a book of about 300 pages -- and could be ready very very soon. I have a hell of a lot of material. The second part would make a second volume of about 300 pages, which, as you can see from the article, if it is going to be any good, takes more time.

In a few days I am going to send you the Pacem in Maribus 2 proceedings, for which I wrote five introductory sections. Much of this material, of the two Convocations, will of course be used for the book.

It is a hell of a lot of work.

Shall be in New York on September 29-30, hoping to see you.

Another matter: Here is one of MANY letters we keep getting about Ascent of Woman. If anything could be done to make this book available again, it would be nice indeed.
