## Alumni and Dalhousie honor Dr. and Mrs. Hicks

Dalhousie University and its alumni set aside the weekend of October 17 to honor Dr. Henry D. Hicks, President Emeritus of Dalhousie University, and Mrs. Hicks.

The gala weekend officially opened at the university's fall convocation on Friday afternoon. Honorary degrees were conferred on Dr. & Mrs. Hicks.

In the university citation, **Mrs. Hicks, B.A. '47, M.A. '49**, was honored for her contributions in the field of teaching and teaching organizations. Mrs. Hicks became the first woman president of the Nova Scotia Teacher's Union in 1958-59. A fellow of the Canadian College of Teachers, she represented the Canadian Teachers' Federation at meetings of the World Conference of the Teaching Profession in Frankfurt in 1958 and Amsterdam in 1960. She was one of three members of a delegation from the Canadian Teachers' Federation to visit the U.S.S.R. in 1960 as guests of the Scientific and Educational Workers of the Soviet Union.

Married to Henry D. Hicks in 1965, Gene Hicks continued her educational career as the "gracious and lively consort" of Dalhousie's President.

For her contribution to the teaching profession and her role at Dalhousie for the past 15 years, the degree of Doctor of Laws, honoris causa was conferred on Gene MacGregor Morison Hicks.

**Dr. Henry Davies Hicks B.Sc. '37** was presented as "Rhodes Scholar, lawyer, provincial premier, Senator, United Nations delegate, philatelist, fisherman bon vivant, and for 17 years President of Dalhousie University".

It is for the latter that alumni best know Dr. Hicks.

Under his leadership, Dalhousie became a modern university. Facilities of Health Professions and of Administrative Studies were formed, graduate studies and research increased, as did doctoral programs. New facilities were provided for chemistry, the Life Sciences, medicine, pharmacy, law and the Killam Library. The Dental School expansion, the Archives building and the former College of Art will soon add to Dalhousie's academic space. During his presidency, both Shirreff Hall and Howe Hall expanded and several apartment buildings were acquired, making Dalhousie a more residential community. The quality of life within the university

has changed due to the programmes in the Student Union Building, the Arts Centre, Faculty Club and DALPLEX, all provided during the Hicks era.

Still active in Canadian politics, Dr. Hicks is a member of the Canadian Senate.

Dr. Hicks has also served as president of the Canadian Commission to Unesco, the Canadian Bible-Society and as a delegate to the United Nations 28th General Assembly. He has been a member of the Canada Council and has served frequently as a Director of the Association of Universities & Colleges of Canada. Dr. Hicks also served on the Board of Governors of the University of Guyana. He holds honorary degrees from Université de Ste. Anne, University of King's College, Mount Allison University, the University of New Brunswick and Acadia University. He was invested as a companion of the Order of Canada in 1970.

For his political career and above all, his service to Dalhousie, the degree of Doctor of Laws, honoris causa was conferred to Henry Davies Hicks.

Convocation was followed Friday night by a jazz concert sponsored by the Alumni Association. Drs. Hicks, their family, friends and alumni enjoyed the spirited Heritage Hall Jazz Band. The concert was followed by an on-stage party with the band.

On Saturday, a testimonial dinner was held in the McInnes Room with over 500 invited guests. During the evening, the university was presented with a portrait of Dr. Hicks to be hung in the Board and Senate Room alongside other Dalhousie Presidents. Drs. Hicks were also presented with a landscape painting of the campus.

A special attraction was a 20 minute film and slide presentation of Dr. Hicks' years at Dalhousie. He was then presented with a hard cover book of the movie "A Man for Dalhousie".

During the weekend, sports teams competed in the Dr. Henry D. Hicks' Sports Festival. The winning team was presented with HDH sweatshirts and the HDH Team Championship Trophy.

## L. Robert (Robbie) Shaw appointed Vice-President

**Robert (Robbie) Shaw LL.B '66** took over the office of Vice-President (administration and finance) at Dalhousie on September 1. Mr. Shaw succeeds Professor Louis G. Vagianos who is continuing his association with Dalhousie as an advisor to the Office of the President while serving as director of the Institute for Research on Public Policy.

A native of Halifax, Mr. Shaw was director of consultation and co-ordination with the federal Department of Economic Development for the past year.

Mr. Shaw obtained his B.A. in 1963 from Queen's University and his LL.B in 1966 from Dalhousie. From 1966 to 1969 he was assistant to the general manager of Halifax Development Ltd., developer of Halifax's Scotia Square, and from 1970 to 1975 was president, general manager and director of Clayton Developments Ltd., which built Clayton Park in the suburbs of Halifax.

In 1976 Mr. Shaw became principal assistant to Premier Gerald Regan of Nova Scotia, a position that involved the development of senior management personnel policies, classification, and selection of senior management, and the administration of the Office of the Premier.

As director of consultation and co-ordination with the Department of Economic Development, Mr. Shaw was responsible for the creation and operation of a comprehensive consultative process to enable the Government of Canada to communicate with business, labour and the provincial governments on economic development policy, strategy and programs. He is a member of the ministry's management committee and of a number of interdepartmental task forces and committees.

While a student at Dalhousie, Mr. Shaw was active in campus and national student associations, and was president of the Student Union.

He has been a member of the Nova Scotia Advisory Board of the Royal Trust Company, a director of Artec Mortgage

Company, president of the Urban Development Institute of Canada, a member of the executive committee of the Housing and Urban Development Association of Canada (HUDAC), president of HUDAC Nova Scotia, vice-chairman of the Resources Development Board of Nova Scotia, a director and trustee of the Institute for Research on Public Policy, and a member of the executive committee of the Waterfront Development Corporation, Halifax.

Mr. Shaw is now a member of the Board of Trustees of Queen's University and its executive and building committees, and a director of L.E. Shaw Investments Ltd. He has also been active in community affairs, as president of the John Howard Society of Nova Scotia, treasurer of the Atlantic Symphony Orchestra, vice-president of Halifax YMCA and Chairman of the Halifax YMCA Advisory Board.

At Dalhousie, Mr. Shaw will be responsible to the president for administrative, personnel, financial, physical plant and other services supporting the academic and research programs.

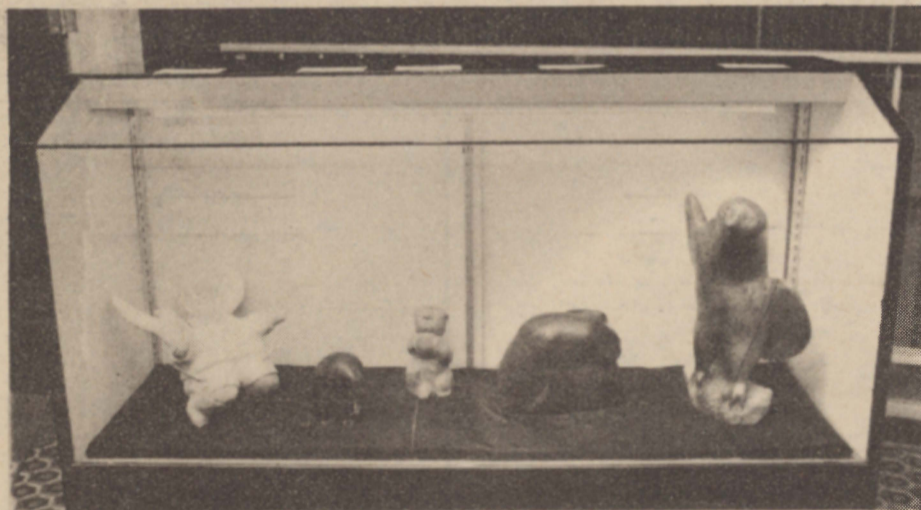

## Prof. C. L. Bennet Dies

News of Professor Bennet's death on July 23 greatly saddened many Dalhousie alumni who graduated in the '20's through the '60's.

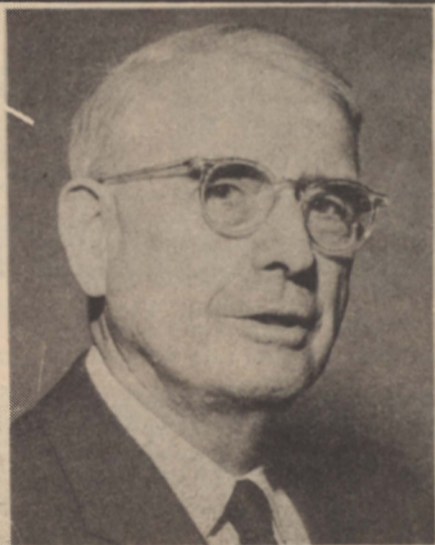
Dr. Bennet was born in New Zealand and received his early education there. Dr. Bennet studied at the Jesus College of Cambridge University and graduated with a Master of Arts degree.

He came to Halifax in 1921 and taught first at King's College and later at Dalhousie. During those years he received his M.A. from Harvard.

In his early years at Dalhousie, Professor Bennet worked under Archie MacMachan and succeeded him as the George Munro Professor of English and head of the department.

While at Dalhousie, Dr. Bennet served in many capacities at various times, including registrar, veterans' advisor, Dean of Graduate Studies, Secretary of the Senate and editor of the Dalhousie Review. He was the first person to be appointed University Vice-President in 1958.

Dr. Bennet was editor of the Canadian Books of Prose and Verse which were used for over 20 years by Nova Scotia schools. He was co-author of the Face of Canada (Harrap 1959) and was always in demand as an adjudicator, critic and advisor.

At Dalhousie, his special fields were Shakespeare, Milton and Carlyle. His English IX class is remembered by many Dalhousie graduates for the evenings of dramatic readings staged in the living room of Dr. Bennet's Dalhousie Street home.

In 1964, Professor Bennet was awarded honorary degrees from King's College, a D.C.L. and Dalhousie University an LL.D.

A favorite and most respected friend of Dalhousie students, Professor Bennet was named Honorary Life President of many graduating classes.

At the time of his death, he was on the Dalhousie faculty list as Professor Emeritus.

## Shaw addresses student leaders

Students should be "more aggressive"

Dalhousie students are not as active in university affairs as they should be. That was the view expressed by Robbie Shaw, Vice-President (administration) in his keynote address at a **Student Leadership Conference** held in the Student Union Building on November 1. The Conference was the second of its kind sponsored by the Dalhousie Alumni Association.

Mr. Shaw compared Dalhousie students with those at Queen's University, of which he is a member of the Board of Governors, saying that "students there are generally more aggressive."

Shaw said that he "would love to be proven wrong," and that he was, in a sense, "issuing a challenge" to Dalhousie students.

A former student union president himself (1966), Shaw gave the students at the conference, all representatives of various clubs and societies on campus, some advice about their involvement.

"I'm not suggesting radicalism," he said, "but students can play a bolder, more aggressive role than they do."

First, students should have the representation. Mr. Shaw harkened back to his days in the student council, when student representation was rare and was not considered as essential as it is today. "Dr. Hicks was the forefront of the movement towards student representation on decision-making bodies," he said.

"Students should be at the meetings they say they'll be at and they should express their opinions — politely."

"It is not good to be shy to speak up just because the others at the table may know more than you do. Frequently the student's perspective is the most important thing said in the room. Students have as good a perspective as anyone in the

community."

Students should be more aggressive about their representation. "I could sit in my office for a year without seeing a student! Shaw observed. "I agree that the administration should try and get out, but I suggest also that it's a two-way street."

Shaw said that people who were active in student government frequently ended up in leadership positions later in life. "Involvement in student government is a valuable one", he said. "The regular participants in activities are gaining in self-confidence just by that very participation. They are thereby preparing themselves to contribute to society in some more effective way."

"This conference indicates the Alumni Association's broader interest (more than just looking for financial contributions) in students and their better understanding of the general operation of Dal," said Shaw.

Vice-President Shaw went on to assure students that the administration is interested in hearing the student's side. "The President's Office is accessible to students in general and student leaders in particular. If we're too busy to talk to students, something is drastically wrong."

The Conference was designed by the Alumni Association for the first time last year to help students better understand their roles and responsibilities as student leaders.

Sessions were held in administration, finance, programming, promotion, S.U.B. operations and legal aspects.

Panelists were drawn from the Alumni Association membership, past student union executives and S.U.B. staff.

The continuing success of the Conference has ensured that it will be an annual alumni/student event.

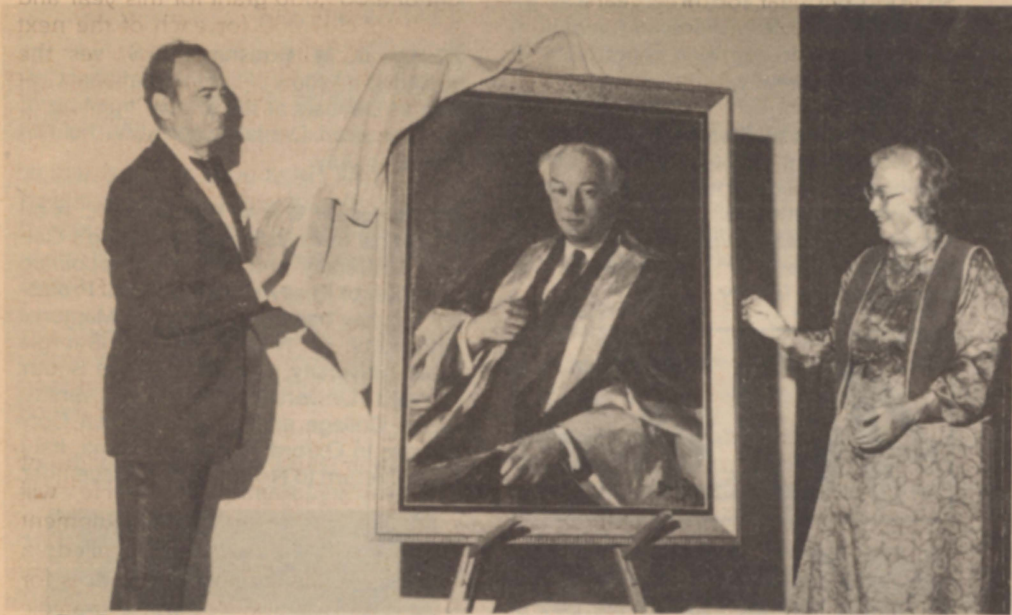

Their careers are as interesting and are too varied and world wide to relate here. This is evidenced by saying that of twenty-seven who graduated in 1936 only six stayed in Nova Scotia — three of these being still alive in Cape Breton — it must be a healthy climate there.

It must have been healthier in Cape Breton than in medicine at Dalhousie in 1931, for only twenty-three of the original forty-eight who enrolled back then graduated in the class. There were six others who came by transfer from other classes and universities. In other words, twenty-five of our originals did not make it on schedule to enter the field of medicine in the depths of the depression, but we were conditioned for the rigors of those years by Dalhousie Medical Centre.

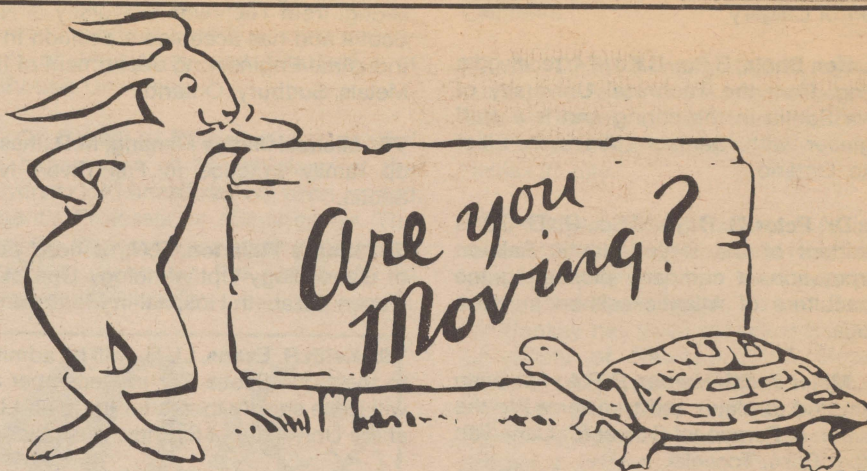
