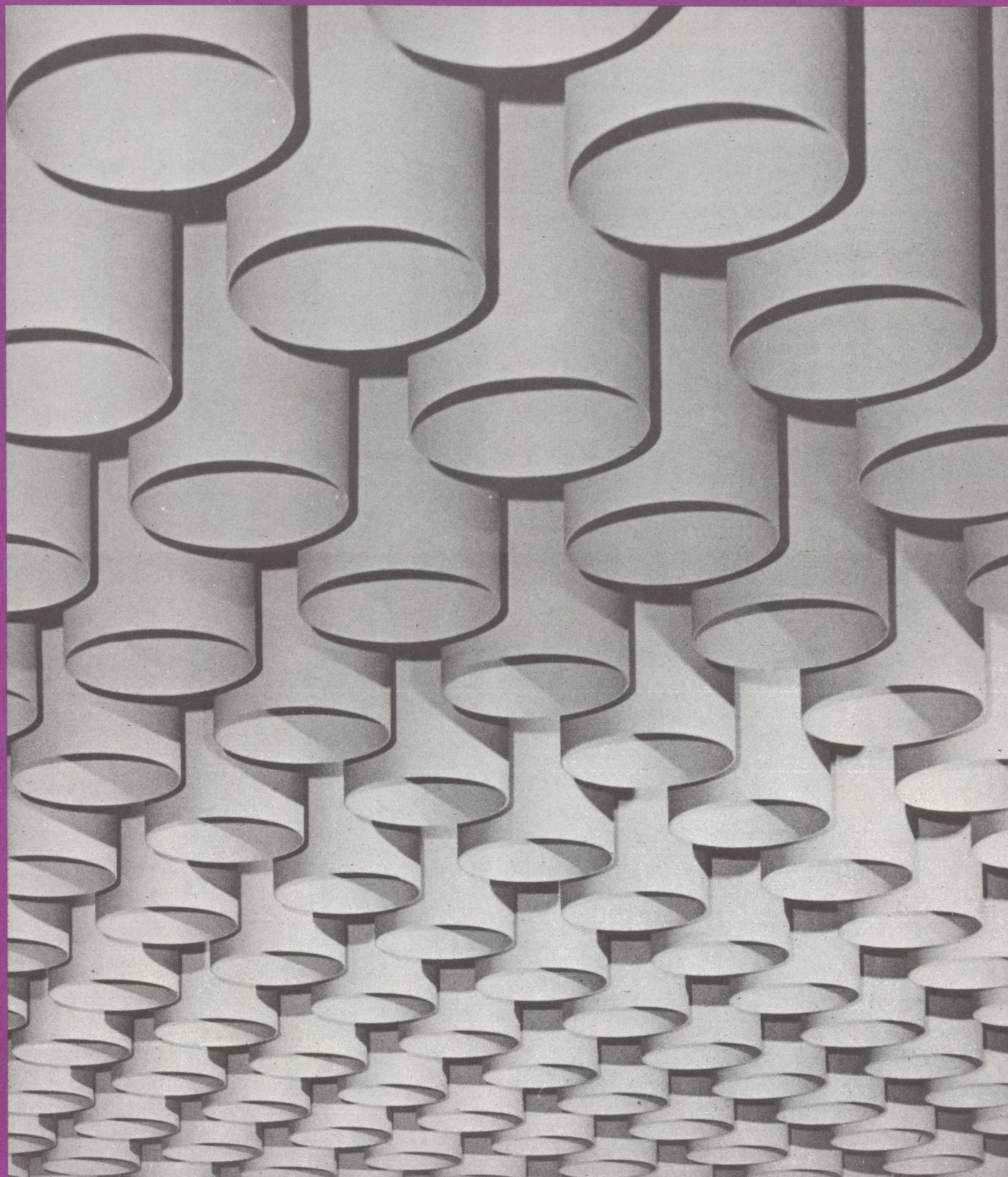

Dalhousie University, Halifax, Canada

Many changes and an accelerated rate of change have taken place during recent years in the life of the university and in its alumni. Student enrollment has increased greatly and this year's graduating class of 1355 is equal to the entire enrollment of Dalhousie just fifteen years ago and represents approximately 9% of our total alumni population of 15,000.

As a result, there has been a marked drop in the median age. The focus of alumni activity is gradually shifting away from social events and nostalgia towards an increased interest in symposia, seminars and serious questions of university administration. Among other things it has been suggested that alumni representatives play a greater role in the governing of the university. Recognizing these changes your alumni board has decided that a thorough review of our program should be undertaken and long range plans developed.

We, as "alumni" are "life members" of the university community and with this membership comes both a right and a responsibility from which flow certain privileges as well as opportunities for service. The participation of alumni is essential to the university's development whether it be as a human resource of experience and enthusiasm or as a financial resource. There is an immense potential for increased involvement of alumni in the ongoing life of Dalhousie and I personally would like to see an extended alumni involvement, heightened alumni awareness and an improved alumni-undergraduate relationship. To do this we need to know what you as an alumnus want and what role you feel our alumni body can and should play in the support and shaping of Dalhousie University.

Annual Meeting

Five past Honorary Presidents were made Honorary Life Members of the Dalhousie Alumni Association at the Annual Meeting held in the McInnes Room of the Student Union Building on Monday, May 8, 1972. Special guests at the meeting were representatives of the graduating class of 1972 and members of the Reunion Classes of 1922, 1932 and 1947. The Association had also invited all its living honorary presidents to be present and receive an honorary life membership in the Association.

The President, Dr. Edwin F. Ross, stated in his report that

- considerable time had been spent in the past year revising the By-laws;
- the brief which had been presented to the Senate Committee on University Government had still to be acted upon;
- a brief had been submitted to the Task Force on the Quality of Student life;
- representatives had been named to various athletic boards from the Association;
- a dinner meeting with the Council of Students had been held in the fall;
- an Open House had been held in the Life Sciences Building;
- despite a blizzard a highly successful evening in the Arts Centre had been held in February;
- prizes had been awarded from the Association for snow sculpture and debating;
- The Young Alumni Club, organized within the framework of the parent association, had proven its value and had been well supported.

The President of the Women's Division, Mrs. R. E. Weatherston, reported as follows:

- the Coffee Party and Sale, held in November, realized net proceeds in excess of \$1,000;
- The Alumnae Friendship Program met with mild success:

Mr. H. Larry Doane, Treasurer, stated that the Association had a total revenue of \$26,799.07 in grants from the University and expenditures of \$18,844.29 leaving a surplus of \$7,954.78. The Association holds investments of \$8,200.00.

Dr. H. Ian MacGregor, President of the Medical Alumni, reported that

- The Annual Meeting of the Association was held on November 23, 1971, and took the form of a reception and buffet in the Faculty Lounge of the Sir Charles Tupper Medical Building;
- Dr. C. J. Beckwith was named Alumnus of the year and Dr. Daniel F. MacInnis was named Honorary President. The Medical Alumni Association presented \$2,000 to the Medical School on behalf of Dr. Beckwith;
- MEDAL was published in February and was well received by the membership;

Mrs. Brian Crocker and Mr. Ted Brown reported on behalf of the Young Alumni Club. The Club sponsored four social evenings this year, plus a night devoted to the *Art of Making Wine* and a night in attendance at Neptune's Second Stage.

Mr. Bruce Irwin, Director of Alumni Affairs, stated that — the alumni population is rapidly approaching 15,000 and we are presently processing more than 3,000 address changes each year. The task of tracking down "lost" alumni goes on continually;

— the Alumni Office is also responsible for administering several University fund raising programs, including DALHORIZONS and the Annual Fund. For the past two years, during the height of the appeal phase of DALHORIZONS solicitations for the Annual Fund were restricted to one per year. DALHORIZONS has now reached the \$7,000,000 mark and while the campaign is continuing, the alumni phase has been completed and the Annual Fund has been reactivated;

— The Association has branches in many areas and last year meetings were held in New York, Toronto, Ottawa, St. John's, Truro and in London, where the Queen Mother was guest of honour at a Dalhousie Club of Great Britain luncheon;

— The Alumni News presents some problems — there has been trouble meeting deadlines and the cost of printing and postage keeps rising. Printers have been changed and there are plans for design changes.

ALUMNI ASSOCIATION BY-LAWS ADOPTED

The Annual Meeting of the Alumni Association adopted a new set of by-laws for the Association. The major change from the previous by-laws is a clause which now defines a member of the Association as any person who has attended Dalhousie for one year or who has a degree from the University. This means that a graduate who returns to Dalhousie for a further degree is an alumnus. Other changes dealt with administrative procedures at the board level and the distribution of ballots. All alumni who make a financial contribution to the University will receive ballots as of right — other alumni may voice upon making a request to the Alumni Office for a ballot.

NEW BRANCH FORMED IN SOUTHERN CALIFORNIA

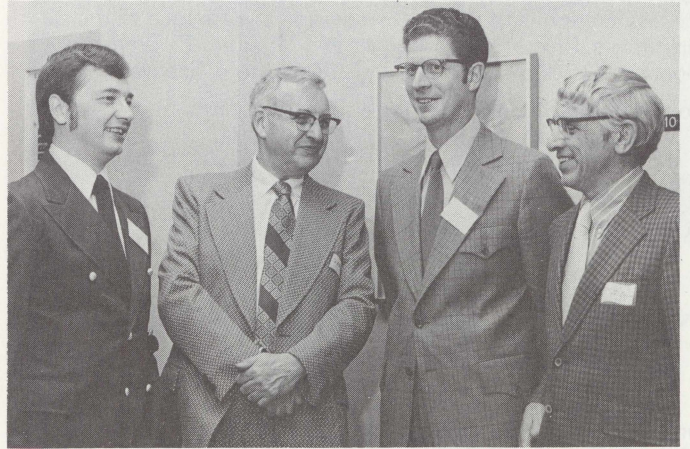
BRANCHES MEET IN TRURO, OTTAWA AND TORONTO

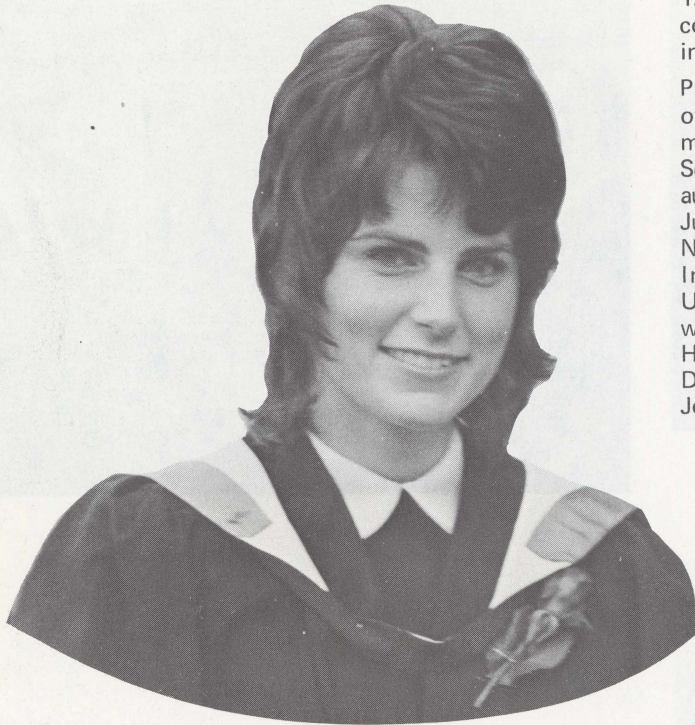

1218 degrees, 137 diplomas and nine honorary degrees were conferred by Dalhousie University at convocation ceremonies in May and June. The honorary degrees went to:

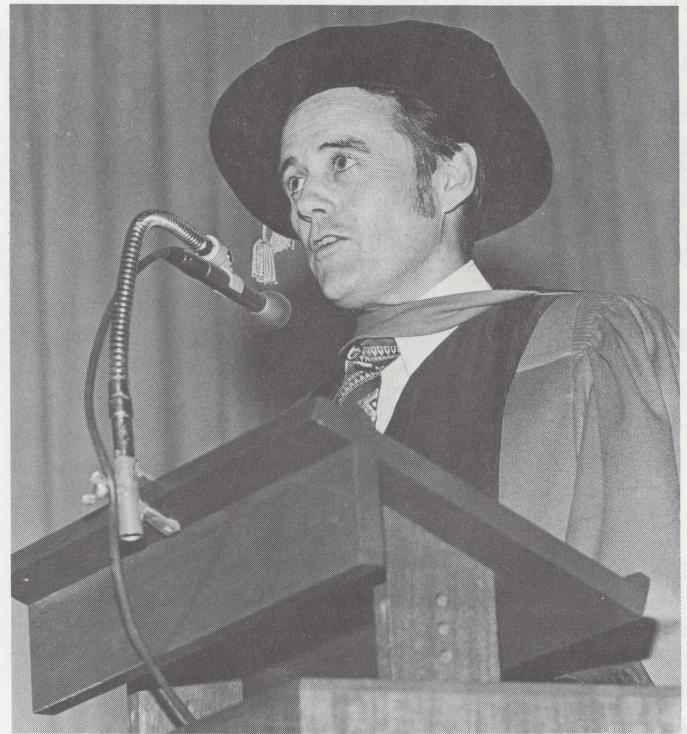

In keeping with Dalhousie tradition for convocation day, the sun was shining on May 11th. It eventually melted the eighteen inches of snow that had fallen the night before.

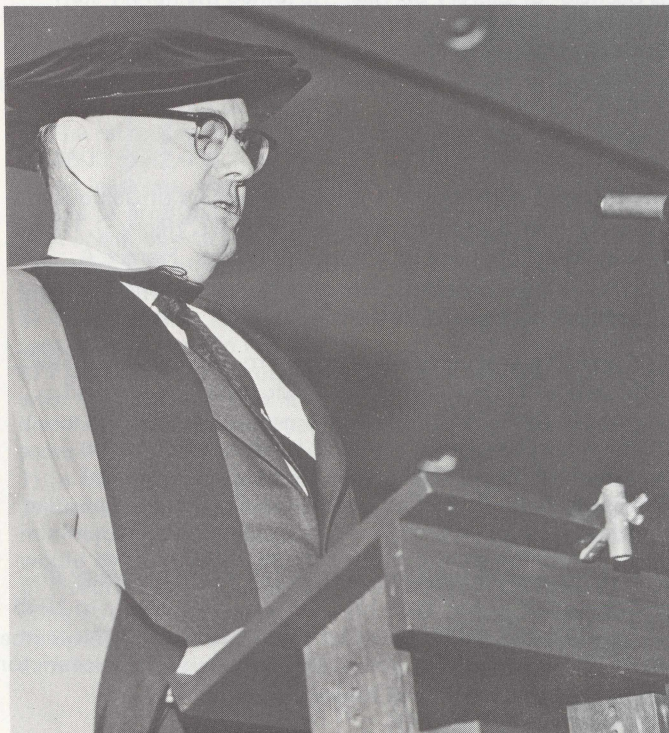




It was Jim Stoker's farewell. He joined the staff of Dalhousie in September 1930 and retires at the end of June.

Campus Notes

Three former members of the opera workshop of the Department of Music at Dalhousie University have won awards for their achievements in voice studies.

Sheila Brand of Truro and Lynn Channing of St. John's, Nfld. have both won Canada Council awards and Gregory Servant, Halifax, has won a Jarvis award for outstanding performance in the opera department at Hartt College of Music. All three were graduate students of Professor Philip May, voice professor at Dalhousie.

Lynn Channing will continue her studies in London and will tour with the Glyndborne Opera this fall. Sheila Brand will continue studies at the London Opera Centre, London, and Gregory Servant will be completing his master's degree at the University of Hartford, Conn.



The establishment of an Institute of Environmental Studies has been approved in principle by the Dalhousie University Senate. Dr. Hicks noted, when making the announcement, that considerable detail had to be worked out before the institute would become operational.

The institute will bring together resources already existing in the scientific, social and legal areas of the university. The institute is intended to be open-ended and may in future involve other universities, or components of research laboratories, municipal bodies or private firms.

The main function of the institute is that of bringing people together to deal with specific problems of the environment on an interdisciplinary basis. The institute is to serve as a forum for communication between professors and their students in a broad socio-scientific area. In practice, students are likely to offer specialization in a specific area with enough background in other areas to permit communication and understanding.

Pending completion of further details on the program, the institute would offer degrees in Environmental Studies at both the Masters and PhD level.

Chairman of the faculty committee which recommended the establishment of the Institute was Dr. F. R. Hayes of Dalhousie's Biology Department. The main reason for recommending the institute, said Dr. Hayes, "is to offer improved opportunities to students to understand as fully as possible every aspect of the man-environment system."



The appointment of M. Doreen E. Fraser as regional health sciences librarian in the division of continuing medical education at Dalhousie University has been announced. Miss Fraser has been the medical librarian at Dalhousie since 1961, and after July 1 will join the faculty of the University's School of Library

Science to institute a teaching program that relates health sciences to library services.

Miss Fraser was instrumental in building up one of the outstanding health sciences library collections in Canada and in providing library services for a greatly increased population of physicians, dentists, nurses, pharmacists, physiotherapists and other health personnel and students at Dalhousie.



Dr. D. E. Ryan, chairman of the department of chemistry, Dalhousie University, has been chosen by the Chemical Institute of Canada for the 1972 Fisher Scientific Lecture Award. The award is presented for distinguished contributions to and leadership in analytical chemistry. He has been chairman of the Chemistry Department since 1928 and has recently been appointed director of the Trace Analysis Research Centre at the University, for which the chemistry department received a \$359,000 National Research Council grant earlier this year.



Alan H. MacDonald has been appointed acting medical librarian at Dalhousie, and will be responsible for the supervision and administration of the staff and services of the W. K. Kellogg Health Sciences Library in the Sir Charles Tupper Medical Building. He was born in Ottawa, attended St. Patrick's High School in Halifax and graduated from Dalhousie with his BA and the University of Toronto with his Bachelor of Library Service. He joined the library staff at Dalhousie in 1964, and has served in many capacities within the University Library system, including two years as law librarian. He is at present an assistant university librarian.



Three appointments to the Board of Governors of Dalhousie University have been announced today by Dr. Henry D. Hicks, the president. They are Dr. Charles R. Baxter, Horace A. Hanson, Q.C., and J. Harold Stafford of the Canadian Labor Congress, all of New Brunswick.

Dr. Baxter was graduated in medicine from Dalhousie in 1925. Since then he has been practising in Moncton. A certified member of the Royal College of Surgeons (Canada) and a Fellow of the American College of Surgeons, he has also served as regional medical officer for the Department of Transport. During World War 1 he served with the Canadian Air Force.

Mr. Hanson was graduated with a BA from the University of New Brunswick and in 1935 his LLB from Dalhousie. In 1945 he was appointed city solicitor for Fredericton and in November, 1953, was appointed Q. C. He is practising with the Fredericton firm of Hanson, Gilbert and Hashey.

Mr. Stafford, regional director of education for the Canadian Labor Congress, is a member of the boards of Saint John General Hospital, Saint John Library, and several other organizations.

He worked closely with the formation of the Dalhousie and St. Francis Xavier labour university education committees, the labor education advisory committee at Memorial University and the University of New Brunswick's industrial relations committee.

Both Mr. Hanson and Mr. Stafford served during World War II — Mr. Hanson with a medical unit and Mr. Stafford with the Royal Canadian Engineers, in Canada and overseas.



After being kicked around for almost two months, the Dalhousie football situation has come down to earth and a revitalized program for the next academic year is almost a certainty.

The University's Sport and Recreation Council agreed to 11 proposals presented on behalf of the football team, which the players feel will put the sport on a more solid base and make the university more competitive.

Based on the 22 players' original demands, the sanction by the council may not have been a total victory, as originally outlined, but it certainly amounted to a major score. "We are quite pleased with what has taken place," said Rick Rivers, team spokesman and quarterback after Tuesday's meeting.

The proposals based by the council are:

- 1) The football team be allotted five 1½ hour practice sessions a week on the main field during prime time. (Prime time being between 6 and 8 p.m.)
- 2) The recruiting budget for the football coach be increased by \$800 to \$2,000.
- 3) At least one, and possibly two, pre-season games of good calibre be arranged each year.
- 4) A coach of proven competency be hired as soon as possible. The team will accept a dual role of co-ordinator of men's intercollegiate athletics and head football coach.
- 5) Two part-time assistant coaches be hired, devoting 25 per cent of their time to football.
- 6) Football camp be continued on the same basis as in the past with the exception that meals after football camp be discontinued but the money from these meals be funnelled into some other aspect of football. (This would approximate \$1,000).
- 7) In faculties of unlimited enrolment, special efforts be made to have quick decisions made and early acceptance given, if the minimum academic requirements are met. Such students would be expected to maintain their averages.
- 8) Reconsideration of the administrative structure for competitive athletics.
- 9) Special consideration for student athletes in the area of campus employment opportunities.

10) Consideration be given to rescheduling labs to 1:45 p.m. from 4:45 p.m.

11) Twenty spaces in residences be reserved for students who make a contribution to the total university life other than academic.

Al Yarr, associate professor in the School of Physical Education and basketball coach, said: "All teams here are sharing a certain pie — I don't think that any team should be given a special status so that they get whatever they want — everyone should get a chance to compete and develop without special status."

Rivers replied that the football players were not seeking special status but only "minimum requirements" to be competitive.

Tony Richards, also on the phys ed staff and university soccer coach said: "I don't feel that any team should be prepared to take less than they got last year." He expressed a fear that budgets for other sports might be cut if a greater emphasis was placed on football.

Council chairman MacKay stressed that "with faith on both sides we can come to a reasonable happy conclusion."

He said that he, personally, felt that football was important at Dalhousie and the question of its continuance" depends on our capacity to mobilize our resources and support coupled with the willingness and the faith of the players to continue."

He said he appreciated that way in which the matter was brought forward by the players. Congratulating Rivers and the other footballers he said, "You spent a great deal of time on it and did a first rate job."

The first prospective football coach is expected on campus today and to meet with representatives from the administration and the football team.

Following the meeting, team co-captain Bud Snow said: "Our whole concern was not prompted by selfish motives — we will certainly benefit by an increased emphasis on football, but our main thoughts are for the students athletes who will come to Dalhousie after we are gone."

The proposals may be somewhat less than the total commitment asked for by the football team, but the feeling of the players is that the compromises should put the Tigers in a new light next season.

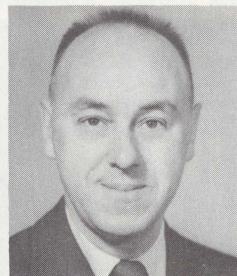
