Dear Ting:

Further to my letter of May 9, 1989, I am now returning Chapters 3, 4, 5, the Conclusion, and the Notes to those materials.

Please make the corrections as quickly as possible and plan on sending everything back to me by the second week in June at the latest. You should also keep a copy for yourself in Vancouver and, probably, an additional copy for Professor Christine Boyle, who is visiting at Simon Fraser University, School of Criminology, and who will probably serve as one of the co-readers.

Please pay attention to the following matters:

- 1) When you cite Conventions, Treaties, Declarations and other official documents, you must cite to the League and U.N. Treaty Series and other official sources not, for example, to N.K. Henever. From time to time you can use Brownlee's documents for convenience sake. For heaven's sake learn to spell and be consistent in your spelling of "the Women's Convention". And please be consistent in referring to the dating of the Declaration: in some places you use 1969; in other cases 1976.
- 2) In Chapter 5, page 1, you only go up to 1987. What is the situation now, in 1989?
- 3) In Note 63 to Chapter 5 you refer to an article by Imbert but you should also refer to his longer article on the same subject in the I.C.L.Q.
- 4) Remember that you must prepare an Abstract, that the bibliography goes at the end, and that the pages must be

numbered sequentially from one to the end.

5) Be sure to check all your headings in the text of the thesis to ensure that they are consistent with the headings in the Table of Contents.

6) The conclusion needs to be strengthened in substance and improved in style. It seems to me that after working on this subject for three years that you should be able to think of a little more to say by way of conclusion.

7) Finally, the title page should be centered in plain bold type, not as the heading stands at present.

I do hope that you have someone on site here at Dalhousie who will attend to last minute details on your behalf, such as arranging for the requisite number of copies, delivery to the School of Graduate Studies, etc., etc. As you know, I am not in a position to undertake that task for you.

I will be out of town from May 20th until June 5th, but I would like to hear from you by telephone before my departure. I would like to send copies to the co-readers by July 1st.

I read, think and write the whole day, from morning 9 o'clock till evening 11 o'clock. Work is hard. Recently I was so busy that I became ill. But work can not be stopped, because the case is required to close by early February.

It is always difficult for doing something in the beginning and there is always difficulties in life. Old ones are overcome and new ones are coming again, no matter how smart one is. But the only thing I always keep is confidence. Now the life is still hard to me. But I do not mind and enjoy my work and life as much as possible. I believe that I will overcome the difficulties and that I am getting better and better. It is not

easy to get a chance to study abroad, in particular working in a law firm, which is the dream of many Chinese. I should take every minute learning and understanding some facts from this country. I hope in the future I can make contribution to China, and to the friendship and exchanging between China and Canada.

I plan to do my thesis in February. Though I am working in the law firm and have not started to improve it yet, I know that the most important for me is my thesis and LL.M. degree from Dalhousie Law School. Without this degree I stand to lose many things in my further life. It is sure that I will not go back to China without getting this degree. If the time is not enough, I will give up any opportunity including working for the law firm and concentrate on my thesis only, no matter how many difficulties I will meet, such as one of the biggest problem --- financial problem, which I may meet again --- in a period after practicing if I have not finished my thesis in certain time.

Vancouver is a nice city. It is warm and beautiful. Since am here I have been to the supermarket, the park, the skating ring, restaurants, taken skytrain and cable car (for getting to the top of the mountain), and joined some parties. I have already some friends. Some of them are students from U.B.C.. Some of them are persons from the law firms. Some of them are persons from Chinese consulate. They give me a lot of help and friendship.

One of the most important and interesting things to me is Asian Studies Centre in U.B.C., where they collected thousand and thousand of Chinese books written by people from Tai Wan, Hong Kong and Mainland China. Some of them discuss Chinese economics, politics, legal system and policies. Some of them give a conclusion to Chinese history, in particular Chinese Cultural Revolution. Some of them introduce Western experiences and Soviet Union's experiences on governing and managing the countries and give a comparative study between West and East. Among those books, some of them are valuable and difficult to find elsewhere. Everyday before I go to bed, I read some of them for half an hour. Those books will help me to know more about China and the world.

Maybe I will go to Ottawa and Toronto in February with Mr. Anthony M. M. Remedios for doing business. Unfortunate, I can not visit Halifax. I really miss Halifax, miss my friends there, especially you. I can not forget the past days when I stayed




