Dear Dr. Borgese,

Thank you very much for your letter dated 18th April 1985 addressed to Dr. S.Z.Qasim, in which you have raised some very important issues relating to financial responsibilities for the overseas travel and coordination of nominations and the IOI fellowships. On both these matters we have given a considerable thought. We quite appreciate the difficulties you are facing in raising funds to provide these scholarships in full - a major part of which includes travel costs for the trainees attending the IOI programmes. However, we dare say that because of our budgetary constraints, it would be impossible for us to provide financial support to the Indian participants to the IOI courses.

Regarding the suggestion for coordination of nominations and preliminary screening of the applications at the Government level, all I can say is that the IOI courses are extremely well known in India and the participation in these has become quite prestigious. Hence, if we were to short-list the names here, it would create a lot of dissatisfaction. However, if their names are eliminated from your side, they perhaps would not mind. Hence, we would suggest that the existing method of selection must continue and quite unofficially we could give you whatever help you may need from our side.


I do hope you will appreciate our practical difficulties in this matter.

Dr. Qasim is separately writing to you in regard to your other proposal as to what we can do to ensure progress in the meetings of the PREPCOM.

Thank you once again for letting us know your feelings, which will receive our utmost attention.
