

Dear Mr. Hodgson:

My colleagues at the Lester Pearson Institute at Dalhousie University showed me the report of your Foundation on the 1984 Grants which I have studied with great interest.

In cooperation with the Lester Pearson Institute, my Institute has just completed a 10-week training programme in marine resource management and conservation for civil servants from developing countries. This was one of a series of sixteen 10-week programmes which we have completed so far. Others are scheduled for the future, at Dalhousie, in Malta, and in other parts of the world, including the Peoples Republic of China and the Indian Ocean.

As a sample I am enclosing the syllabus for a programme which will start next month\$ in Yugoslavia^a.

We are an independent nongovernmental international organi-⁴sation with headquarters in Malta. We are governed by a Board of Trustees of outstanding personalities. The President of the Board is H.E. Ambassador Layachi Yaker of Algeria. Joseph Warioba, Minister of Justice and Attorney General of Tanzania; Jorge Castañeda, former Minister for Foreign Affairs of Mexico; Anton Vratusa, President of the Federal Chamber of the National Assembly of Yugoslavia are other members of the Board. Our second governing body is the Planning Council, of which I have the honor to be the chairman. It is composed of 24 outstanding scientists, diplomats, legal experts and industrial experts.

Our annual budget is around CA\$ 800,000. Almost 25 percent of this comes from CIDA, our major donor, followed by the Commonwealth Secretariat, various U.N. agencies, and Governments of States hosting our conferences or training programmes.

Our activities consist of policy research, publications (the Ocean Yearbook, published for us by the University

of Chicgo Press), Conferences (Pacem in Maribus), and training.

Our main emphasis is on North- South cooperation in ocean affairs and on working with developing countries to enable them to get the greatest benefit from the new law of the sea. We are convinced this can make a significant contribution to development and an improvement of the world food situation.

We would very much like to apply for a grant from your Foundation. If, in principle, our activities were to be of interest to you, could we perhaps discuss some concrete possibilities upon my return to Dalhousie early in September.

I am presently in Geneva attending the Third Session of the Preparatory Commission for the International Seabed Authority & the International Tribunal for the Law of the Sea.

Looking forward to hearing from you, with all good wishes,
