

Dear Mr. Sasakawa:

May I refer to our correspondence of 1987/88. In 1987 I was awarded the Sasakawa Environment Prize --which was all applied to scholarships to our training programme. That year you generously added another grant: of \$50,000 for our training programme in Beijing, China.

Our Institute has gone a long way since that time. We have done a great deal of policy research, published widely, organised four more Pacem in Maribus conferences -- among which one on shipping, ports and harbours, in Rotterdam. The publication of the proceedings of that conference, by Pergamon Press, is imminent, and I shall see to it that you will receive a copy.

Our training programmes are expanding all over the world. We have completed almost 40, and the number of our alumni is nearing 700.

The latest stage of our expansion consists in the establishment of Operational Centres in India, Colombia, Fiji and Senegal, to consolidate our regional training programmes, intensify relations with our alumni, strengthen region-specific research, and organize brief seminars with decision-makers. This development has been made possible by a grant of 2.6 million dollars by the World Bank's Global Environment Facility. The programme is to start next January.

We are now organising a second training programme in China, on the invitation of SOA. It will take place, this time, in Xiamen, at the Third Oceanographic Institution. I have just been in China and arranged all the details.

Enclosed please find the syllabus, as agreed between IOI and SOA.

We are very happy with the programme. It has a number of innovative features, such as the weekly round-tables which will involve the whole faculty of the Chinese Oceanographic Institutions; a lot of case studies, and a special programme on data management. SOA is also sending one of its research ships for a cruise for the participants.

The programme will be co-sponsored by the United Nations University.

Could we invite you to co-sponsor the programme? Could we apply, once more for a grant for scholarships? If it could be \$80,000, i.e., 50 percent of the budget, it would help us greatly.

For your information, I am enclosing also some information about our forthcoming conference in Lisbon, which is making a direct input into the UNCED process.

Pacem in Maribus XXI, in 1993, will be in Japan.

Subject: Cooperation

Dear Mr. Morishima,

Our colleague and friend, Dr. Alicia Barcena, suggested that we should get in touch with you to explore the possibilities of cooperation. Permit me to give you some very succinct information about our institute and its current projects.

The International Ocean Institute (IOI) is a nongovernmental organisation, with headquarters in Malta and an operational Centre in Canada, at Dalhousie University. Our activities consist of policy research, training, conferencing, and publications. Recently we received a quite substantial contribution from the World Bank's Global Environment Facility (GEF) which enabled us to establish four new operational centres, in Fiji (in cooperation with the in India (in cooperation with IIT), in Senegal cooperation with the Economic Commission for Africa) and in Colombia (in cooperation with the Jorge Tadeo Lozano University).

Our training programmes, designed particularly for mid-career civil servants from developing countries, are broadly interdisciplinary, covering Law of the Sea, introduction to oceanography, management of living and nonliving resources, coastal management and the management of ports and harbours, marine science policy, technology development and management, national legislation and the building of national infrastructure, regional development and cooperation, sustainable development in small islands, etc. Particular emphasis is laid on the implementation of Agenda 21 as it relates to the seas and oceans and other post-UNCED developments (the UNCED follow-up Conferences between now and 1995). These are intensive, 10-week programmes, comprising 300 classroom hours, field trips,

simulation exercises, and case studies.

We have conducted over forty such programmes, in all parts of the world, at an average rate of four programmes per year. Over the next years, the number of programmes will be doubled.

We always need scholarships for our participants. On the average, each scholarship, for a ten-week programme, costs \$10,000, and this includes air fares, ten weeks of room and board, tuition fees, teaching materials, field trips, medical insurance, and pocket allowance.

As part of our endowment drive, we are now trying to get a number of endowed scholarships, i.e., endowments of \$100,000 each, which would maintain the scholarship in perpetuity.

We would like to discuss the possibilities of endowed or ad hoc scholarships with you.

As already mentioned, our activities are not restricted to training programmes, and we shall be glad to provide you with additional information when we meet on Thursday at 16:00. We are looking forward to this meeting.
