The International Ocean Institute takes pleasure in inviting you to attend Pacem in Maribus V, to be held in Malta from September 9 through 13, 1974.

As during the past four Convocations, we shall have the participation of distinguished statesmen and legal experts, industrialists, fishery experts, ocean scientists, ecologists, and students and junior civil servants, with a maximum interaction among these groups.

The Convocation will be presided over by H.E. Mr. H. Shirley Amerasinghe of the Republic of Sri Lanka who, as you know, is President of the U.N. Conference on the Law of the Sea. Sir Anthony Mamo, Governor-General of Malta, will be the Honorary Chairman. The inauguration will take place on September 9 at 8:00 p.m. at the Corinthia Palace Hotel.

The Convocation will deal with two major topics:

- 1. An assessment of the results of the Caracas session of the U.N. Conference on the Law of the Sea, with special emphasis on
 - a. The implications of the Economic Zone concept for the development of an international ocean regime, and
 - b. The prospects for arms control and disarmament in the oceans. This topic will be introduced by Mrs. Alva Myrdal of Sweden on the afternoon of September 13. Her presentation will be followed by a report by Dr. N. K. Panikkar of India on the Indian Ocean as a Zone of Peace, and by general discussion.
- 2. The development of the living resources of the Mediterranean. This topic will be introduced by Dr. Sidney Holt, Director of the IOI.

aims and scope

During the last decade there has been a remarkable upsurge of interest in the marine environment. This has led to a rapid increase in oceanographic research, and reflects the growing general awareness that the ocean and seabed constitute the last major part of the Earth which remains to be explored, and which will probably be the last rich source of raw materials – both biological and non-biological – upon which mankind can draw after the exhaustion, perhaps in the not too distant future, of certain continental resources.

It is also being recognized that the exploration and the exploitation of the sea requires international regulations and cooperation in order to preserve the marine environment and to combat pollution. Last but not least, the scale of these operations requires a thorough knowledge of the financial

and economic problems involved.
Consequently, the two subjects on which the scope of the journal OCEAN MANAGEMENT will be centered are:

- 1) The economic uses of the sea, such as:
 - offshore mining
 shipping and navigation
 fisheries and aquaculture
 waste disposal
 coastal zone management
 tourism
 interaction among various uses
 benefit/cost analysis of marine
 operations
 planning of marine operations
- 2) The legislative and regulatory framework for ocean management, including:

national legislation and regulations regional agreements international conventions

feel that this aspect of the journal should be stressed, because crossfertilization of the disciplines involved in ocean management is one of its main purposes. It is expected that the papers published in OCEAN MANAGEMENT will be of interest to and understandable for a wider audience than just the relevant specialists.

There has in the past been no central journal for papers on ocean management and, as a result, articles on this topic have been scattered throughout a large number of journals specializing in widely differing disciplines. This situation has seriously hampered the flow of communication in the field, and the proposal to create a new journal uniquely devoted to ocean management has received wide approval. It is hoped that it will serve its dual purpose of providing rapid publication of valuable information on all aspects of ocean management, and of becoming a platform for discussions on this subject.

Authors are invited to submit suitable manuscripts to:

A detailed Guide to Authors is available upon request. It will also be printed in the first issue of each volume. Please pay special attention to the following notes:

Preparation of the text

The manuscript should be submitted in triplicate and include an abstract of not more than 500 words at the beginning of the paper.

References

- References in the text with the name of the author(s), followed by the publication date in brackets.
- b) The reference list should be in alphabetical order and on sheets separate from the text.

Tables

Tables should be compiled on separate sheets. A title should be provided for each table and they should be referred to in the text.

Illustrations

- a) All illustrations should be numbered consecutively and referred to in the text.
- b) Drawings should be completely lettered, the size of the lettering being appropriate to that of the drawings, but taking into account the possible need for reduction in size (preferably not more than 50%). The page format of OCEAN MANAGEMENT should be considered in designing the drawings.
- Photographs must be of good quality, printed on glossy paper.
- d) Figure captions should be supplied on a separate sheet.

Proofs

Two sets of proofs will be sent to the author, to be checked for printer's errors. In the case of two or more authors please indicate to whom the proofs should be sent.

Reprints

Each author receives 50 reprints free of charge. Additional reprints can be ordered on a reprint order form, which is included with the proofs.
