

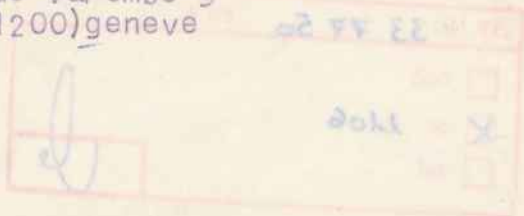

Dear Prof. Elizabeth, peace and health

After the course I had in Malta (1981) I for the first time began to analyse working with fishermen (artisanal) that live in mangrove areas (Costeiras) under a more broad focus (coastal management, mangrove management, aquaculture management, fishermen development). Then I decided writing a "paper" based on the programme that is being carried in an artisanal fishermen community (Ponto dos Corvalhos) in a mangrove area, 20 Km south of Recife. This programme is being carried by the "Church Commission for the Fishermen" and I give technical assistance in a part-time basis (two times a week). Since last November I heard of "The first symposium on Tilapia in aquaculture" to be held in Tiberias (Israel) next May (3 of May - 8 of May); I submitted the Committee of the Symposium the paper "The Ponto dos Corvalhos experience with Tilapia: a case study on land and water (mangrove) mismanagement and technology transfer" and it was accepted by them. The aims of this letter are: ① to put IOI in touch with personal work - as soon as the copies are available I would like to send IOI for criticisms; ② Brazil is facing a even more deep eco-



no one crisis so that funds are very scarce specially  
after International Monetary Fund is "on the scene";  
if it was not enough, the institution I am linked  
in a part-time basis (the church commission for the  
fishermen - Comissao Pastoral dos Pescadores) is also  
in difficulties; the OREAM that is one of the main  
institutions that help the church commission for the fish-  
ermen with financial support, for this year cut the  
proposed budget by some 40%. So, the second aim of  
the letter is it a misunderstanding that IOI could help  
in discovering funds (if they are available) within itself  
or in institutions that deal with 3rd World Develop-  
ment programmes? The funds were to buy an air ticket  
(Receipt - Israel - Receipt). I enclose a copy of the abstract  
as well as a copy of the letter they sent me.  
I thank you in anticipation for the attention given.
