# WEEK 1: THE INTERNATIONAL SETTING

## Monday

Morning : Introduction to the course, its nature, training methodology, expected outputs, administrative arrangements. Black Sea - Mediterranean interactions: need for integration the two managerial regimes.

Afternoon : Introduction: Ocean Management (Coastal Zone and EEZ), sustainable development: the concepts and their implications.

Systems analytical approach to ocean management.

#### Tuesday

Morning : Introduction to the Law of the Sea. New concepts, analysis of new provisions; spaces created by the Convention; territorial sea, contiguous zone, exclusive economic zone, archipelagic waters, the regime of islands.

Afternoon : Convention on the Law of the Sea: international ocean  $\mathcal{CH}^{\wedge}\mathcal{H}$  (space, the high seas, marine scientific research, protection of the marine environment. Developments 1983-94.

#### Wednesday

Morning : UNCED, 1992 and follow-up measures. Links with Law of Vthe Sea; Agenda 21; changes necessary in Barcelona and Black Sea Conventions.

Afternoon: Workshop: importance of ocean management and the Vintegration of environment and development.

#### Thursday

Morning: The changing international system: economically,

/ The new industrial revolution and its impact on management, Veconomics, and societal structures.

Afternoon : The new environmental economics. Accounting methods for linking GNP and ecology.

#### Friday

Morning: Introduction to oceanography: fundamental importance of scientific research for sea uses; oceanography - physical, chemical, geological, biological; coastal oceanography and coastal processes.

Afternoon: Workshop - continued.

# Monday

Morning: Oceanography: the impact of advancing technology electronics, remote sensing, new materials, genetics; the changing research vessel; the software dimension, data collection, collation and dissemination; economics of data collection and assessment.

Afternoon: Coastal ecosystems: structure and function. Critical ecosystems and their vulnerability. The Black Sea and Mediterranean ecosystems: their special characteristics.

#### Tuesday

Morning: Coastal resources: distribution and abundance; nonliving resources - land, water, energy, minerals; living resources - fisheries, corals, wildlife, scenic and recreational; resource assessment.

Afternoon: Coastal activities: tourism, transport, fisheries, aquaculture, industry, mining; need for conflict removal and harmonisation; methods of achieving integrated policies.

#### Wednesday

Morning: Remote sensing and principles of GIS. Applications to coastal zone management.

Afternoon : Workshop on how to handle data for developing a coastal zone management plan.

## Thursday

Morning : Chemistry of sea-water: isotope oceanography, age and rate of sedimentatioon. Chemical oceanography and the chemistry of pollution.

Biodiversity : threats, causes of extinction and need to conserve. Management tools and case studies.

Afternoon : Methods and concepts of risk assessment; development of risk profiles and contingency plans; role of risk management in coastal management, use of information technology, data banks etc.

### Friday

Morning : Technology assessment and investment appraisal systems. How to handle high-tech, uncertainty and risks. Public and private sector differentials.

Afternoon : Workshop - continued.
