I was so lucky to get you over the phone the other day, and I want to thank you once more for all your encouragement and help.

Here, now, is the information I promised you:

## 1. The International Ocean Institute

The IOI is located at the Royal University of Malta. It is governed by an international Board of Trustees and a Planning Council. The list of the members of these bodies is enclosed. Since 1970 the IOI has organized a series of annual conferences, Pacem in Maribus I-VI. It has organized a series of research projects and held a number of regional meetings.

The International Ocean Institute was established in 1972 with the cooperation of the Government of Malta and the United Nations Development Programme. It is an independent institution at the University of Malta, governed by an International Board of Trustees and a Planning Council. The list of members of these bodies is attached.

The purpose of the Institute is to study in depth the issues underlying the building of a new international order in the oceans, to propose new approaches and solutions, and to widen the circle of the dialogue on ocean affairs. Besides the annual Pacem in Maribus Convocations -- five of which have taken place in Malta and a sixth one in Okinawa -- the Institute has organized a series of regional meetings in cooperation with the Governments of Yugoslavia, of Jamaica, and of Mexico. It has sponsored a series of research projects on such subjects as the Development of the Mediterranean, the Development of the Caribbean, the feasibility of an Ocean Development Tax, Energy and the Oceans, Disarmament and Arms Control in the Oceans. It has organized seminars and summer schools at the University of Malta and publishes a series of books and proceedings. It has official observer status at the Third United Nations Conference on the Law of the Sea. The Statute of the Institute is attached. International Ocean Institute

## The Friends of the International Ocean Institute

The FIOI is a public foundation incorporated under California Law with an IRS ruling making contributions tax-exempt. The purpose of the FIOI is to support research such asthat undertaken by the IOI and to increase awareness in this country of ocean-related problems.

The FIOI has a Board of three officers:

President: Professor Wendell Mordy, Center for the Study of Democratic Institutions, Santa Barbara.

Vice-President: Mrs. Neila Danelius, 1404 Hilcrest, Santa Barbara

Secretary-Treasurer: Mr. Aaron Kozak, 310 Madison, New York, N.Y. 10017

The FIOI has been in existence for a little over a year and has been useful for the transmission of funds to the IOI. Now, however, we want to build it up into an effective American organization, probably called, more briefly, "Friends of the Oceans." We want to do a number of things:

- Put together an active Board of directors. It would be splendid if you could be Honorary Chairman of this Board. It would be splended if Mr. E. Taylor Shewning could be active Chairman. Other persons that have been suggested for emembership are: Katharine Graham; Eunice Schriver; Harlan Cleveland; Joe Slater; Stanley Sheinbaum. But we would be grateful if you could make some more suggestions. We also have a PR office in New York: Arts, Letters & Politics Inc., 250 West 57th Street, New York, and they would like to help us in putting together the Board.
- b. Build up a membership.
- Prepare a mailing piece (the New York Office will C. do that, according to our specifications).
- Get ready to publish a bi-months newsletter. d.
- Think of some project here in the States, onceivably on marine parks, possibly in cooperation with Anthony Wayne Smith's National Parks Conservation Association, or some othe project that might be suggested.

I am totally absorbed by IOI, and that is quite a handful.
