I am particularly sorry because I read your paper with the greatest interest -- and some puzzlement. Incidentally, the paper is extremely well written and organized.

But I am at a loss as far as your conclusions are concerned. As you rightly point out, the malfunctioning of the public sector is intrinsic in the mal=functioning of parliamentary democracy as bequeathed by the British.

What is the remedy.

The way you write "socialist" in quotation marks makes the reader suspect what you do not really suggest: that the remedy would be to rely on the private sector, that is on the multinationals. To my mind, that cure would be worse than the evil. But I am really not sure what it is that you are suggesting. While I find your analysis excellent, I find your conclusions unclear.

I hope we shall have an occasion to discuss this matter further after my return on February 28.




